(57) **CLAIM**

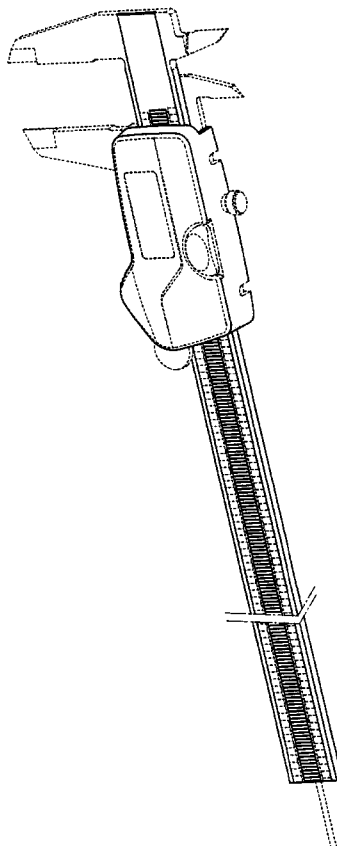
The ornamental design for a slide caliper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of my new slide caliper; FIG. 2 is a top view of FIG. 1; FIG. 3 is a bottom view of FIG. 1; FIG. 4 is a right side view of FIG. 1; FIG. 5 is a left side view of FIG. 1; FIG. 6 is a front view of FIG. 1; and, FIG. 7 is a back view of FIG. 1.

The parts shown in broken lines are shown for environmental purposes only and form no part of the claimed design. Portions of the slide caliper are not shown for ease of illustration and to illustrate an indeterminate length.

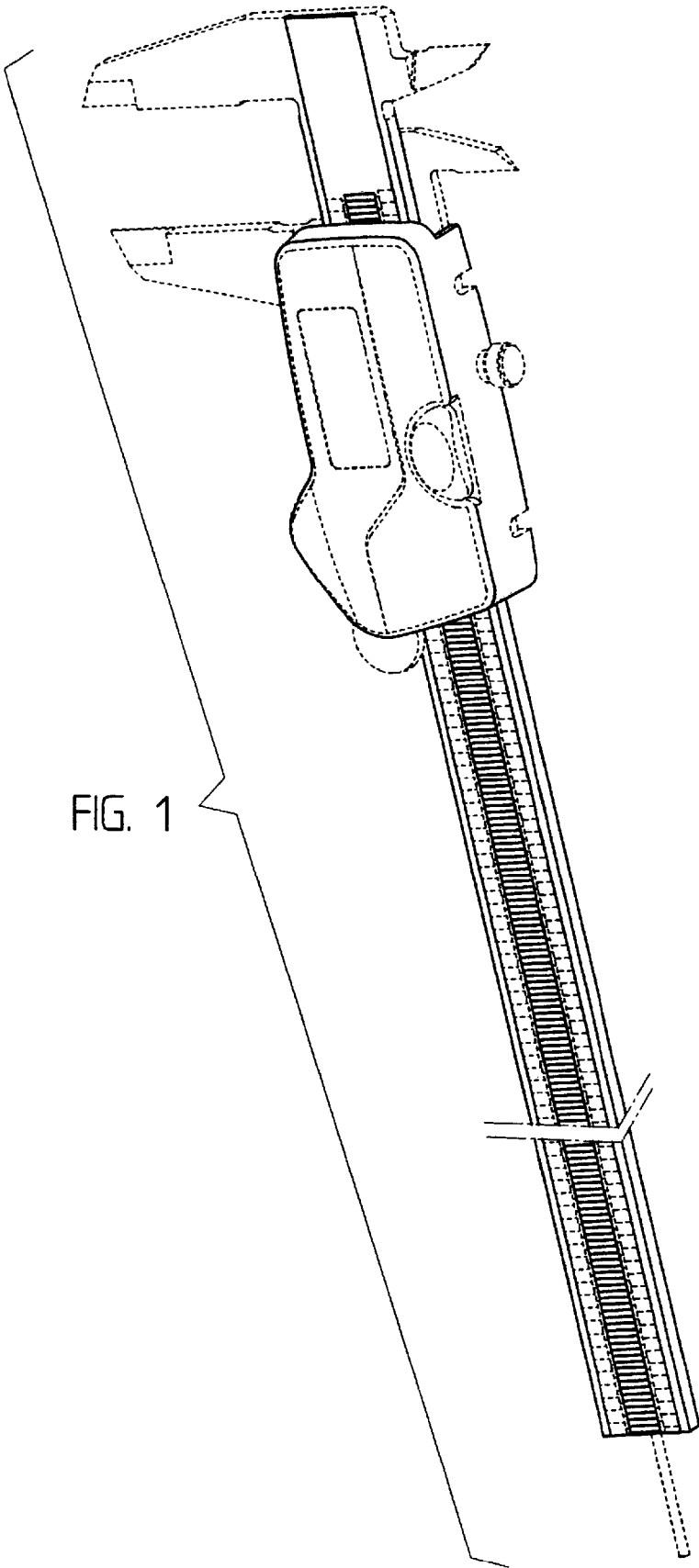
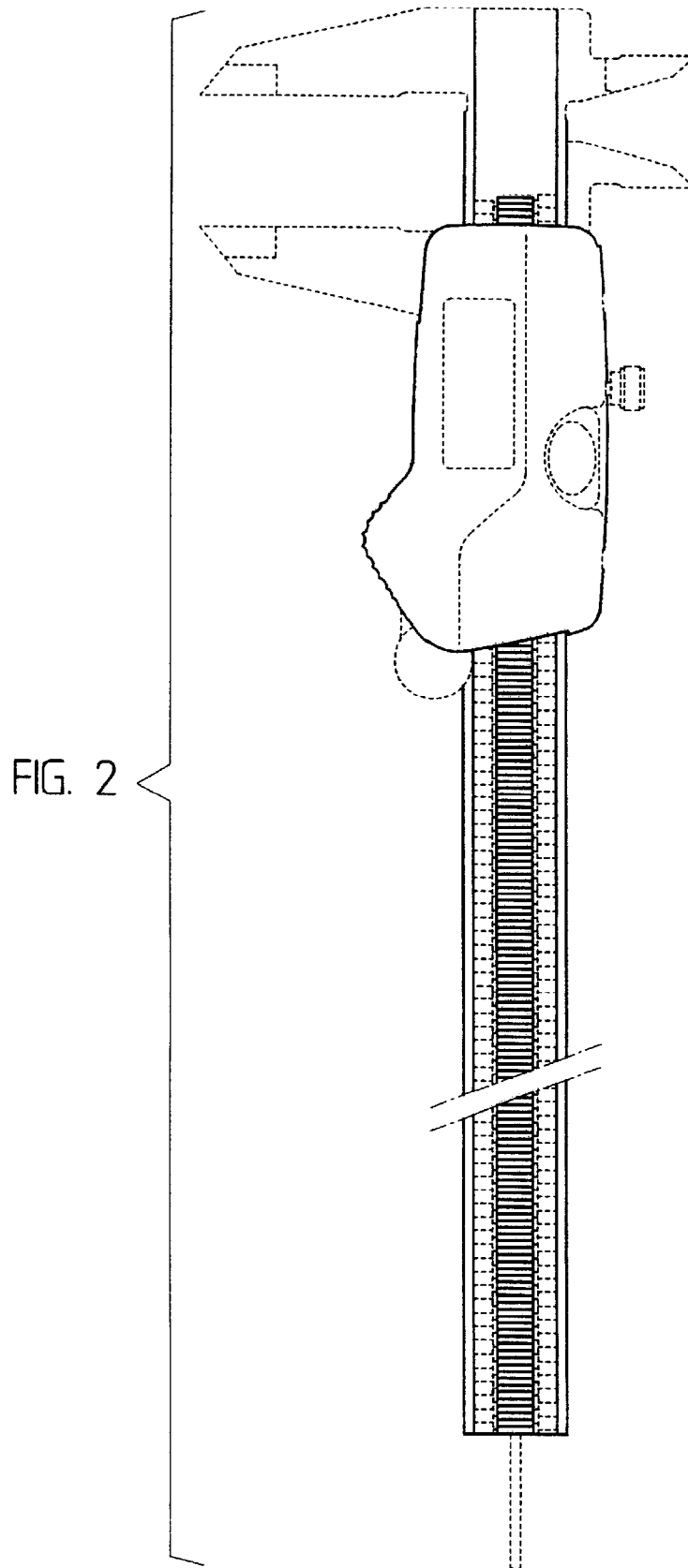

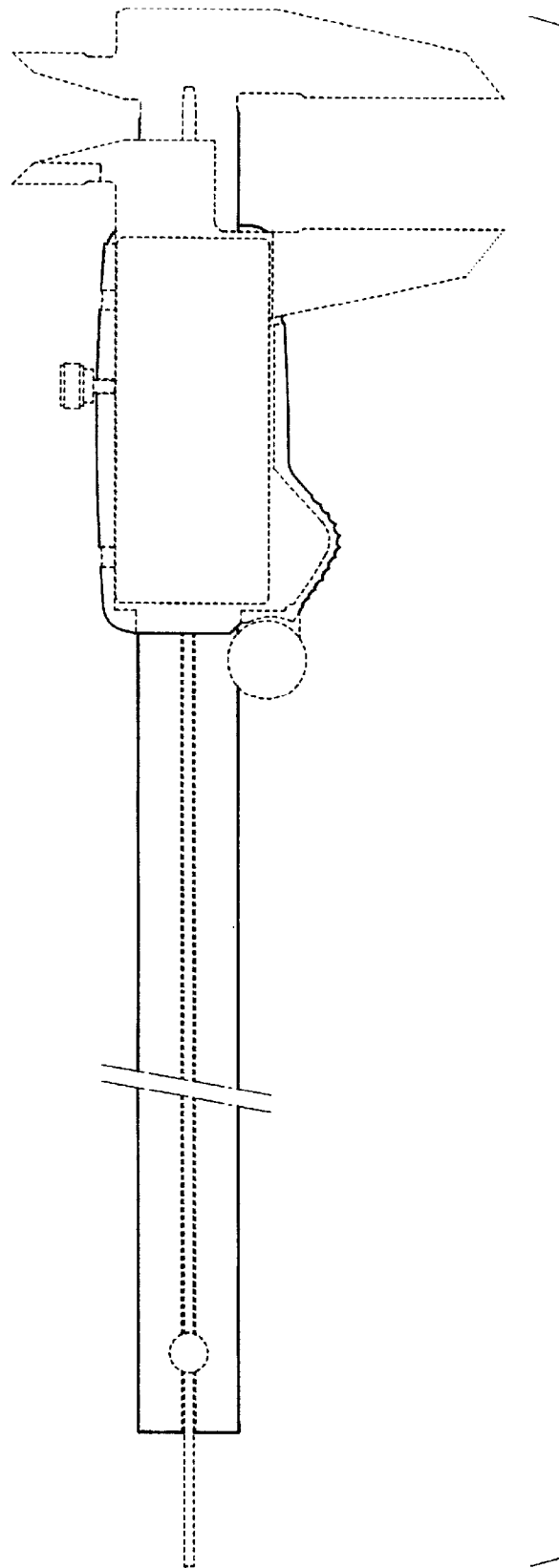
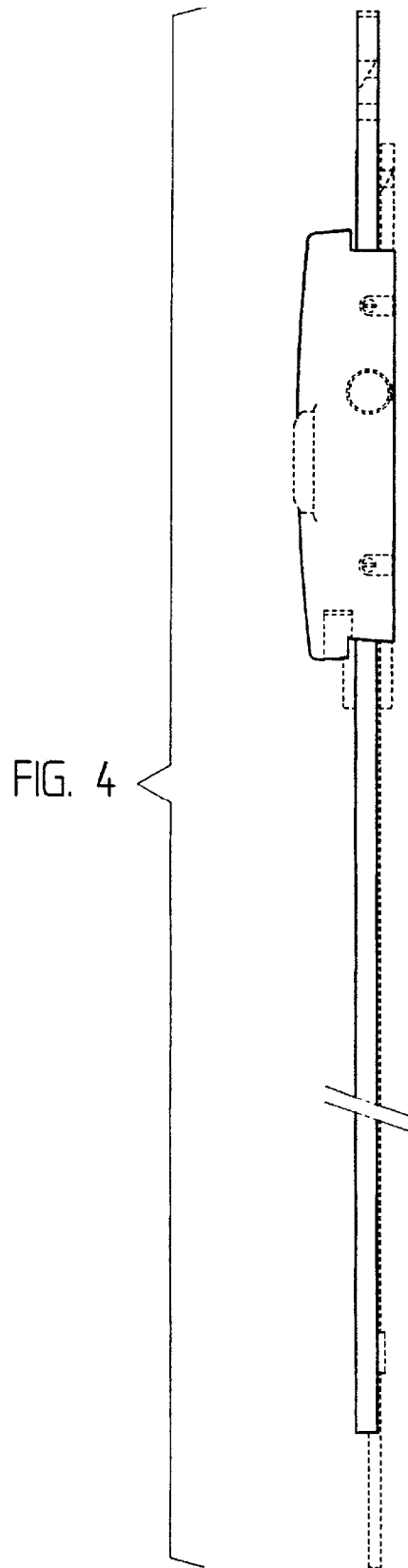

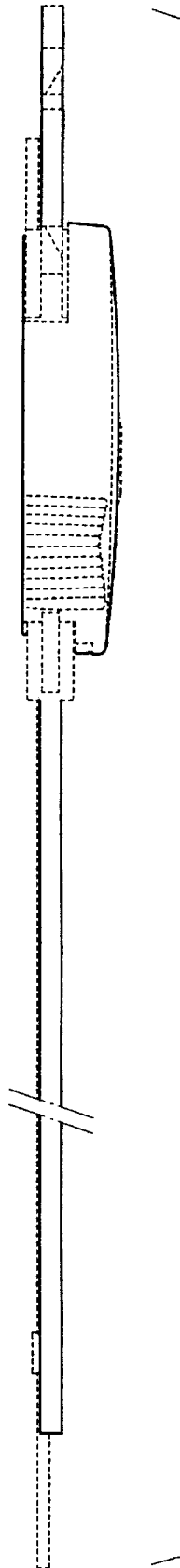

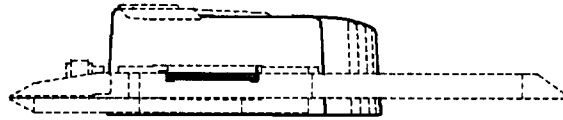
