

(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom view of a shoe showing my new design; FIG. 2 is a bottom front perspective view thereof; and, FIG. 3 is a bottom rear perspective view thereof. The broken lines immediately adjacent to the front and rear of the photographic area define the bounds of the claimed design and form no part thereof. 




