(57) **CLAIM**

I claim the ornamental design for a “light stake,” as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a light stake according to the claimed design.

FIG. 2 is a back perspective view of the light stake shown in FIG. 1.

FIG. 3 is front view of the light stake shown in FIG. 1.

FIG. 4 is a back view of the light stake shown in FIG. 1.

FIG. 5 is a left view of the light stake shown in FIG. 1.

FIG. 6 is a right view of the light stake shown in FIG. 1.

FIG. 7 is a top view of the light stake shown in FIG. 1; and,

FIG. 8 is a bottom view of the light stake shown in FIG. 1.

The broken lines shown in dash-dash form are dashed lines that show portions of the article and form no part of the claimed design. The broken lines shown in dot-dash form are boundary lines that do not exist in reality in the light stake embodying the design and show bounds of the claimed design. It is understood that the claimed design extends to the boundary lines, but does not include the boundary lines.

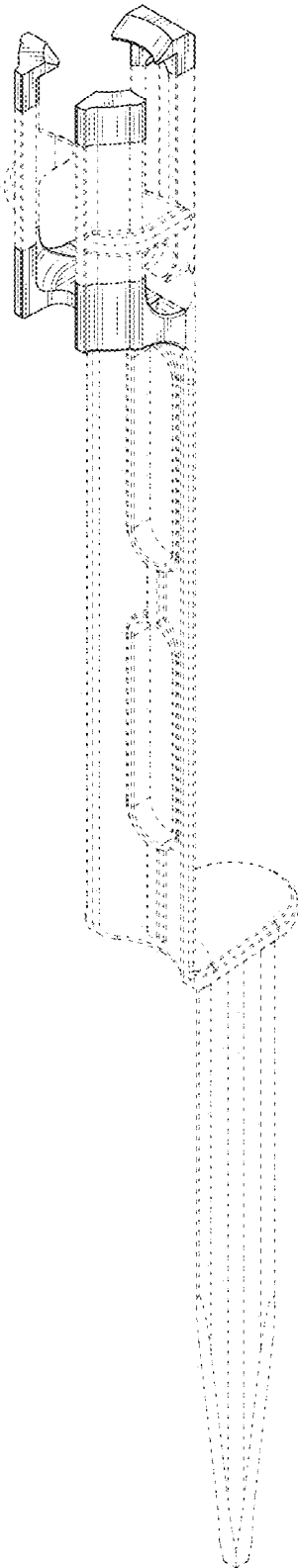

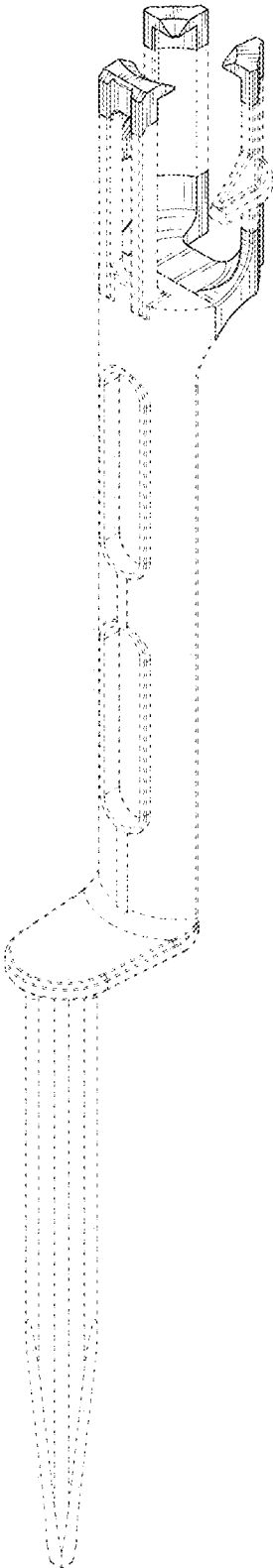

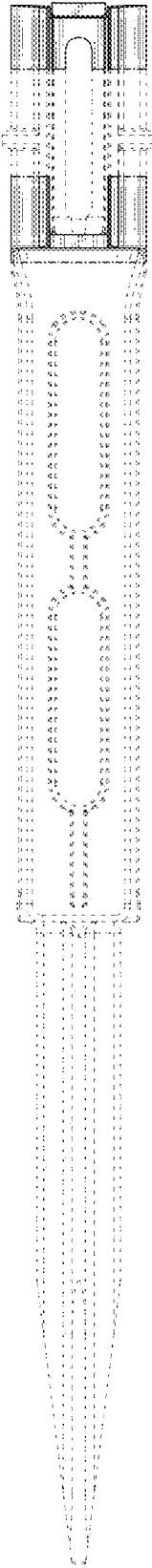

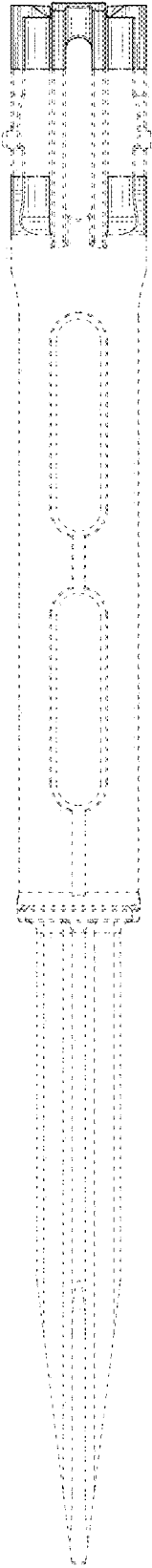

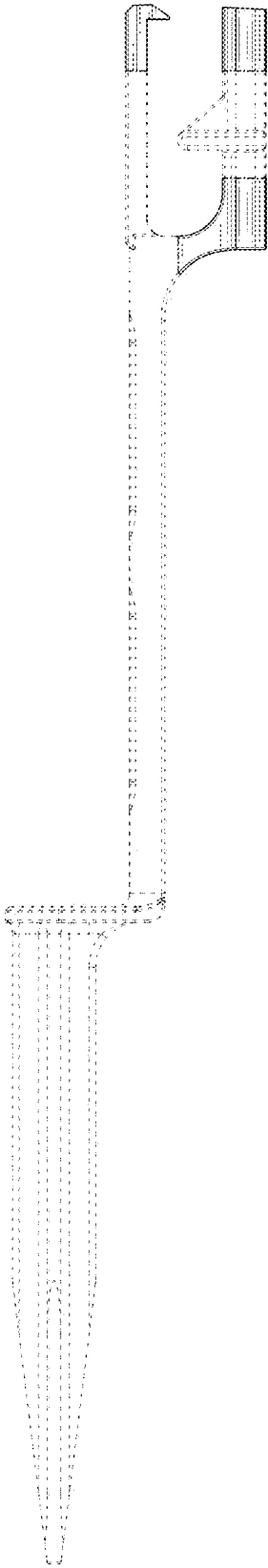

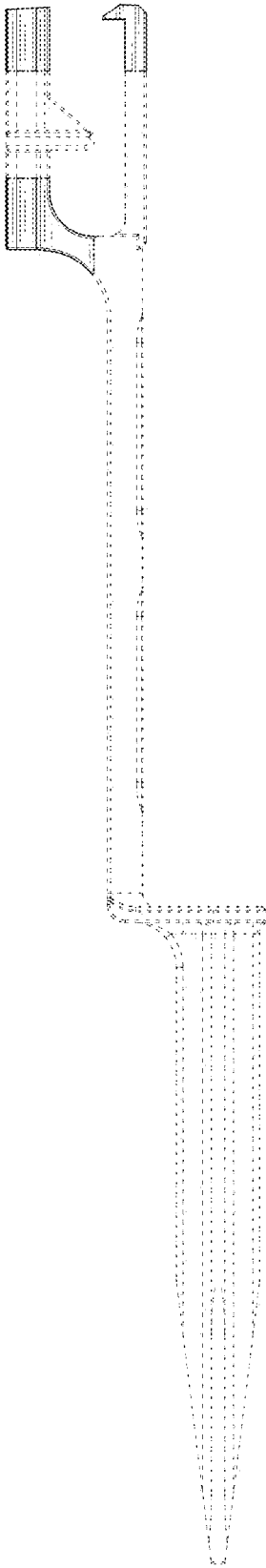

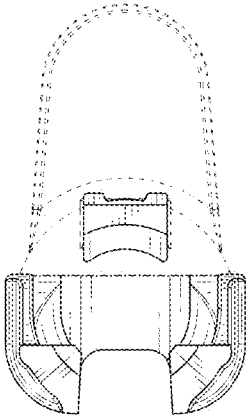

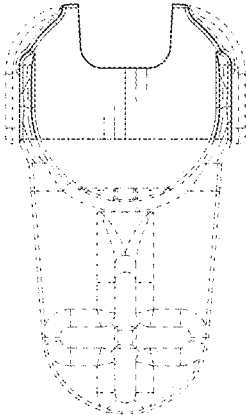
