(57) **CLAIM**

The ornamental design for a stay for furniture, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a stay for furniture according to the invention;

FIG. 2 is a front elevation view of the stay for furniture of FIG. 1;

FIG. 3 is a rear elevation view of the stay for furniture of FIG. 1;

FIG. 4 is a top plan view of the stay for furniture of FIG. 1; FIG. 5 is a bottom plan view of the stay for furniture of FIG. 1;

FIG. 6 is a right side elevation view of the stay for furniture of FIG. 1;

FIG. 7 is a left side elevation view of the stay for furniture of FIG. 1;

FIG. 8 is an enlarged cross sectional view of the stay for furniture through line 8-8 shown in FIG. 2, where the internal structures are omitted;

FIG. 9 is a cross sectional view of the stay for furniture through line 9-9 shown in FIG. 6, where the internal structures are omitted;

FIG. 10 is a perspective view of the stay for furniture of FIG. 1 in a state where the arm has rotated;

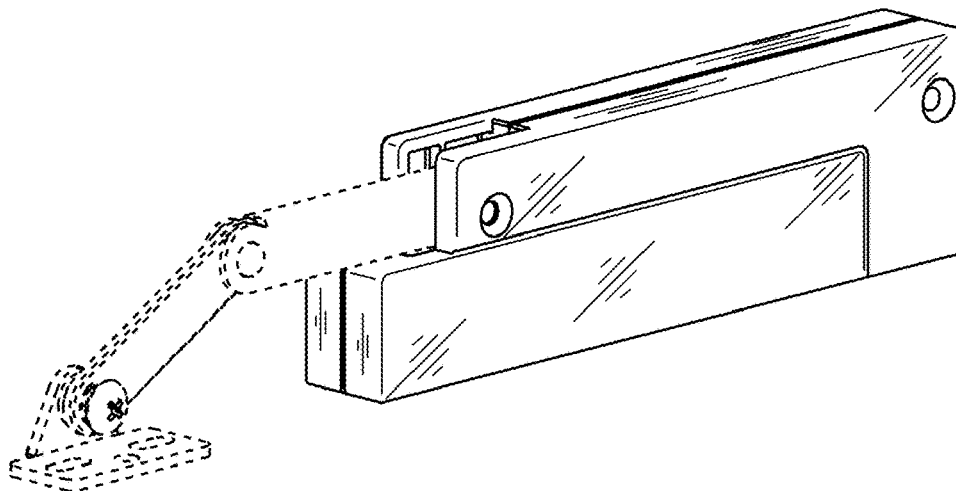
FIG. 11 is a front elevation view of the stay for furniture of FIG. 1 in a state where the arm has rotated;

FIG. 12 is a front elevation view of the stay for furniture of FIG. 1 in a state where the main body of the stay is attached to a wall of furniture, the arm of the stay is attached to a door of the furniture, and the arm has rotated; and,

FIG. 13 is a front elevation view of the stay for furniture of FIG. 1 in a state where the main body of the stay is attached to a wall of furniture, the arm of the stay is attached to the door of the furniture, and the arm has not rotated.

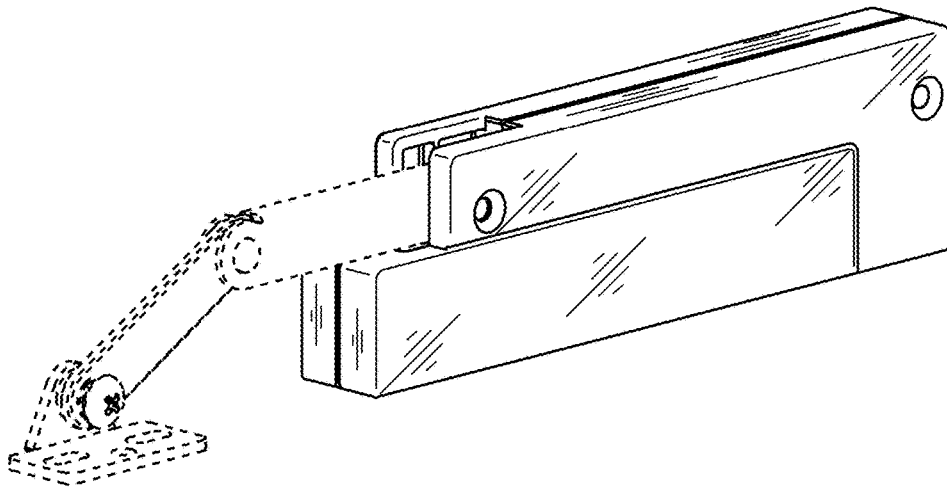

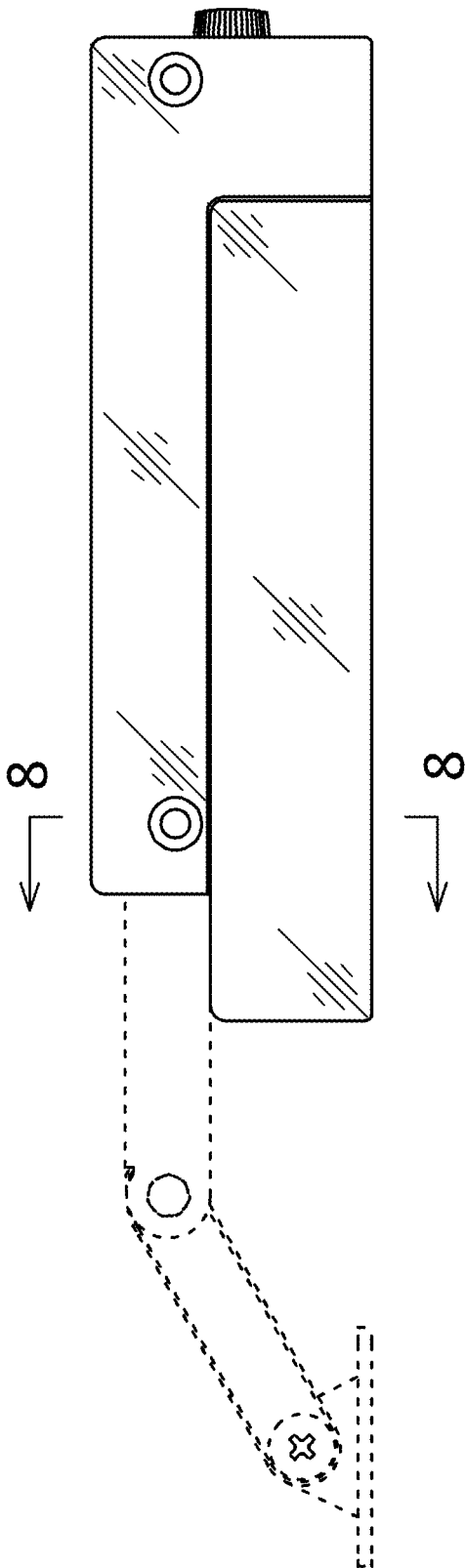

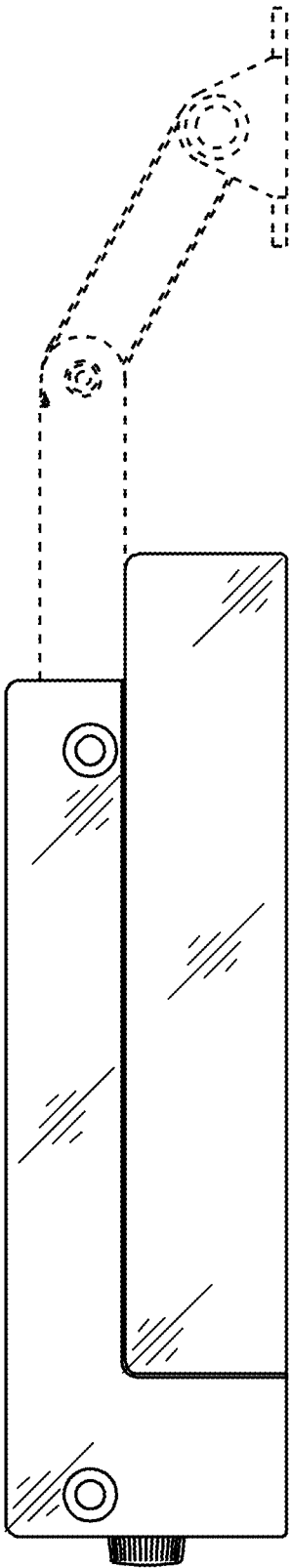

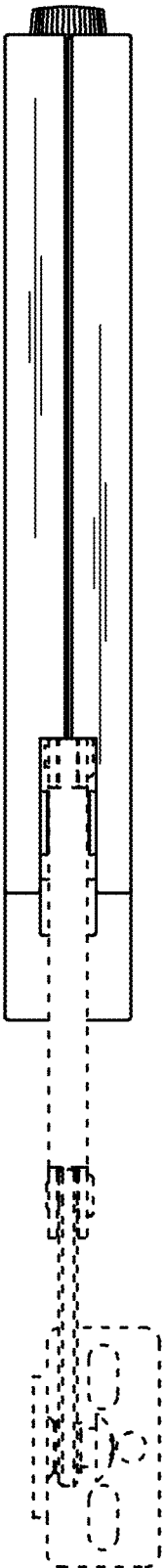

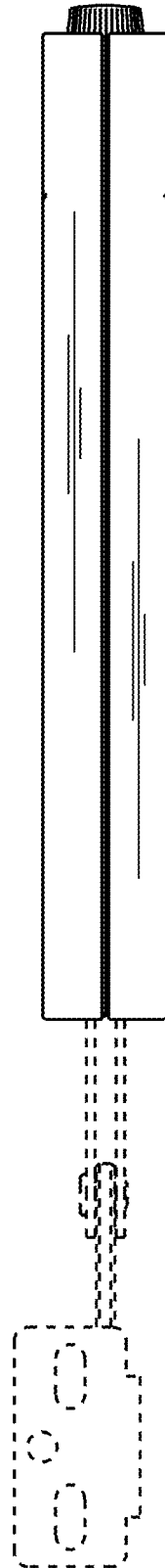

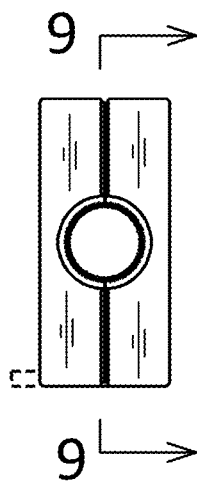

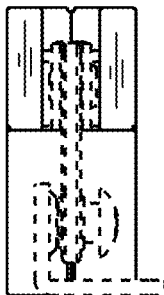

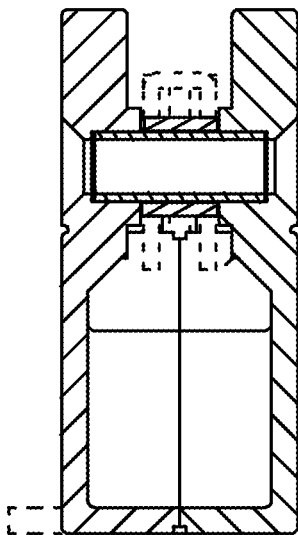

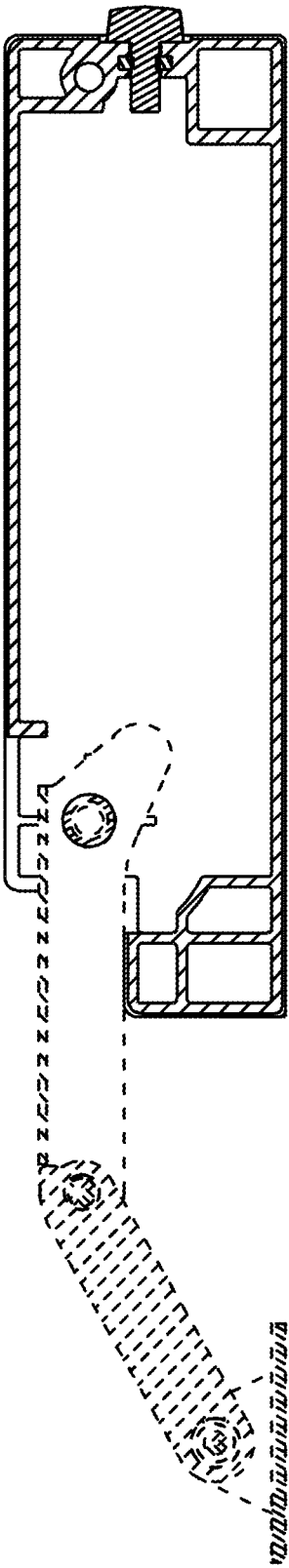

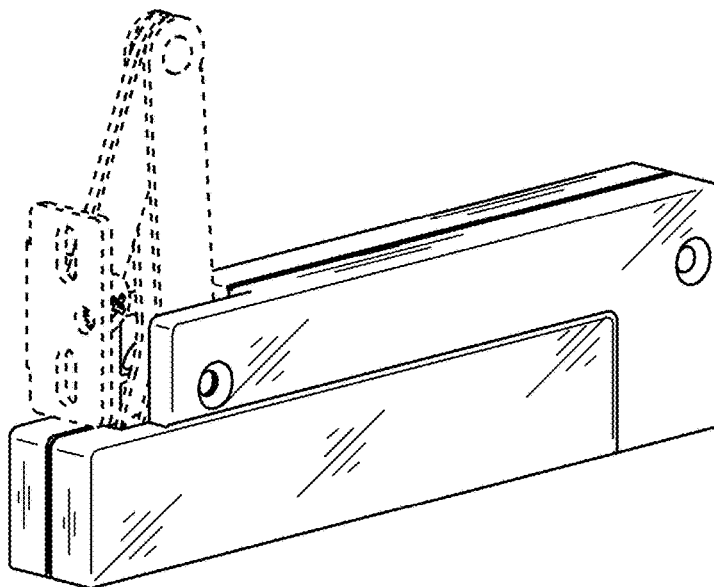

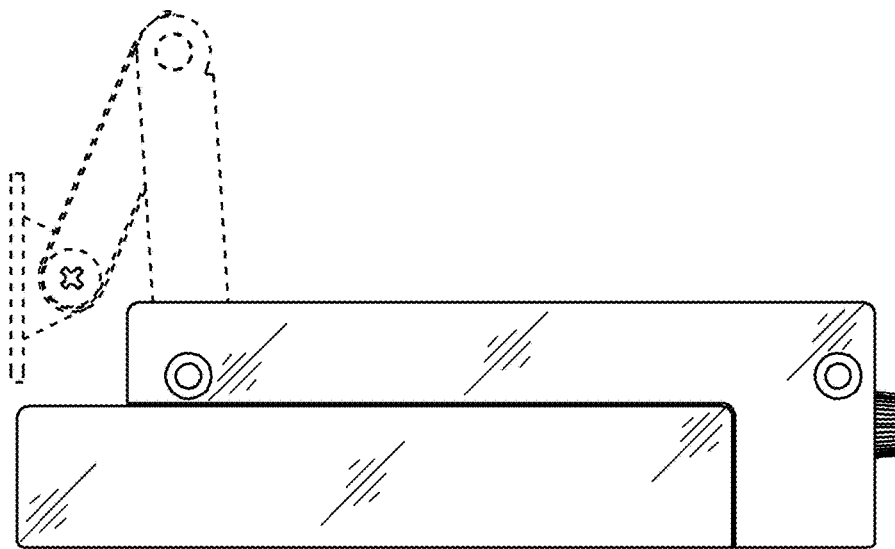

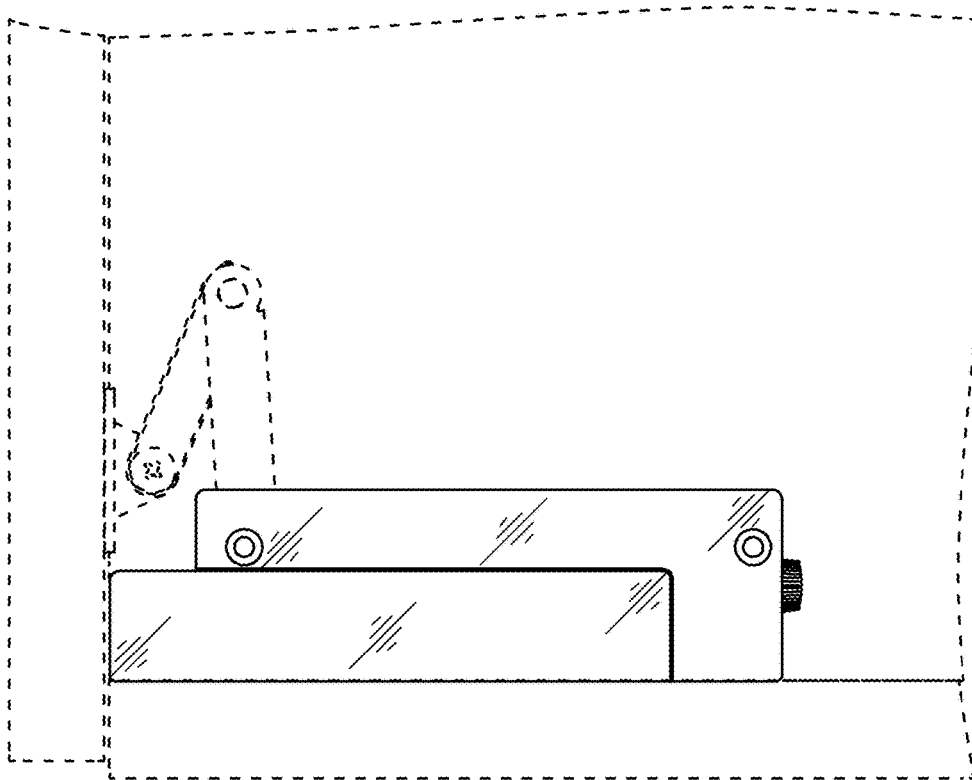
