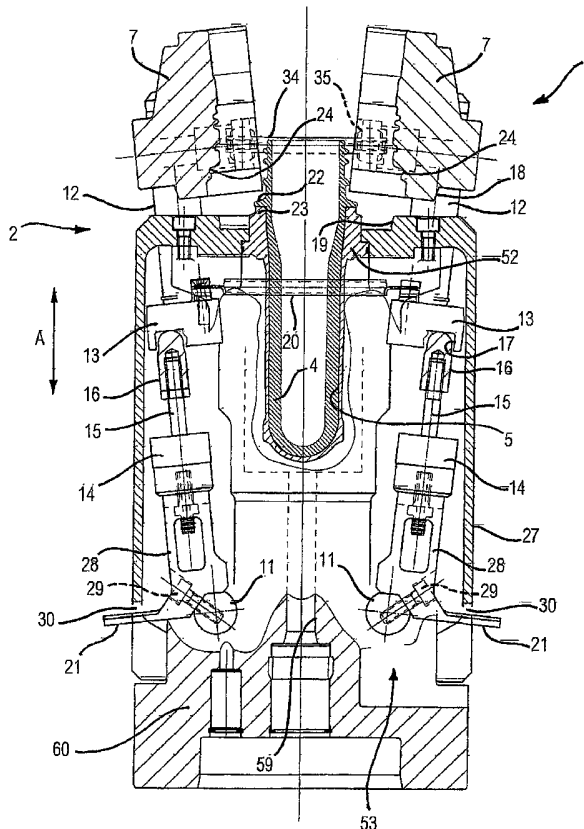

(57) Abstract: An apparatus comprises forming means (2, 3; 102, 103; 202, 203; 302, 303) closable in a direction (A) to form an object (4; 39; 104; 204), said forming means (2, 3; 102, 103; 202, 203; 302, 303) comprising at least two elements (7; 107; 207; 307) reciprocally movable along respective arched trajectories to disengage from said object (4; 39; 104; 204), said arched trajectories having respective components parallel to said direction (A).
