(57) **CLAIM**

The ornamental designs for a console for a dental apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right side perspective view of a console for a dental apparatus in accordance with a preferred embodiment of the present design.



FIG. 2 is a rear, bottom, left side perspective view of the console shown in FIG. 1.

FIG. 3 is a front side plan view of the console shown in FIG. 1.
















