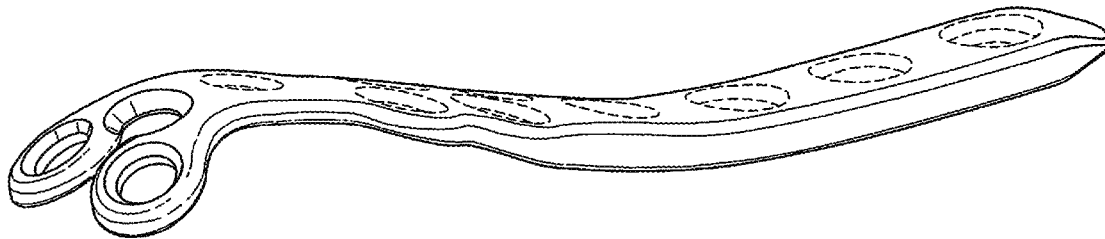
(57) **CLAIM**

The ornamental design for an medial tibia fracture plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the medial tibia fracture plate;  
FIG. 2 is a perspective view thereof;

FIG. 4 is a left side view thereof;

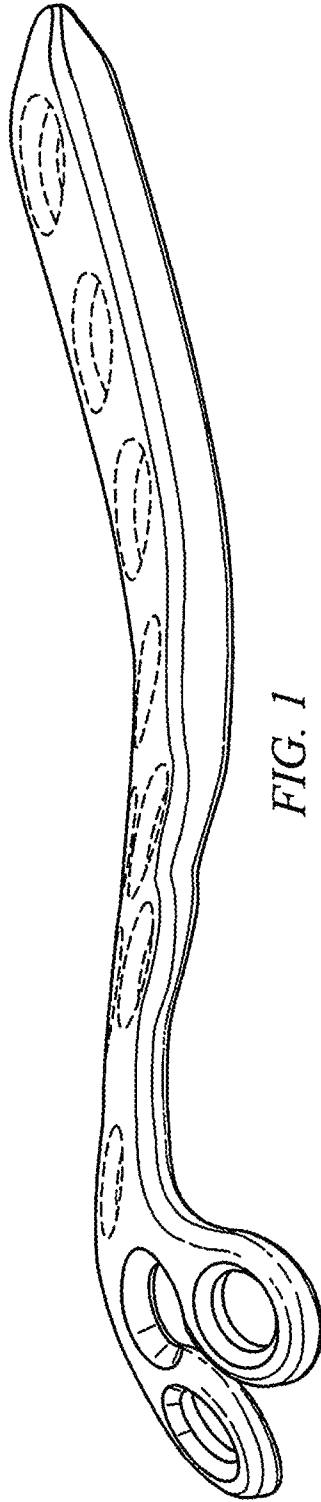

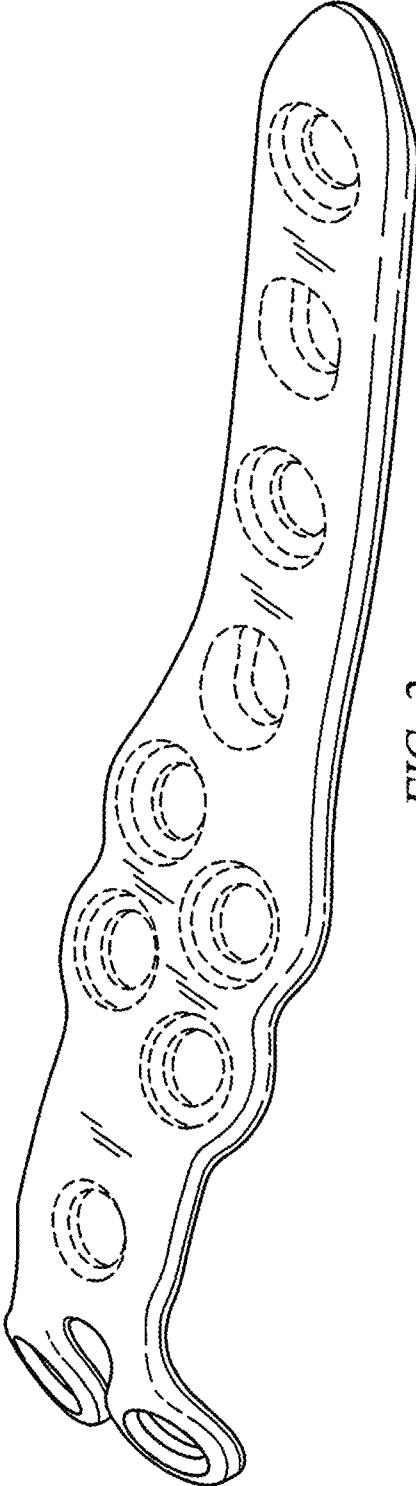

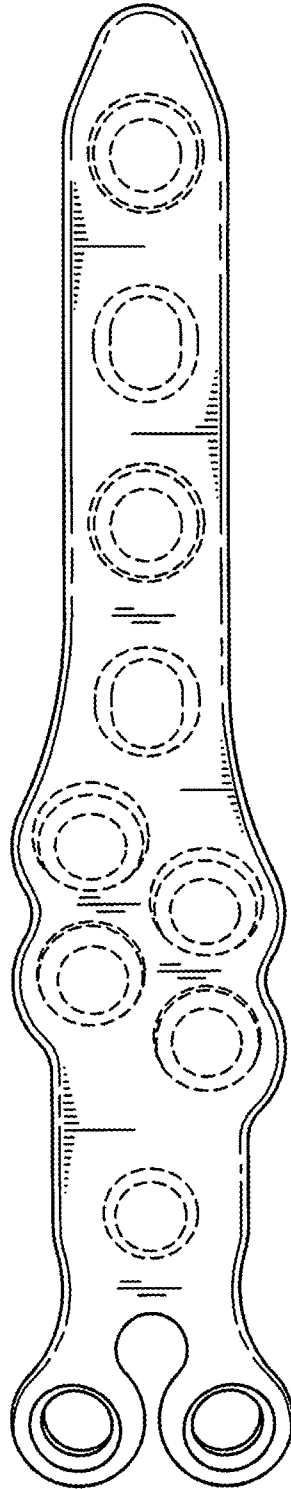
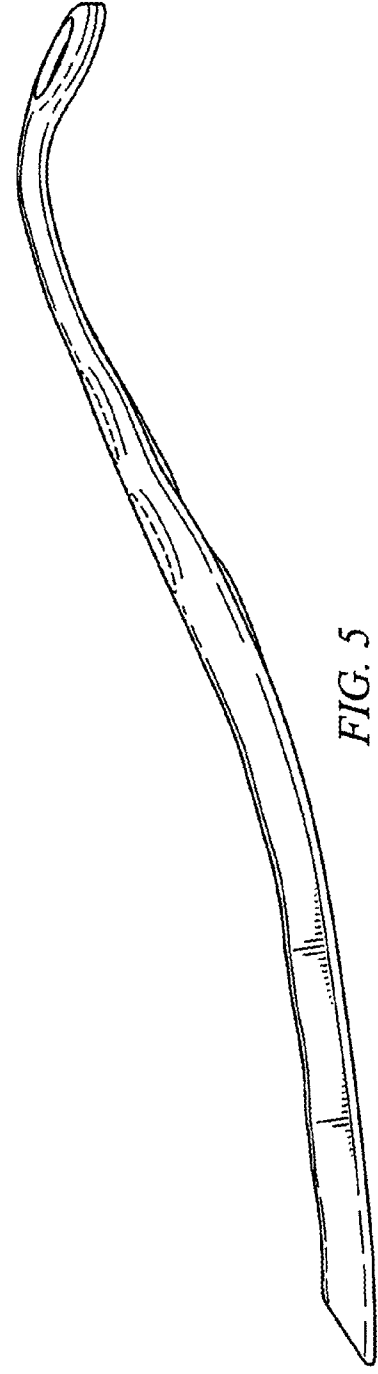
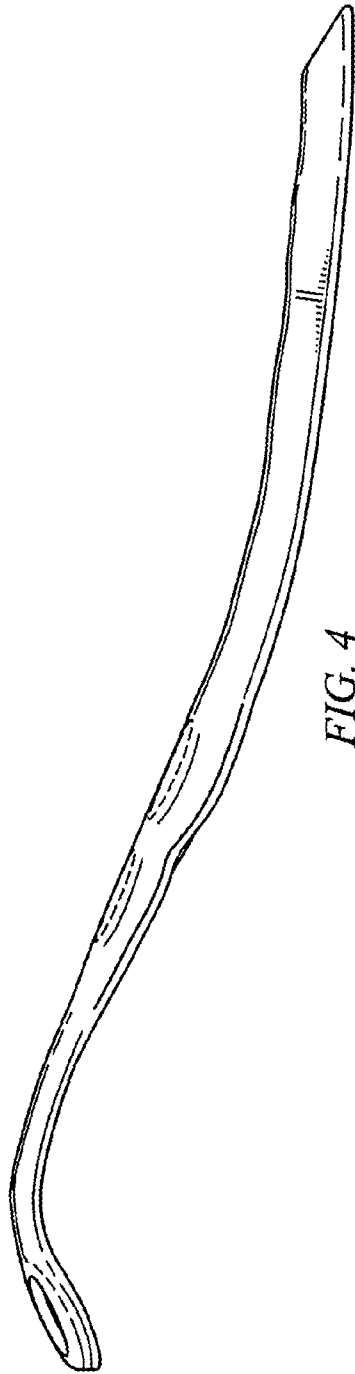

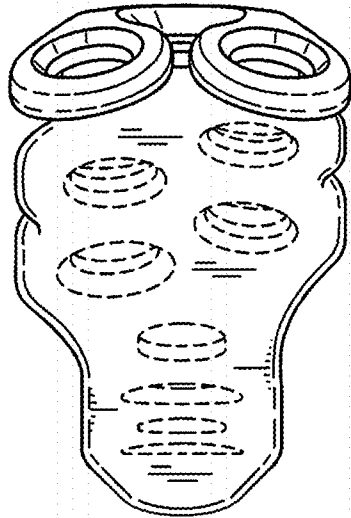

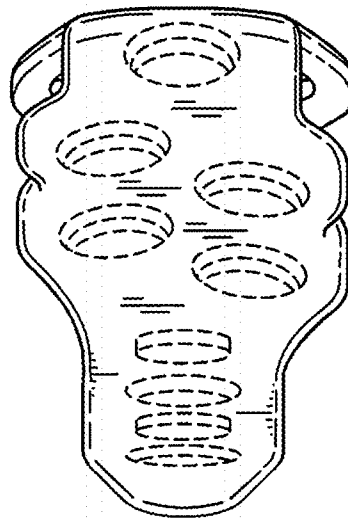

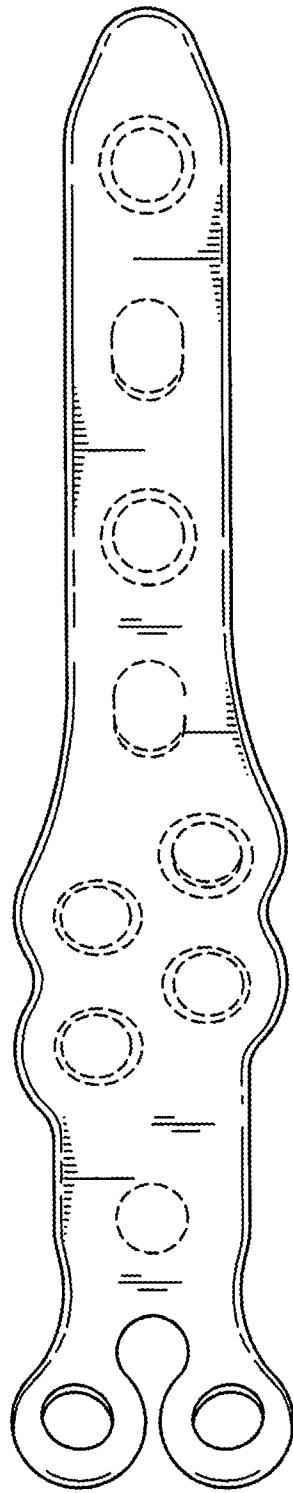
