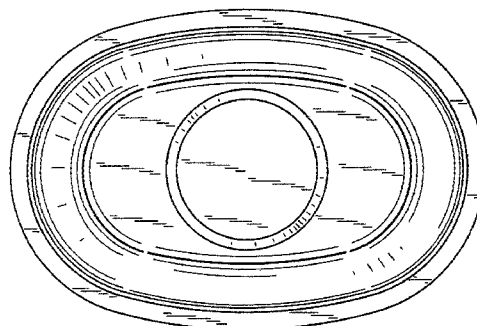
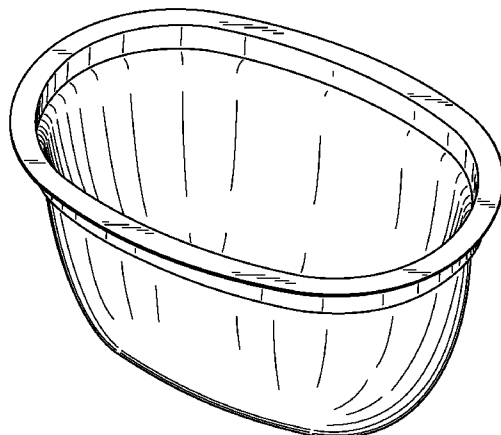
(57) **CLAIM**

The ornamental design for a food cup, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a food cup showing our new design;
FIG. 2 is a right side elevational view thereof; the left side elevational view being a mirror image thereof;
FIG. 3 is a front elevational view thereof; the rear elevational view being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a side sectional view showing section taken along line 6-6 of FIG. 5.

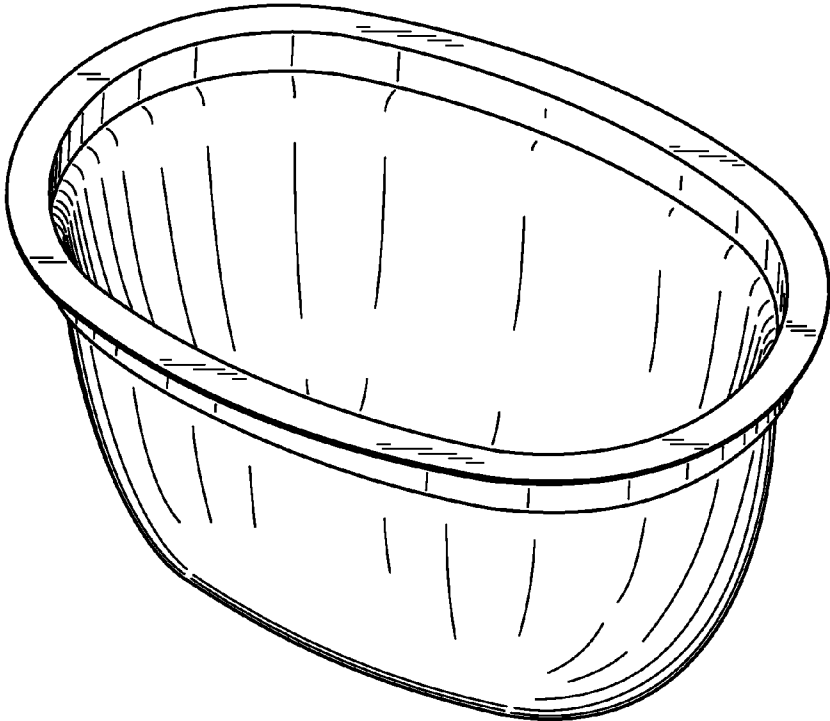

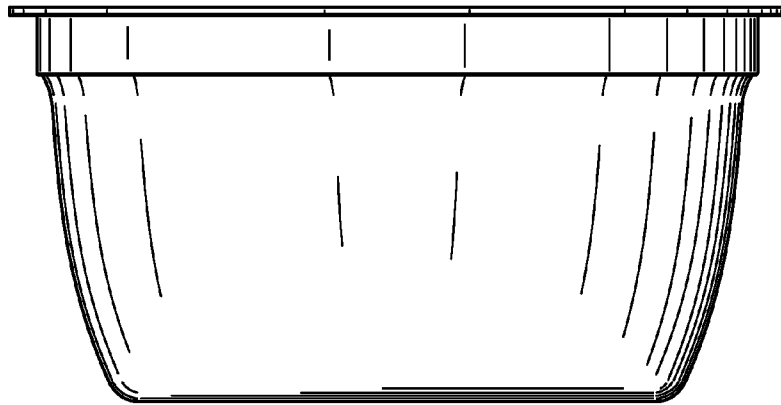

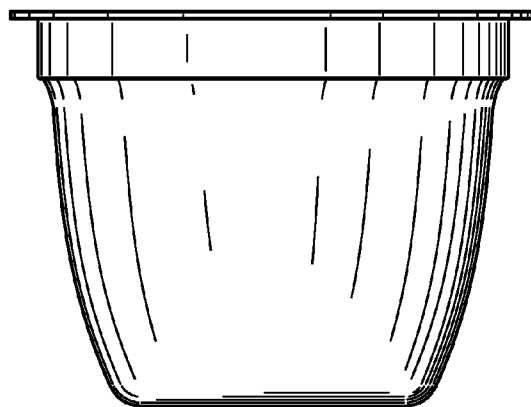

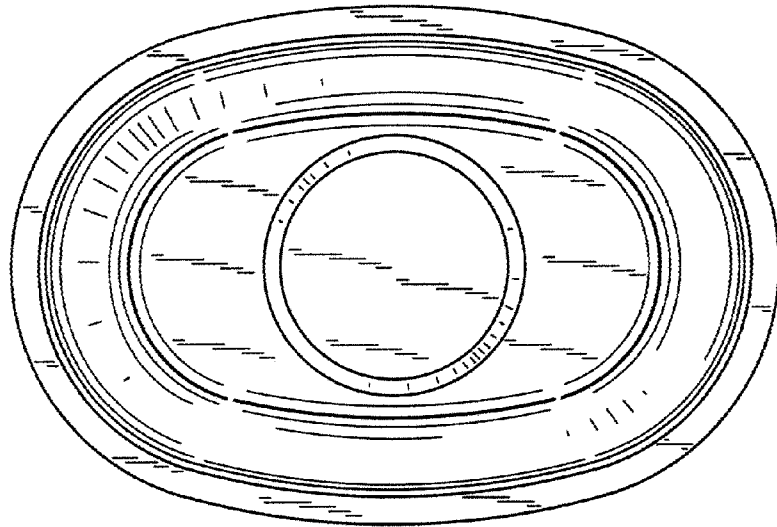

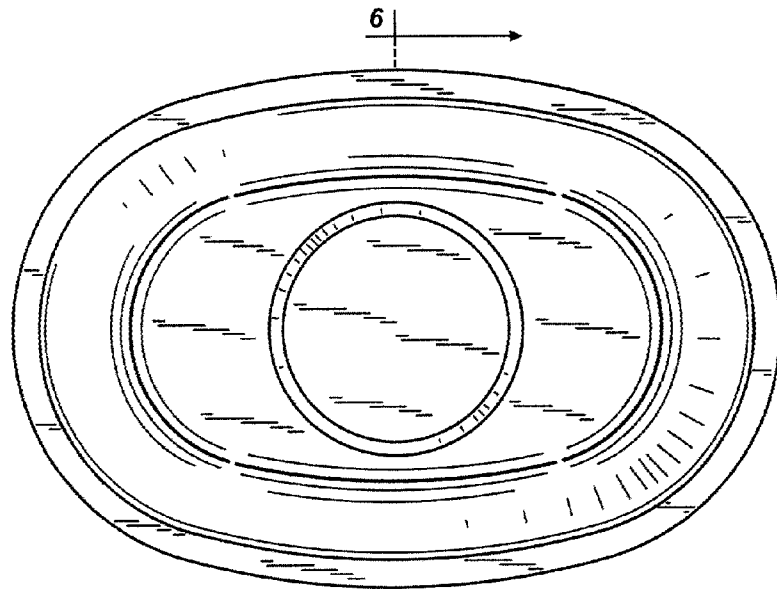

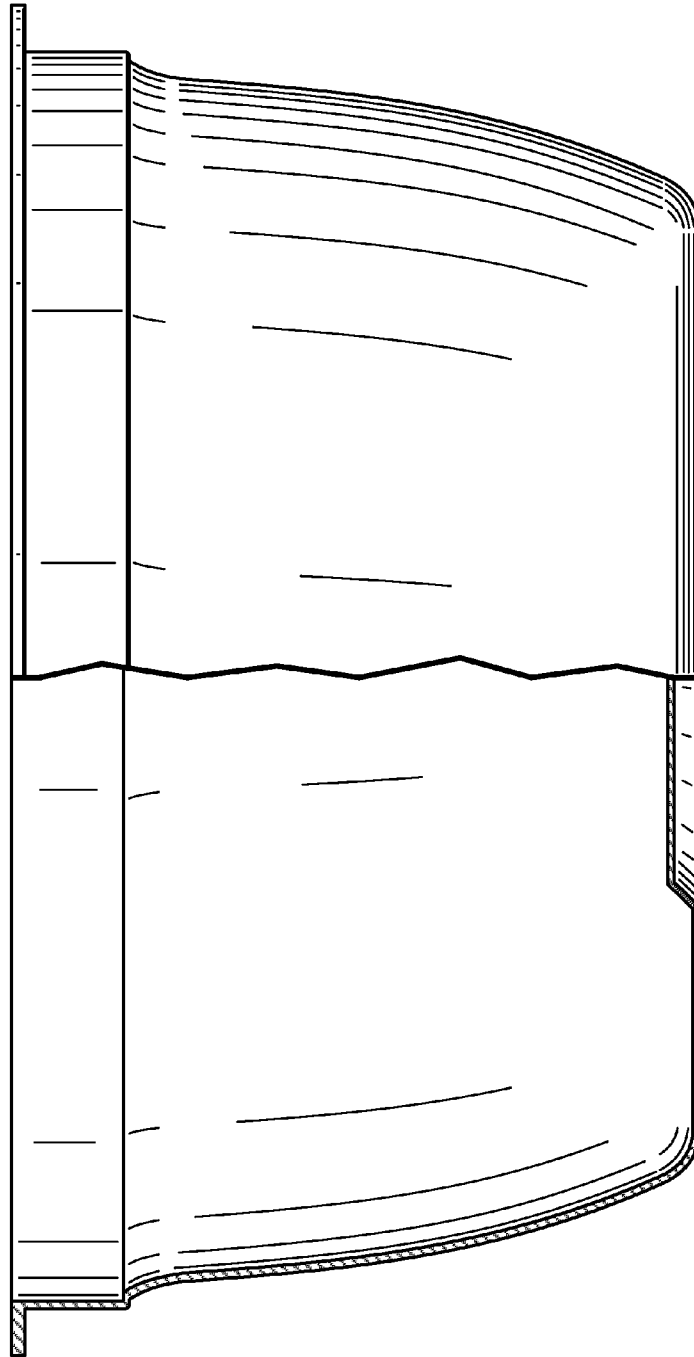
