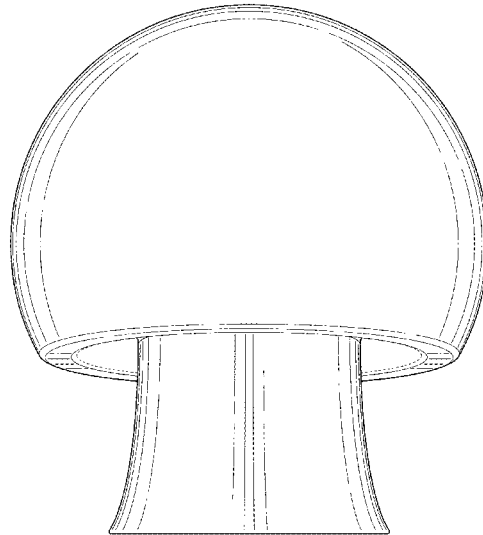
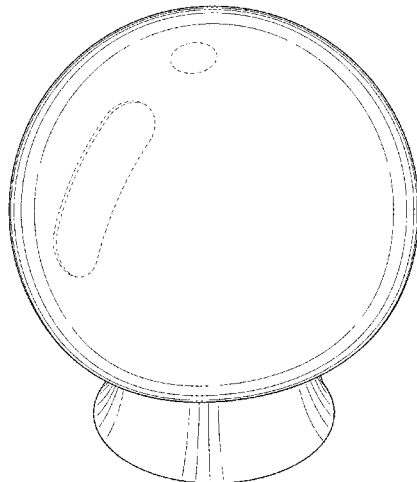
(57) **CLAIM**

We claim the ornamental design for the pet toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet toy in accordance with the present design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

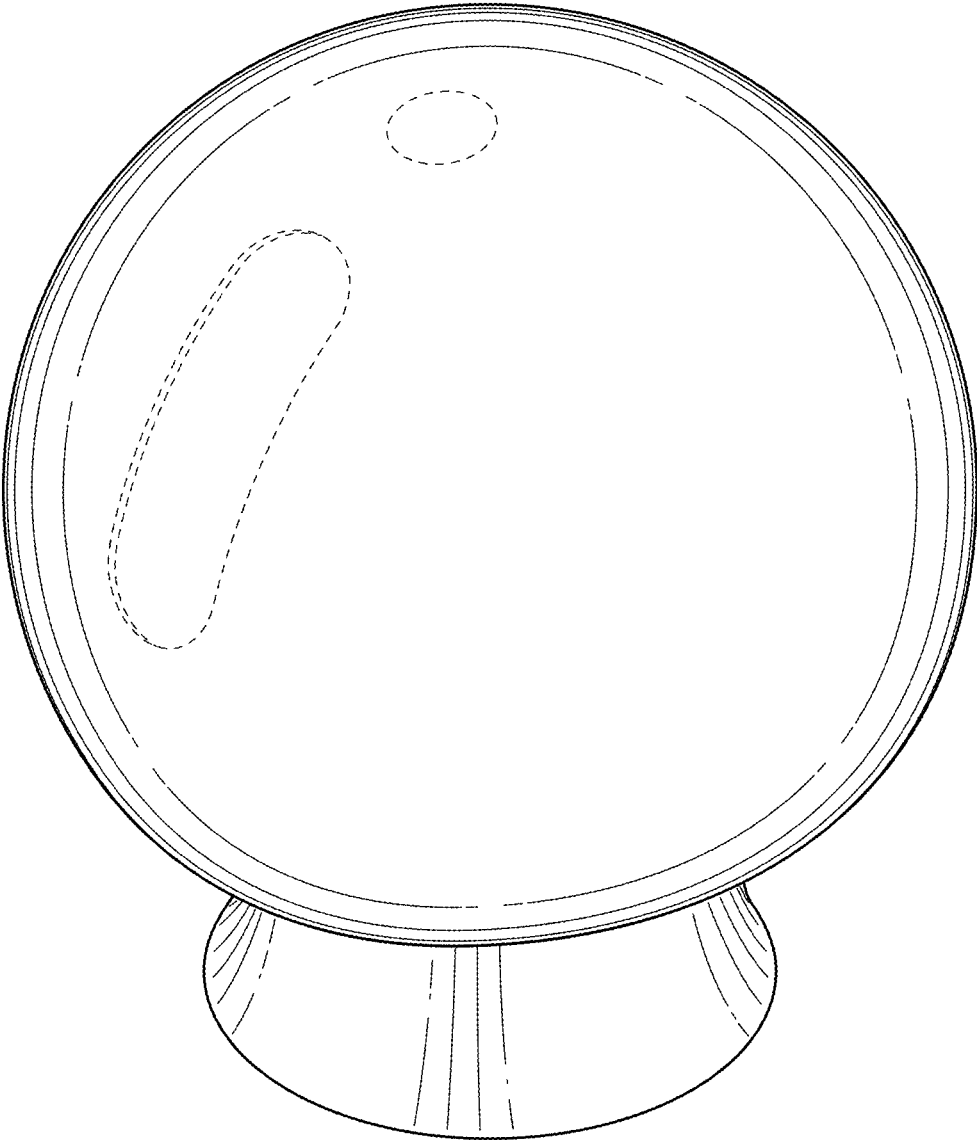

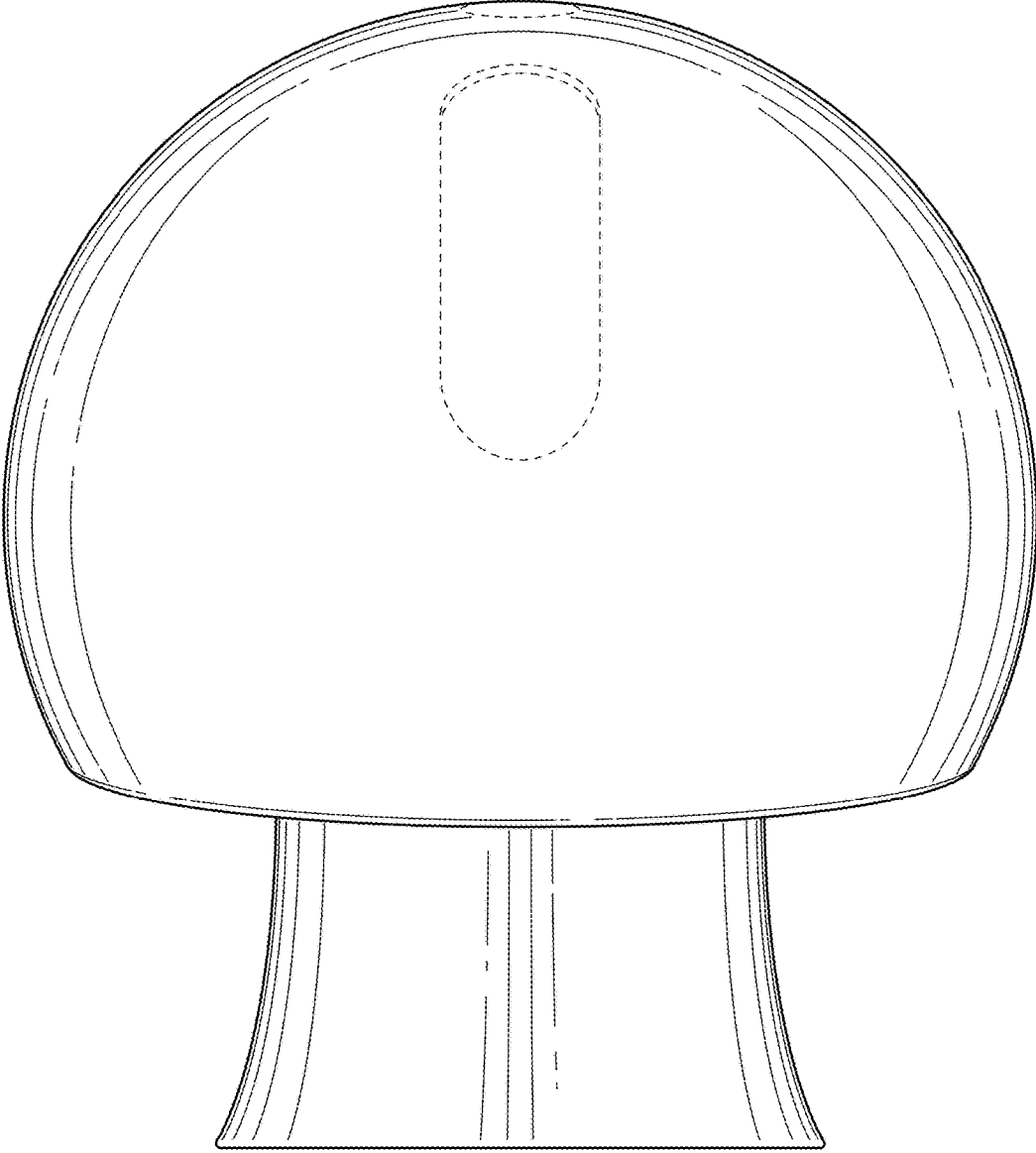

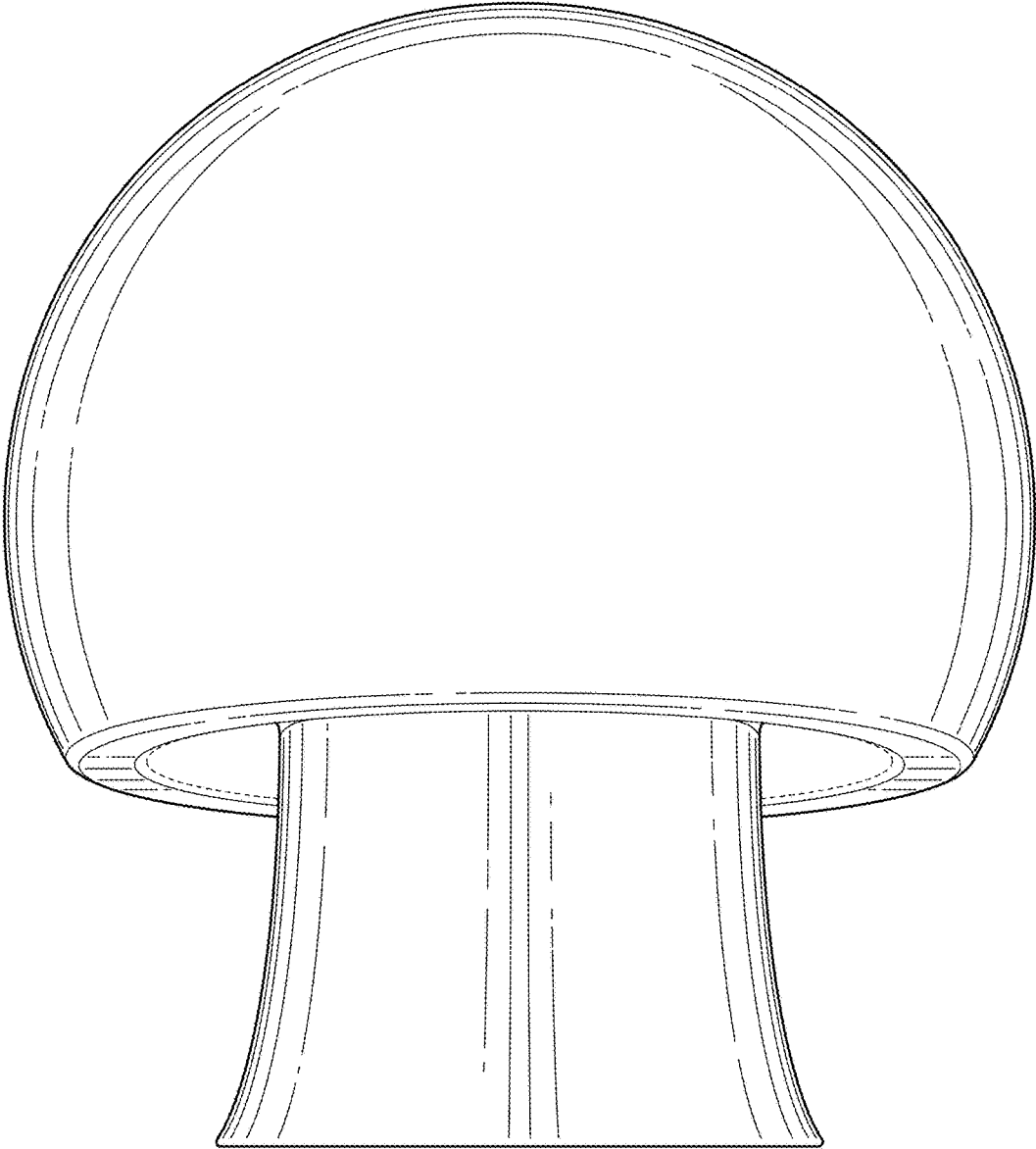

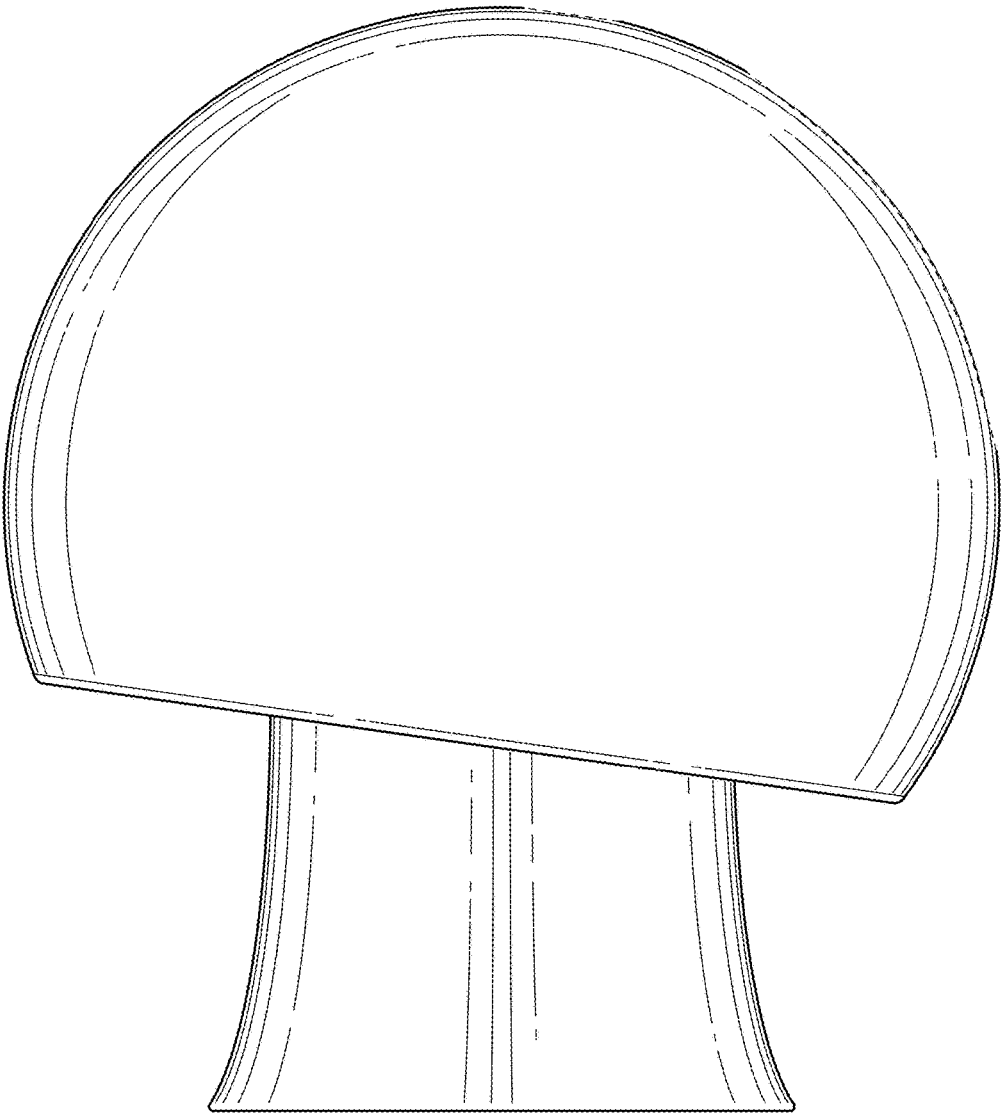

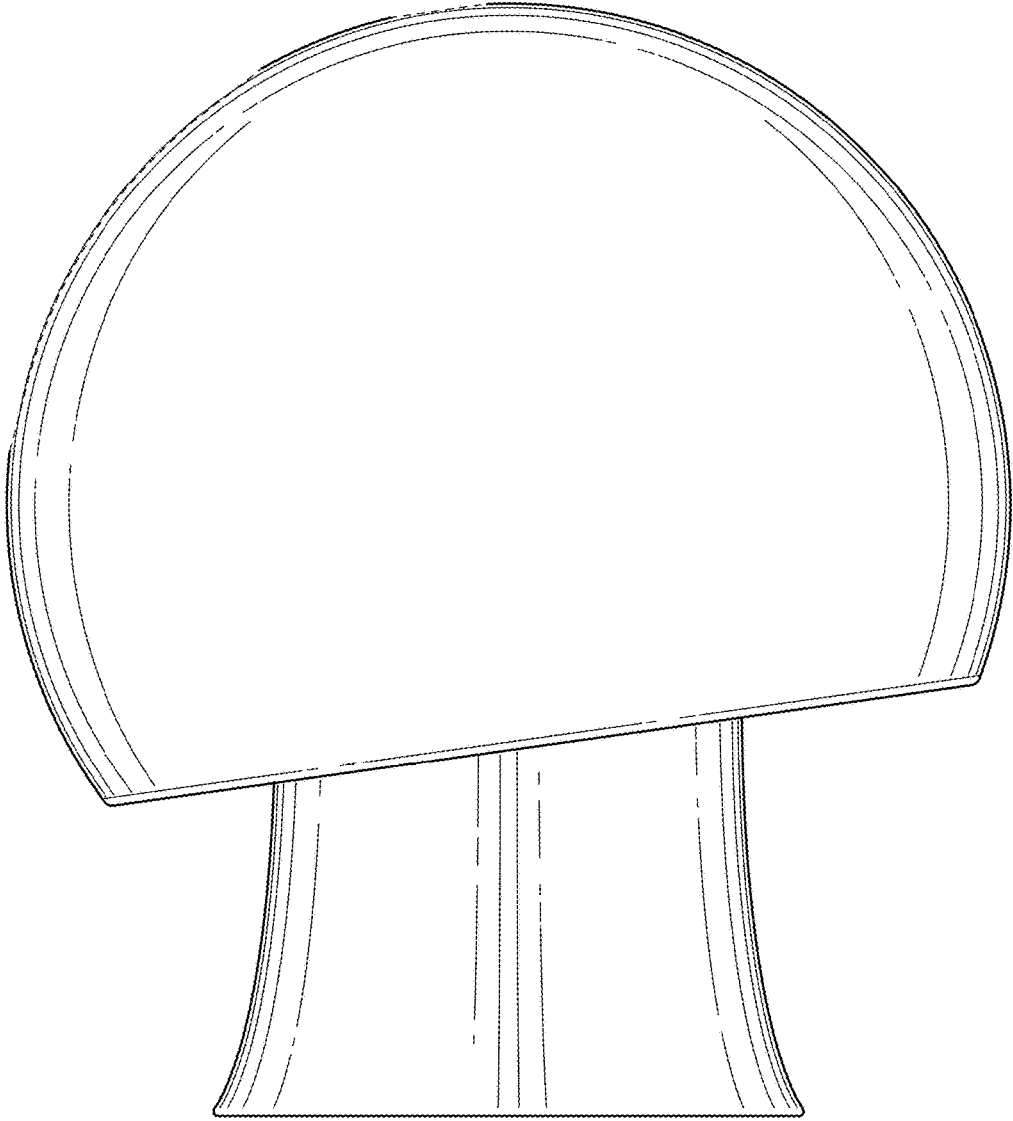

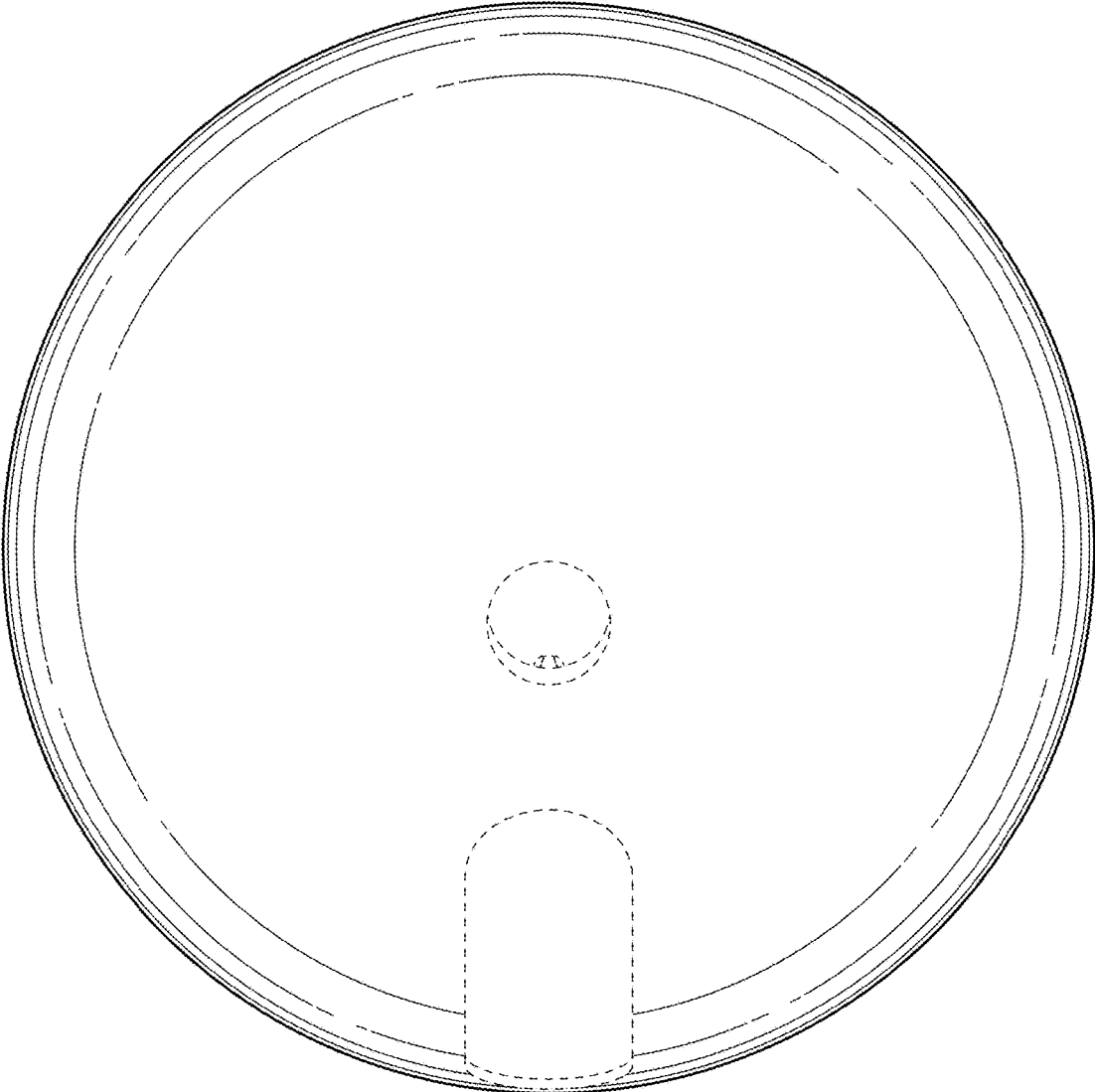

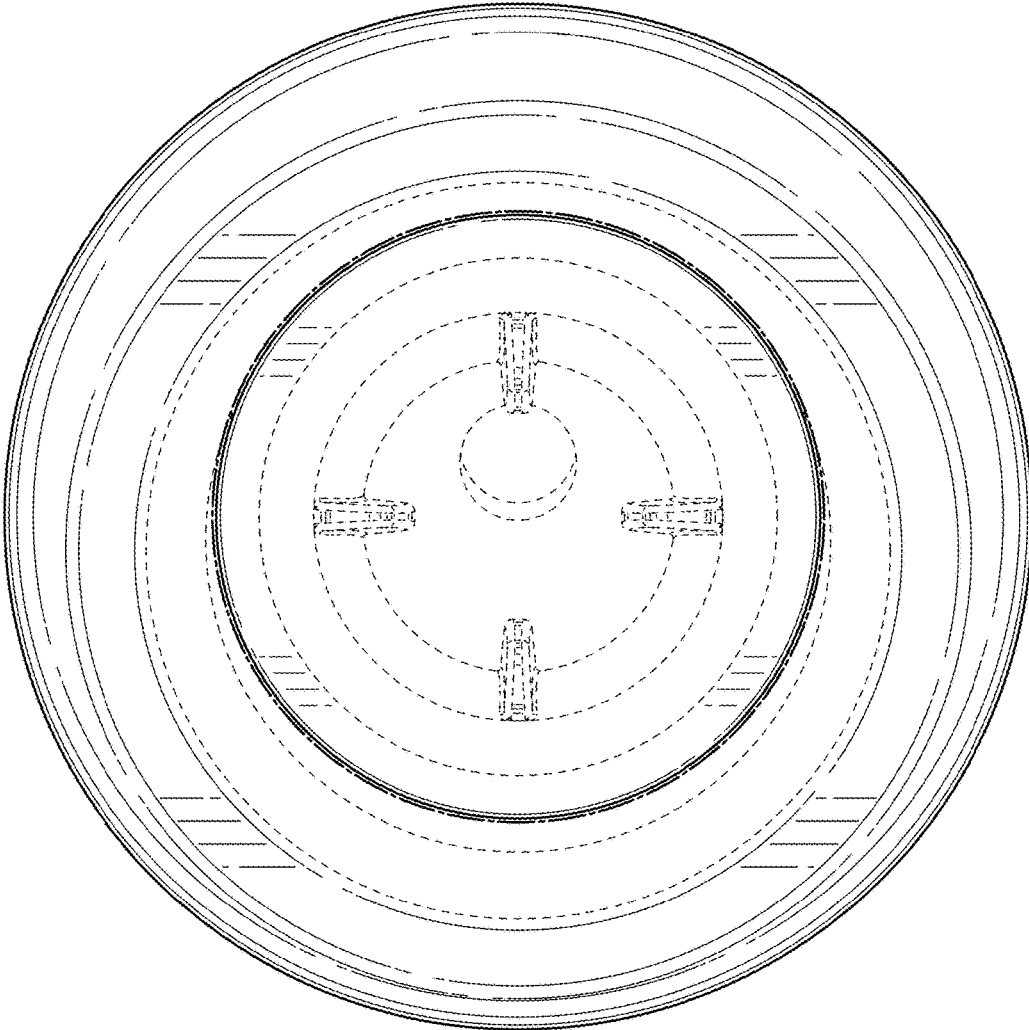
