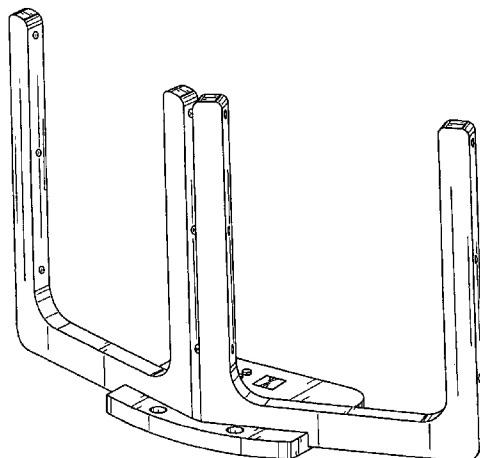
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear perspective view of a beam activated musical instrument showing the present design;

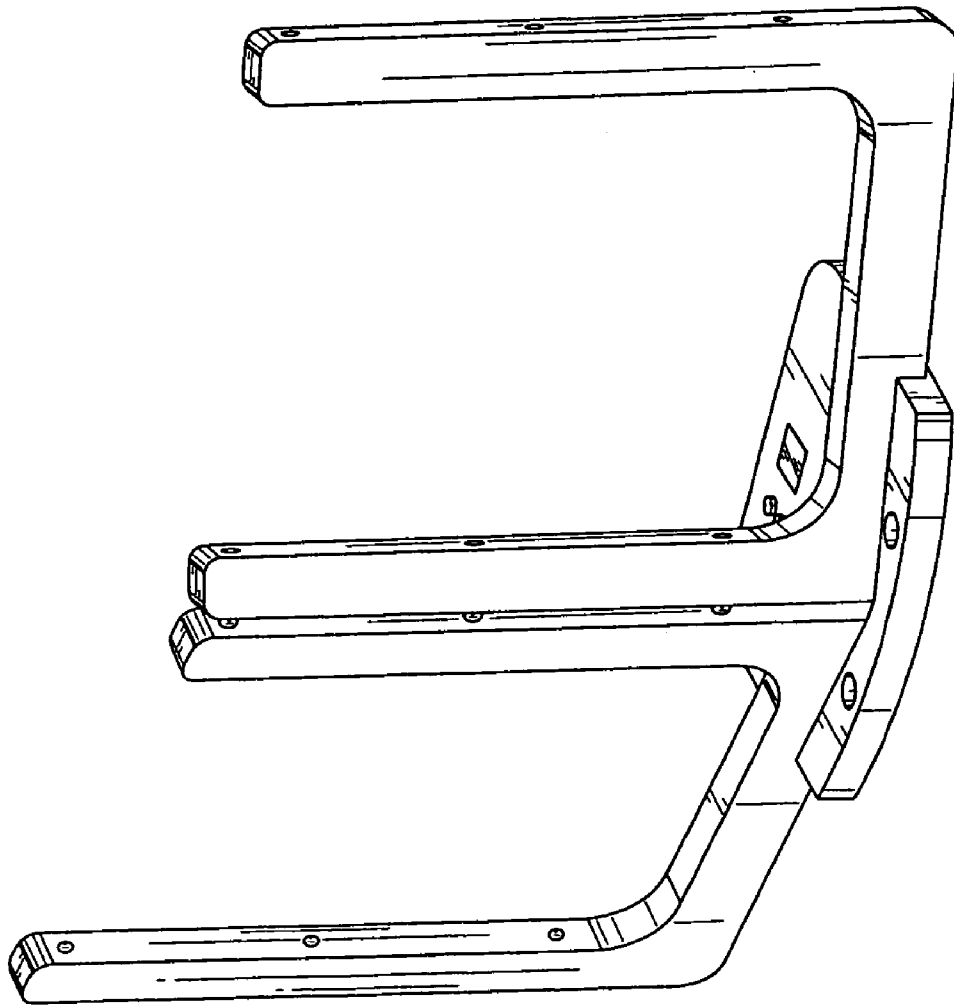

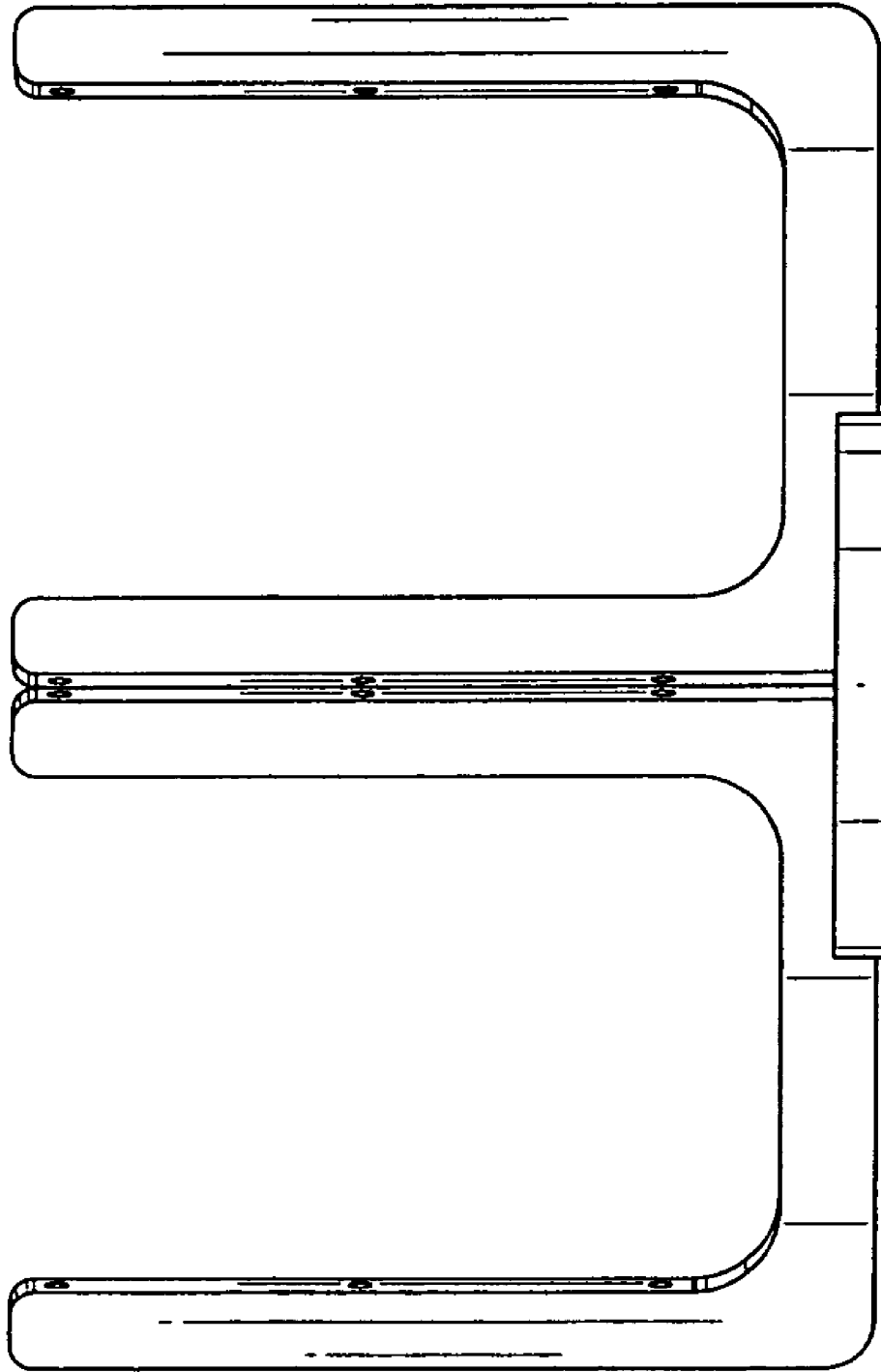

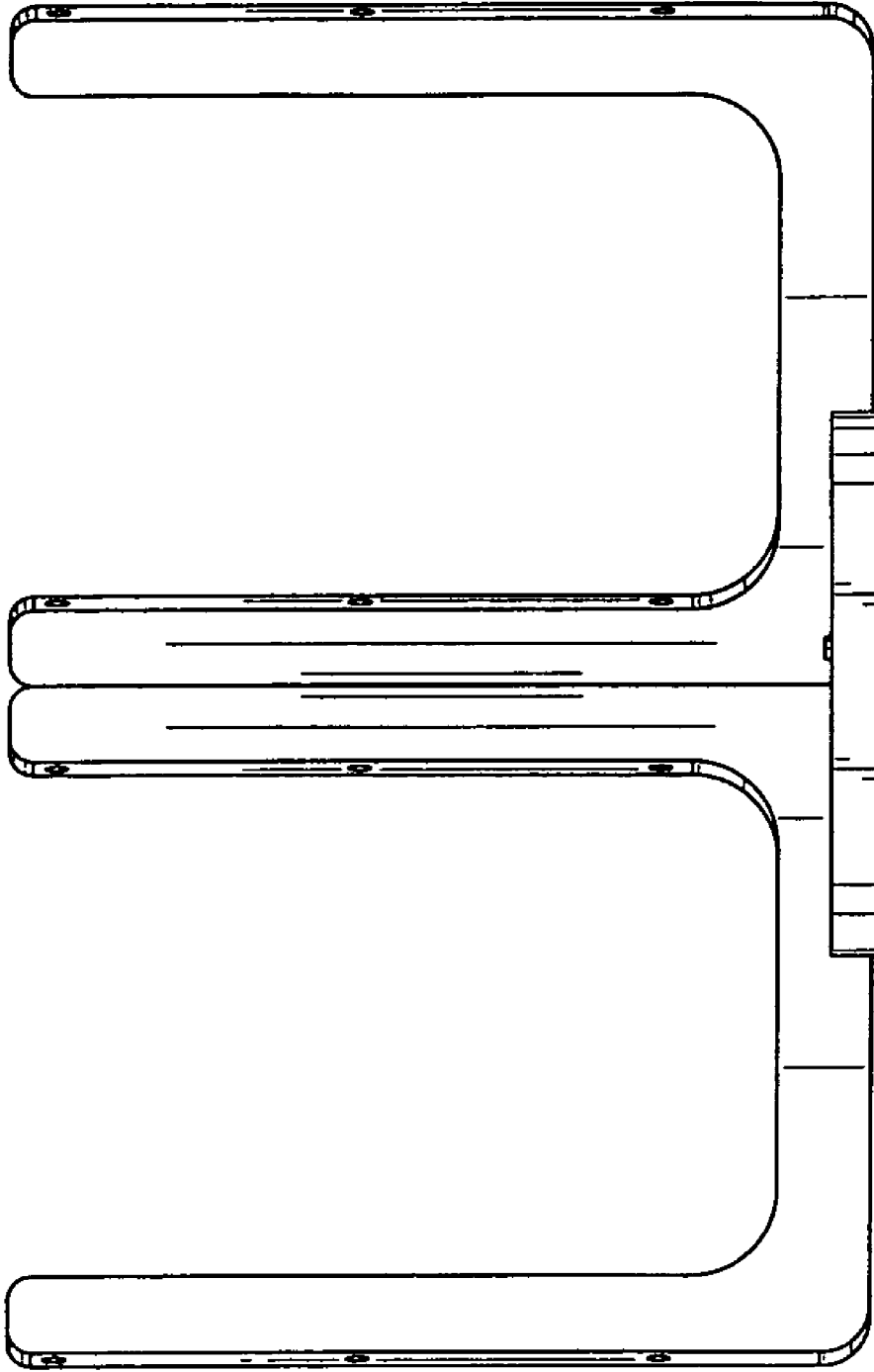

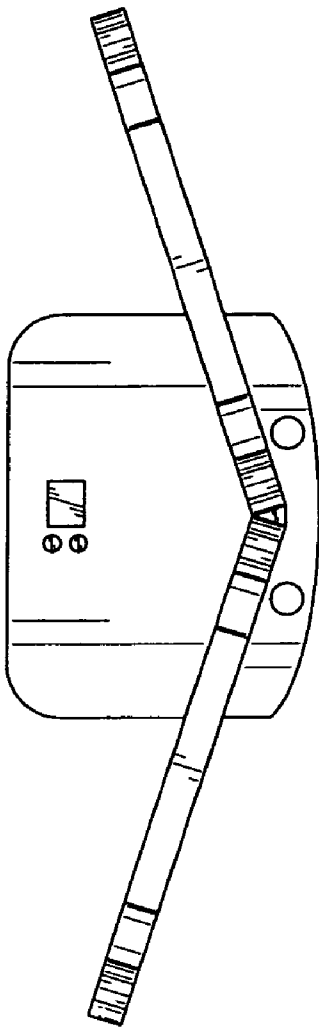

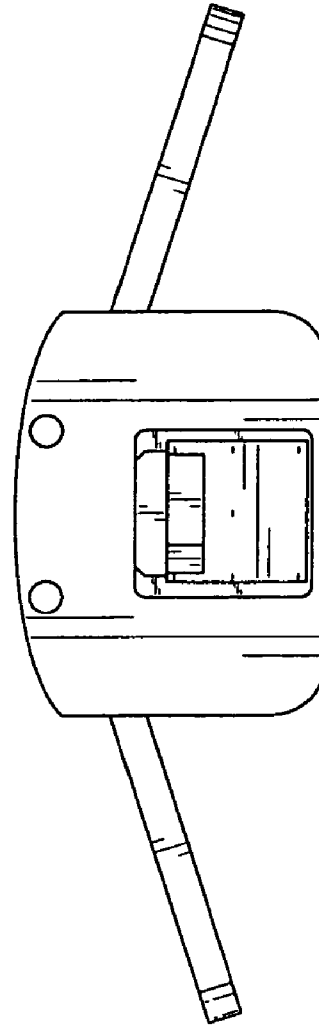

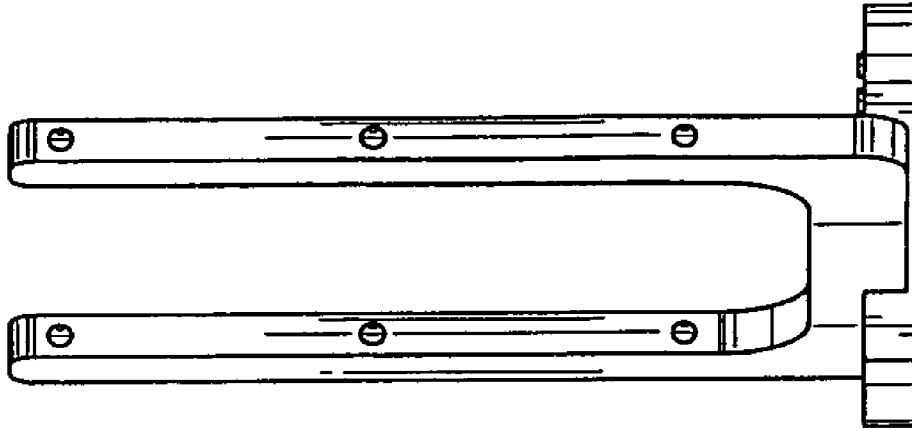

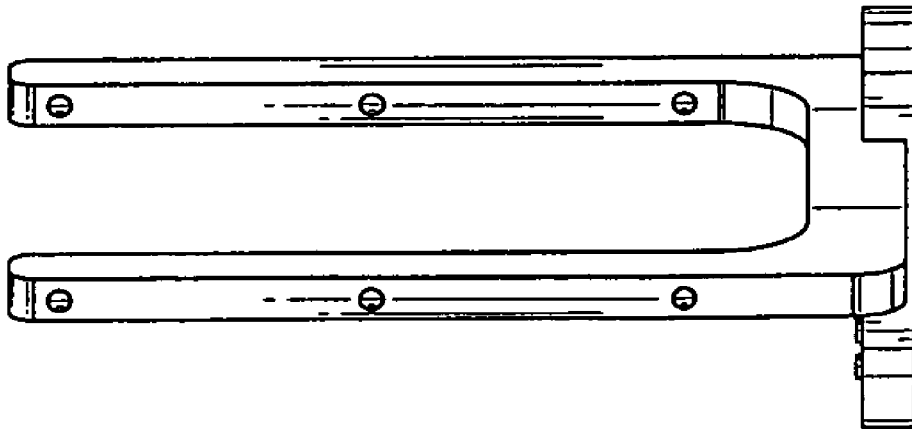
