(57) **CLAIM**

The ornamental design for a portable medication organizer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the portable medication organizer.

FIG. 2 is a front elevational view of the portable medication organizer;

FIG. 3 is a rear elevational view of the portable medication organizer;

FIG. 4 is a left side view of the portable medication organizer;

FIG. 5 is a right side view of the portable medication organizer;

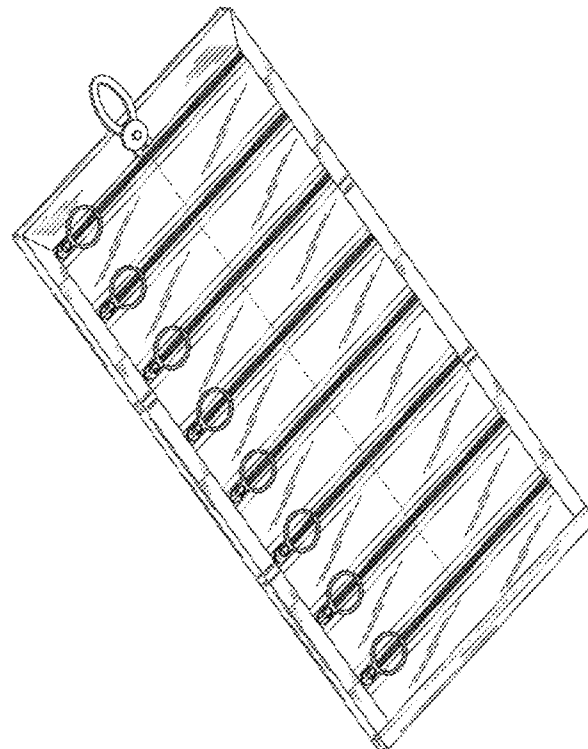
FIG. 6 is a top view of the portable medication organizer.

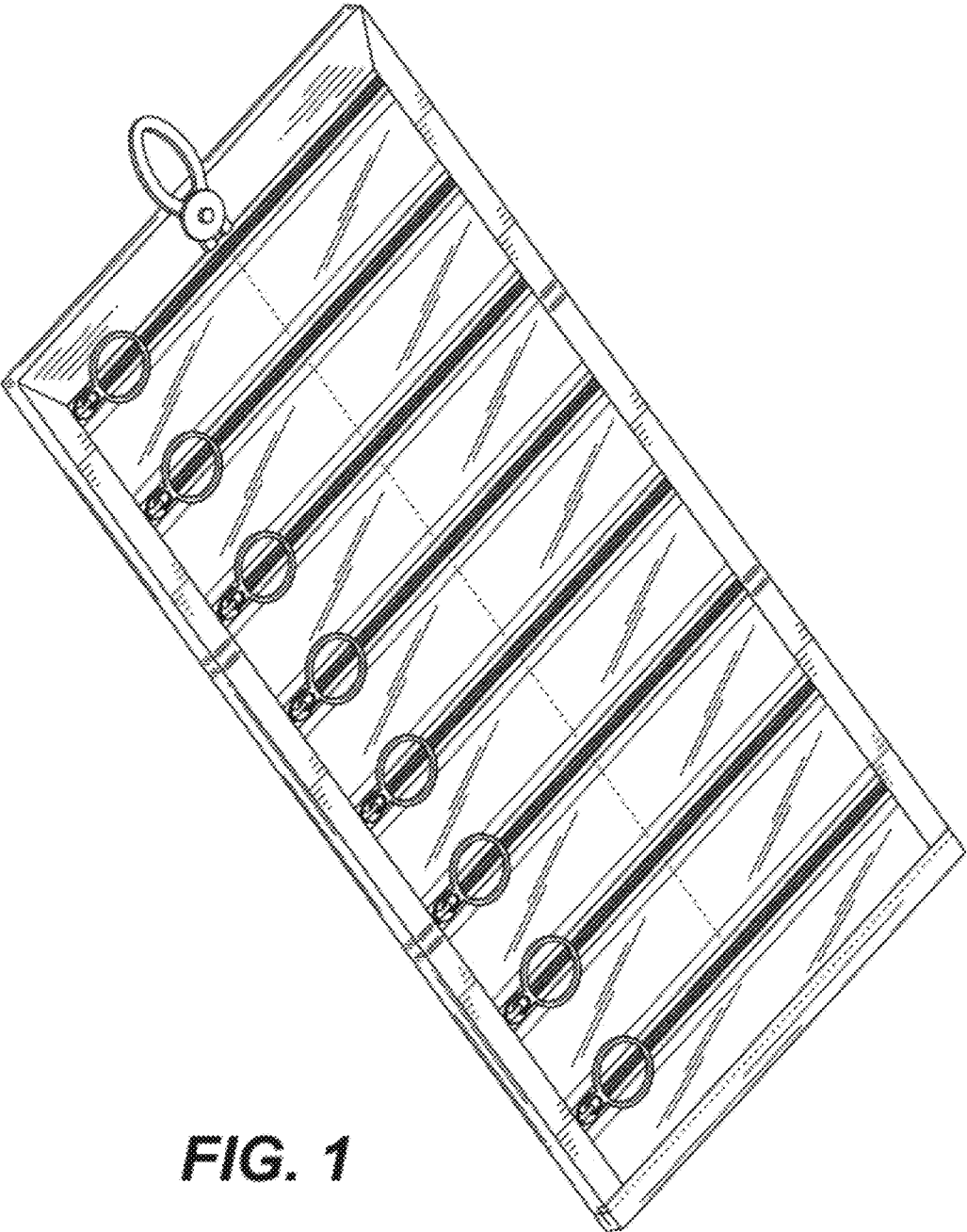

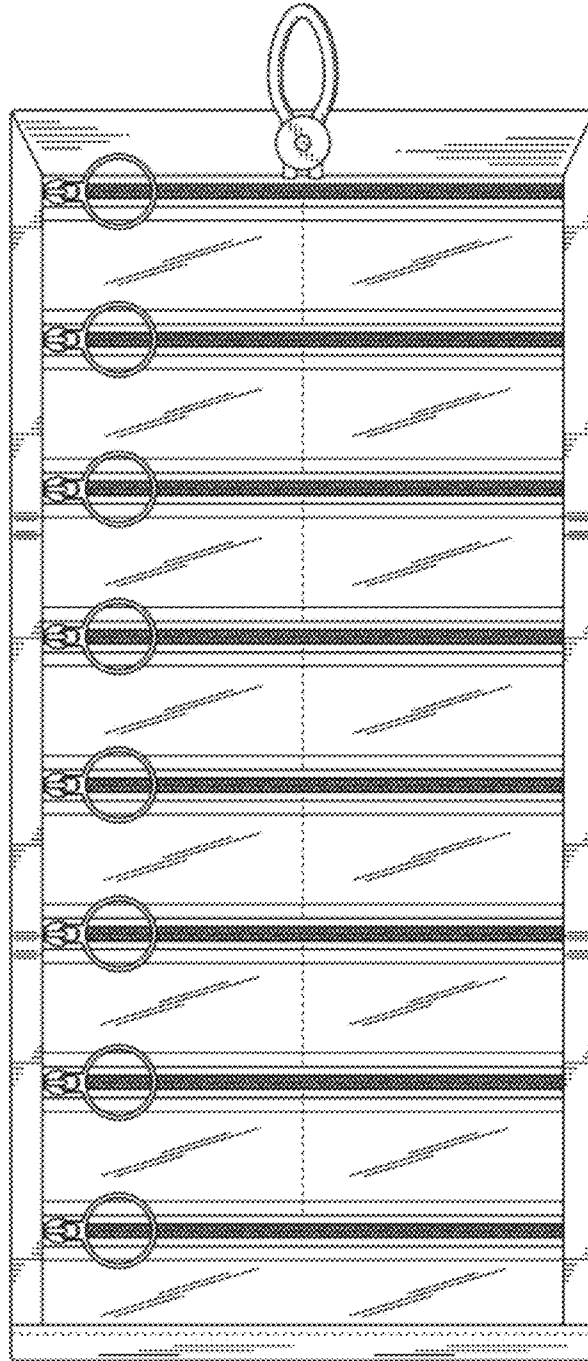

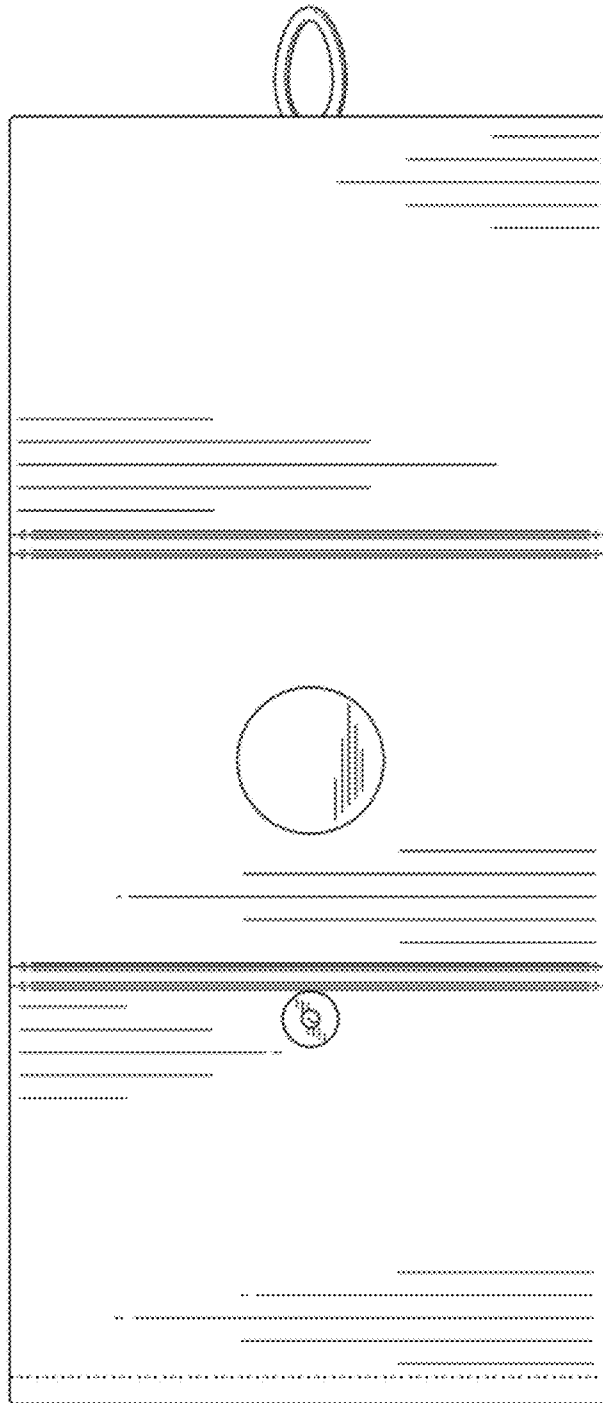

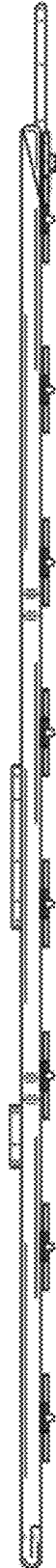

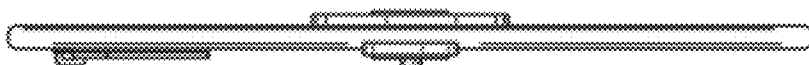

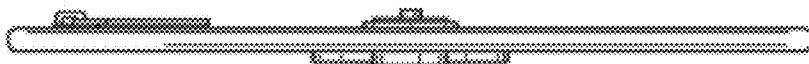

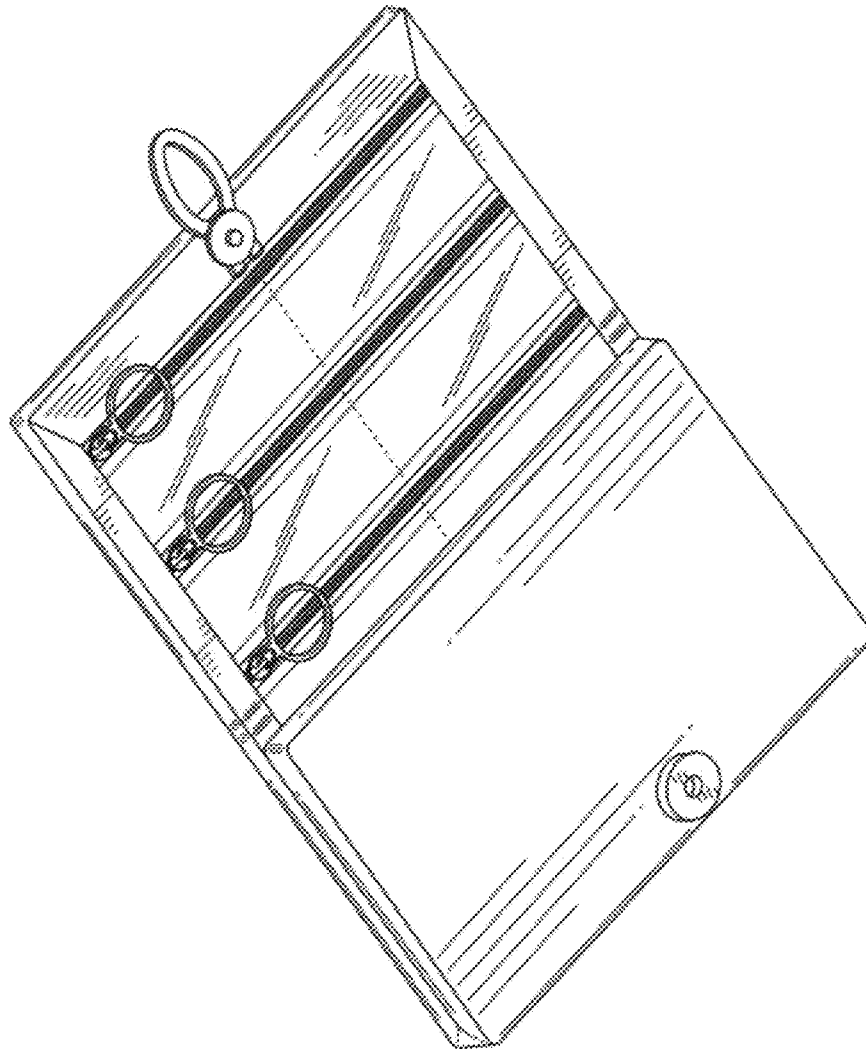

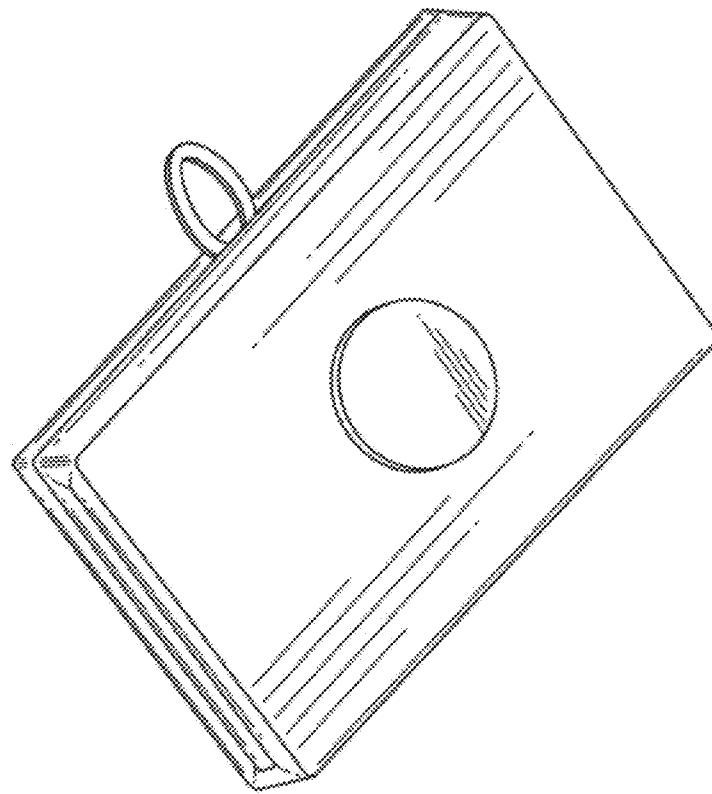
