FIG. 4 is a right side elevational view;

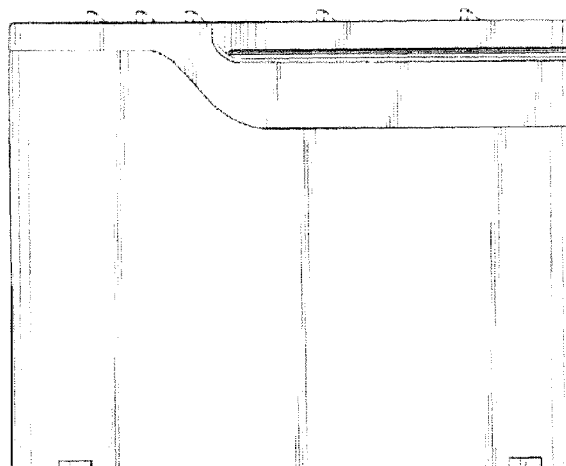
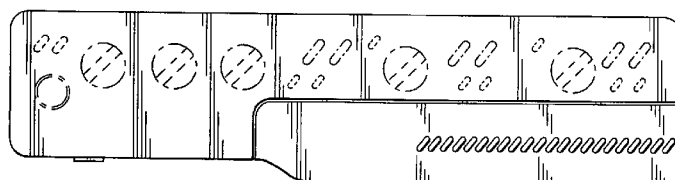
FIG. 5 is a bottom elevational view; and,

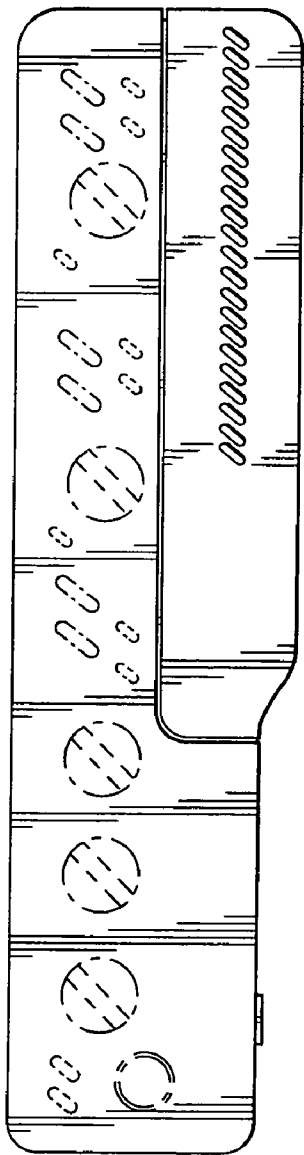

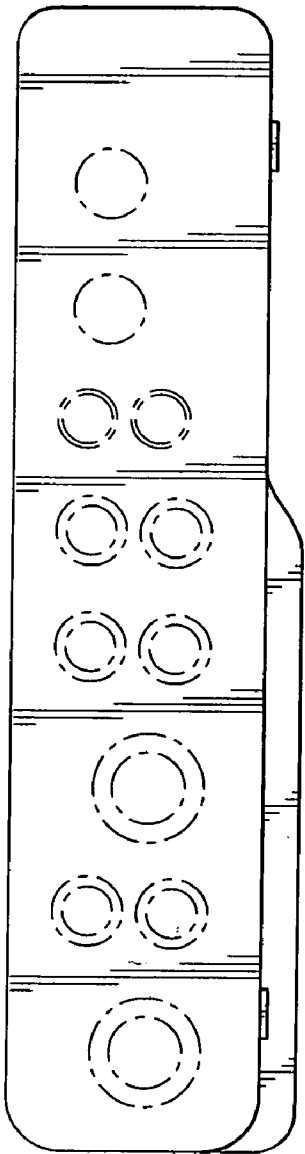

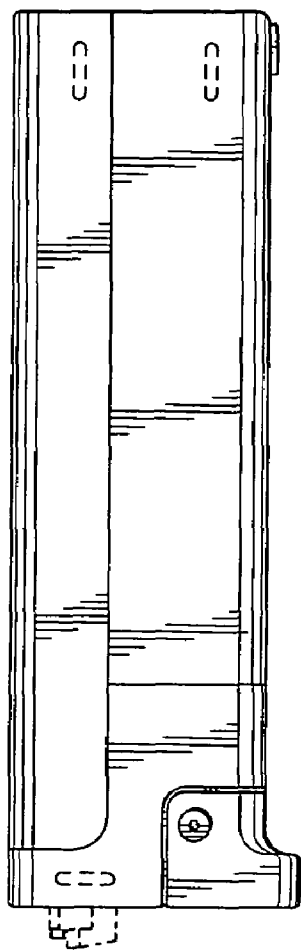

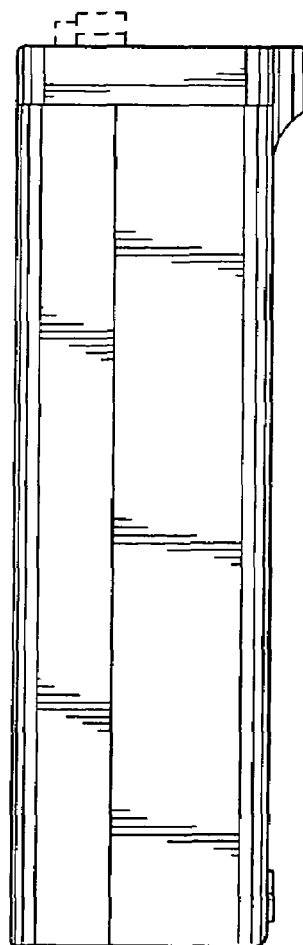

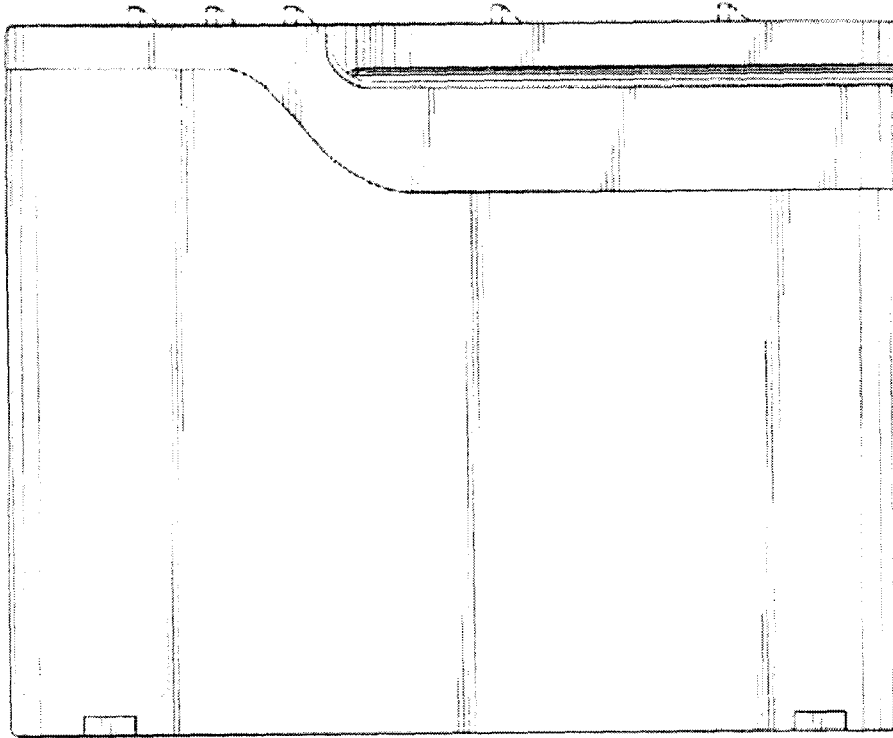

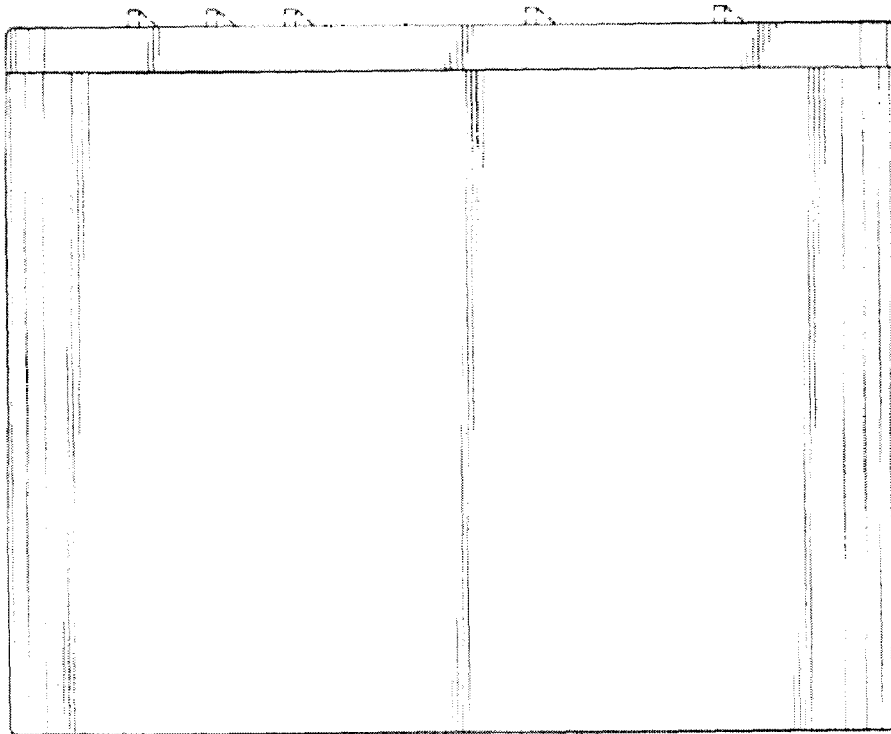
