(57) **CLAIM**

I claim the ornamental design for a batting helmet, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a batting helmet of the present design.

FIG. 2 is a top perspective view of the helmet of FIG. 1.

FIG. 3 is a side view of the helmet of FIG. 1.

FIG. 4 is a front view of the helmet of FIG. 1.


FIG. 5 is top view of the helmet of FIG. 1.














