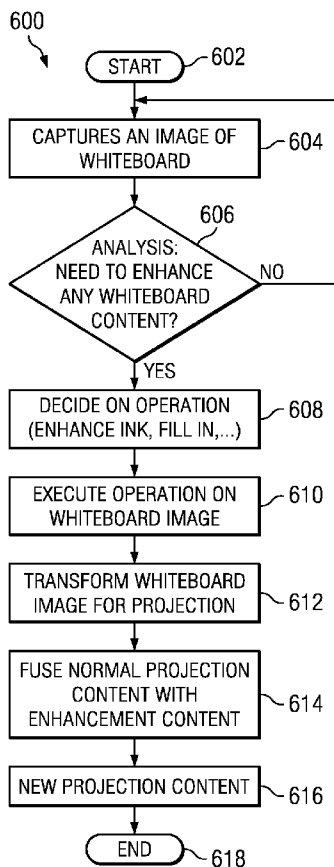

(57) **Abstract:** A method and apparatus for projecting enhanced information on a white board that include capturing 604 an image of information on a white board, analyzing 606 the captured image and determining 608 the type of enhancement needed for the information displayed, enhancing 610 the information in the image according to the determined type of enhancement, and projecting 616 the enhanced information on the white board.
