

The ornamental design for a front panel for a computer housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a front panel for a computer housing showing our new design, the housing is shown in broken lines for illustrative purposes only and forms part of the claimed design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image; FIG. 4 is a rear elevational view thereof; FIG. 5 is a bottom plan view thereof.








