(57) **CLAIM**

The ornamental design for a remote control for a light bar or spotlight, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of one preferred embodiment of a remote control for a light bar or spotlight incorporating our new design, illustrating the control cables in phantom;

FIG. 2 is a rear elevation view of the FIG. 1 embodiment;

FIG. 3 is a top plan view of the FIG. 1 embodiment;

FIG. 4 is a bottom plan view of the FIG. 1 embodiment;

FIG. 5 is a left side elevational view of the FIG. 1 embodiment;

FIG. 6 is a right side elevational view of the FIG. 1 embodiment; and

FIG. 7 is a front, top and left side perspective view of the FIG. 1 embodiment.

FIG. 8 is a front elevational view of another preferred embodiment of a remote control for a light bar or spotlight incorporating our new design;

FIG. 9 is a rear elevation view of the FIG. 8 embodiment;

FIG. 10 is a top plan view of the FIG. 8 embodiment;

FIG. 11 is a bottom plan view of the FIG. 8 embodiment;

FIG. 12 is a left side elevational view of the FIG. 8 embodiment;

FIG. 13 is a right side elevational view of the FIG. 8 embodiment; and,

FIG. 14 is a front, top and right side perspective view of the FIG. 8 embodiment.




























