

(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a tire showing our new design, the opposite side perspective being a mirror image thereof, it being understood that the tread forms no part of the claimed design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right elevation view thereof;
FIG. 5 is a left elevation view thereof;
FIG. 6 is a top elevation view thereof;
FIG. 7 is a bottom elevation view thereof; and,
FIG. 8 is a cross-sectional view taken along line 8-8 of FIG. 2.
















