DESCRIPTION

FIG. 1 is a front, top and right-side perspective view of an air humidifier showing my new design;

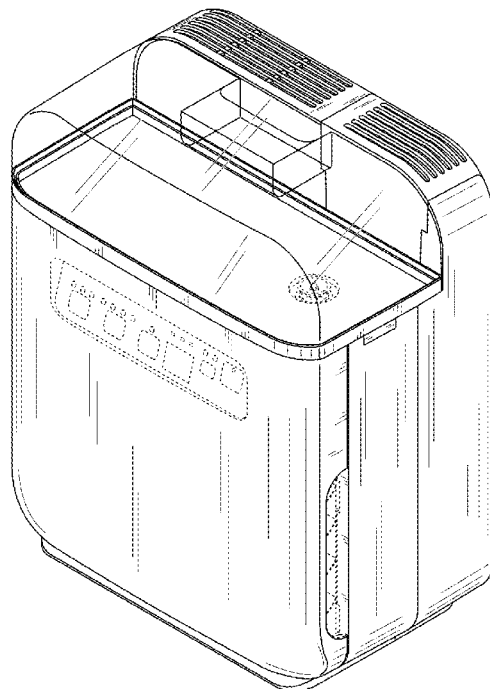

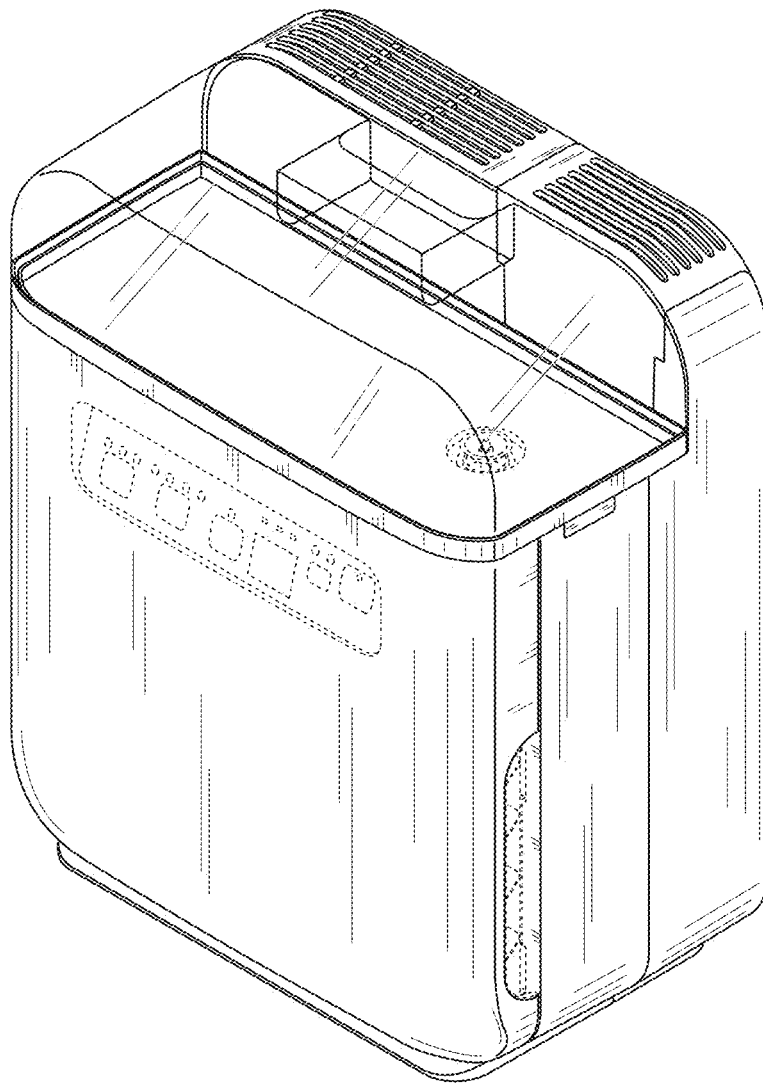

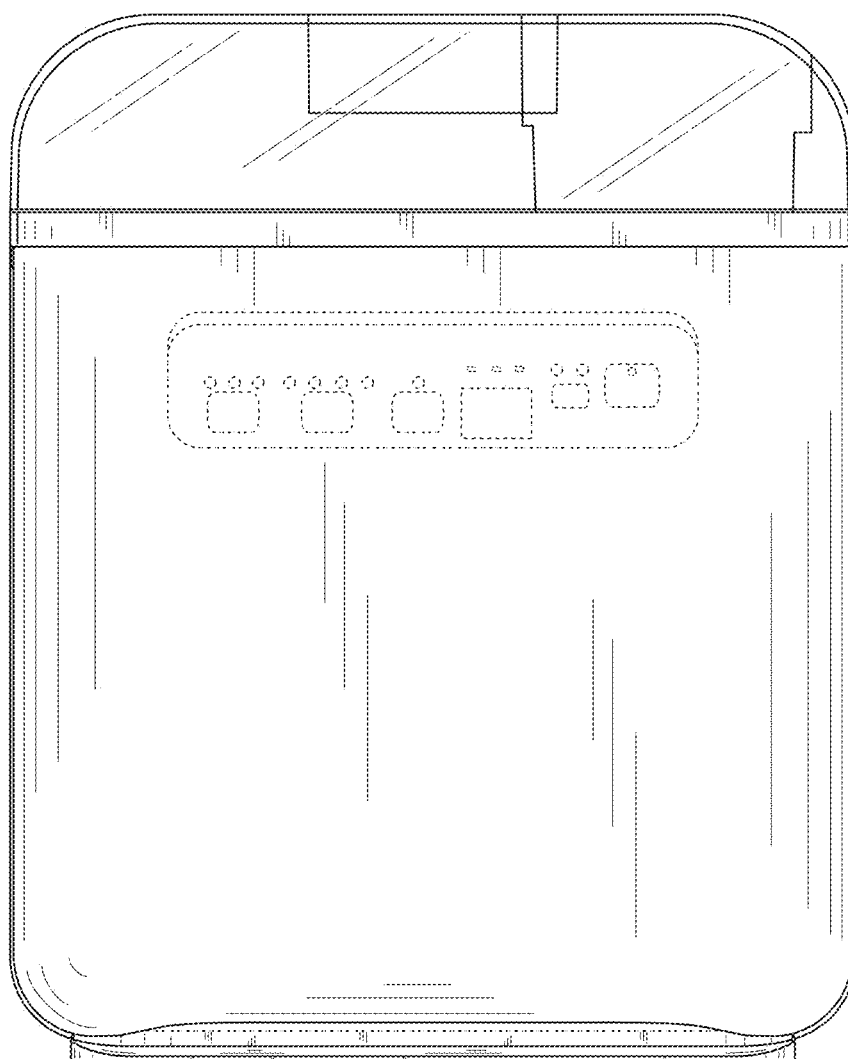

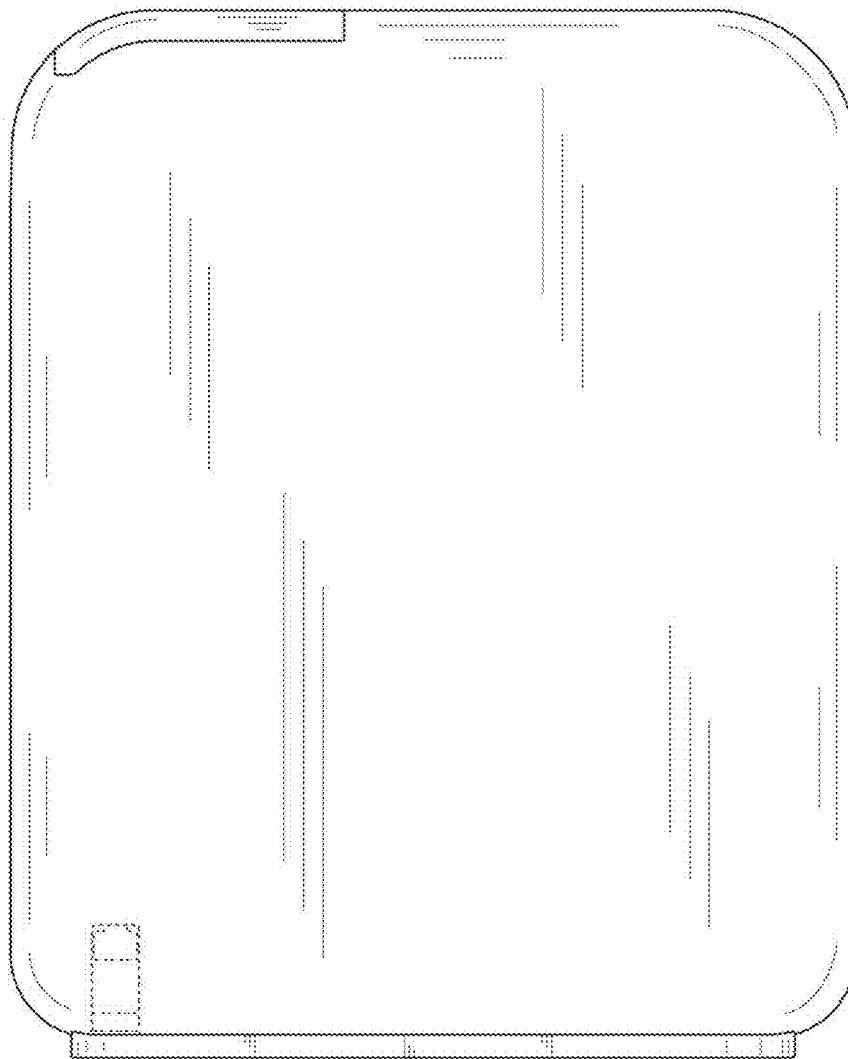

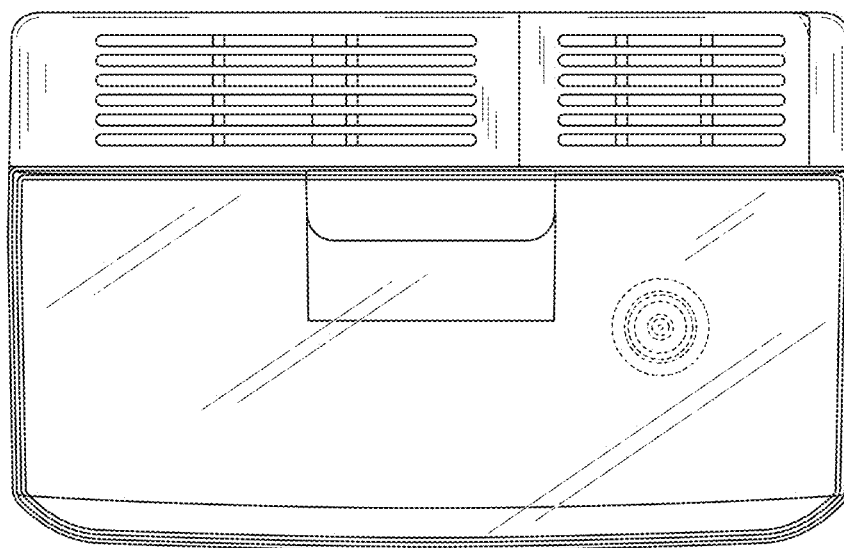

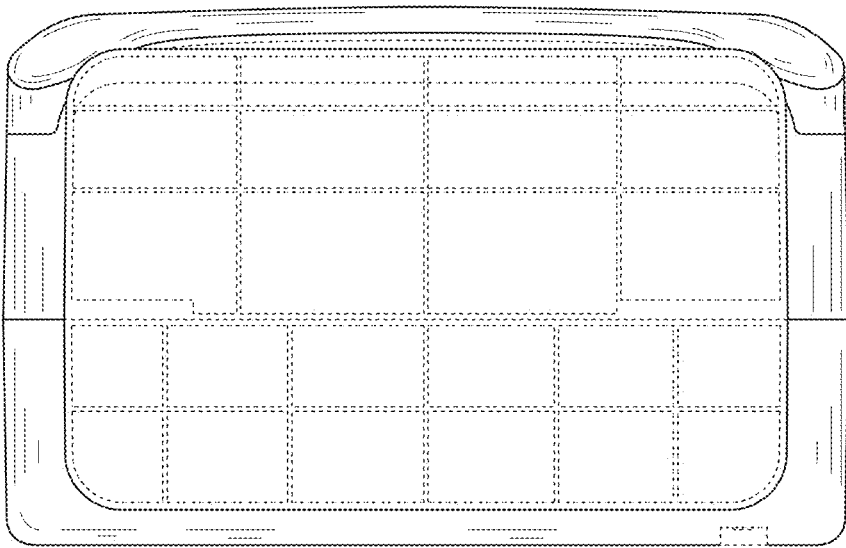

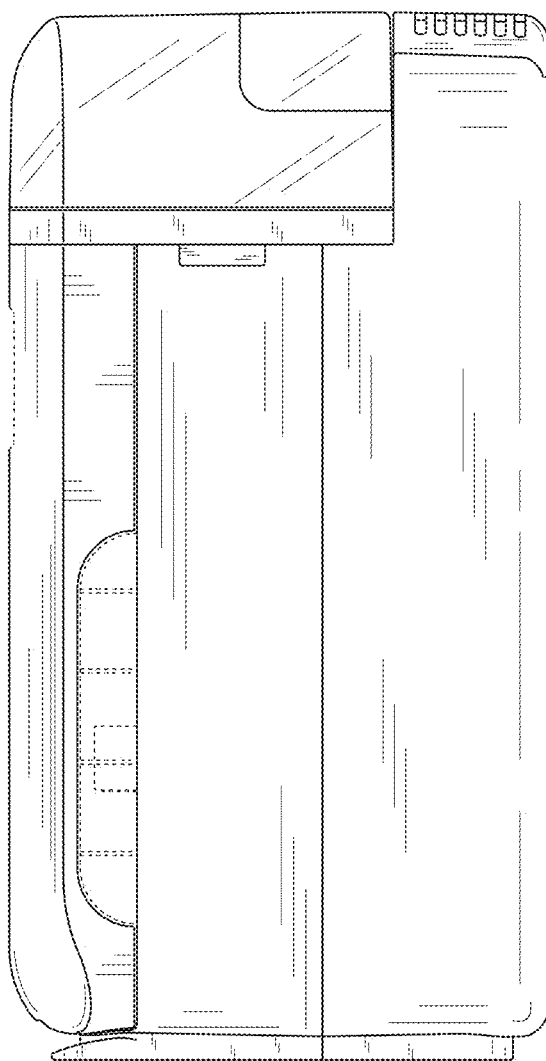
