
(57) **CLAIM**

The ornamental design for a shallow mesh grilling bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the shallow mesh grilling bowl.  
FIG. 2 is a bottom view of the shallow mesh grilling bowl.  
FIG. 3 is a front side view of the shallow mesh grilling bowl.












