
(57) **CLAIM**

The ornamental design for an armored vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an armored vehicle showing our new design.  
FIG. 2 is a rear view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a front and left side perspective view thereof;  
FIG. 6 is a rear and left side perspective view thereof; and,  
FIG. 7 is a top, front and right side perspective view thereof.














