(57) **CLAIM**

We claim the ornamental design for an exhaust cover, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a first embodiment for an exhaust cover according to the present invention, shown in a state of use.

FIG. 2 is a front, right side perspective view of the exhaust cover shown in FIG. 1.

FIG. 3 is a second front, right side perspective view of the exhaust cover shown in FIG. 1, enlarged for ease of illustration.

FIG. 4 is a top, right, rear side perspective view of the exhaust cover shown in FIG. 1, enlarged for ease of illustration.

FIG. 5 is a right, rear side perspective view of the exhaust cover shown in FIG. 1, enlarged for ease of illustration.

FIG. 6 is top, front, right side perspective view of exhaust cover shown in FIG. 1, removed from the environment for ease of illustration.

FIG. 7 is a front, elevational view of the exhaust cover shown in FIG. 1.

FIG. 8 is a rear, elevational view of the exhaust cover shown in FIG. 1.

FIG. 9 is a right side elevational view of the exhaust cover shown in FIG. 1.

FIG. 10 is a left side elevational view of the exhaust cover shown in FIG. 1.

FIG. 11 is a top plan view of the exhaust cover shown in FIG. 1.

FIG. 12 is a top, front, right side perspective view of a second embodiment of an exhaust cover.

FIG. 13 is a front, elevational view of the exhaust cover shown in FIG. 12.

FIG. 14 is a right side elevational view of the exhaust cover shown in FIG. 12.

FIG. 15 is a left side elevational view of the exhaust cover shown in FIG. 12.

FIG. 16 is a top plan view of the exhaust cover shown in FIG. 12.

FIG. 17 is a top, front, right side perspective view of a third embodiment of an exhaust cover.




FIG. 18 is a front elevational view the exhaust cover shown in FIG. 17.












































