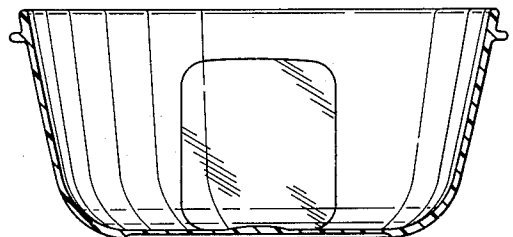
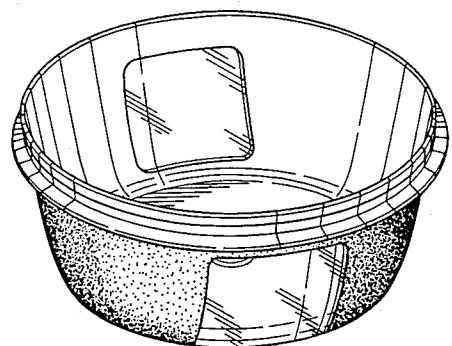
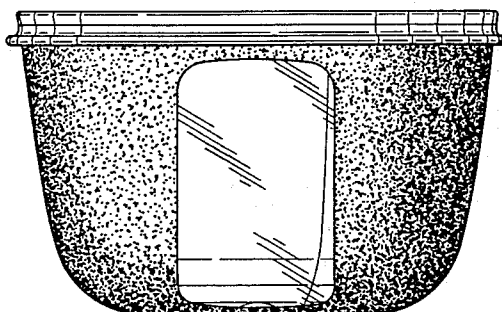
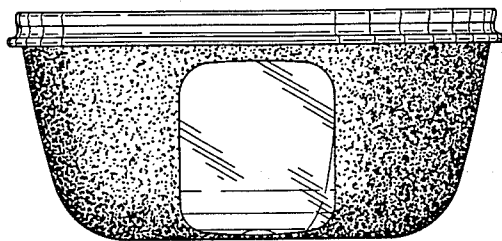
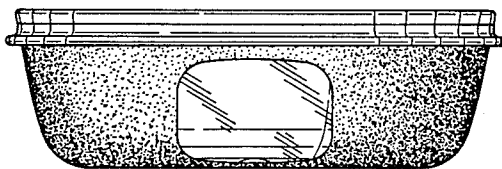

[57] CLAIM

The ornamental design for a bowl, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a bowl showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front or rear elevational view thereof;  
FIG. 4 is a left or right side elevational view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a top perspective view of a second embodiment of our new design for a bowl;  
FIG. 7 is a front or rear elevational view of the bowl of FIG. 6;  
FIG. 8 is a bottom plan view of the bowl of FIG. 6;  
FIG. 9 is a top perspective view of a third embodiment of our new design for a bowl;  
FIG. 10 is a front or rear elevational view of the bowl of FIG. 9; and  
FIG. 11 is a bottom plan view of the bowl of FIG. 9; and  
FIG. 12 is a sectional view taken on line 12—12 of FIG. 2.  
A top plan view of the bowl of FIG. 6 and FIG. 9 is substantially similar to the top plan view of FIG. 2.



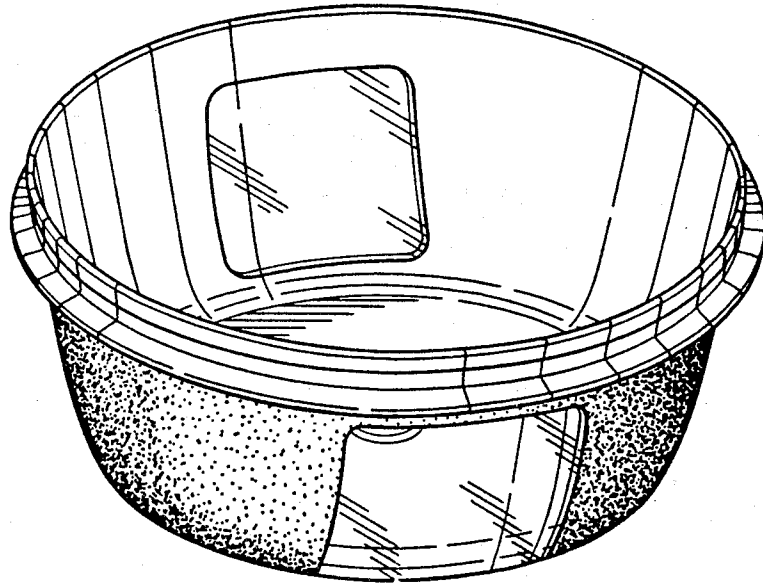

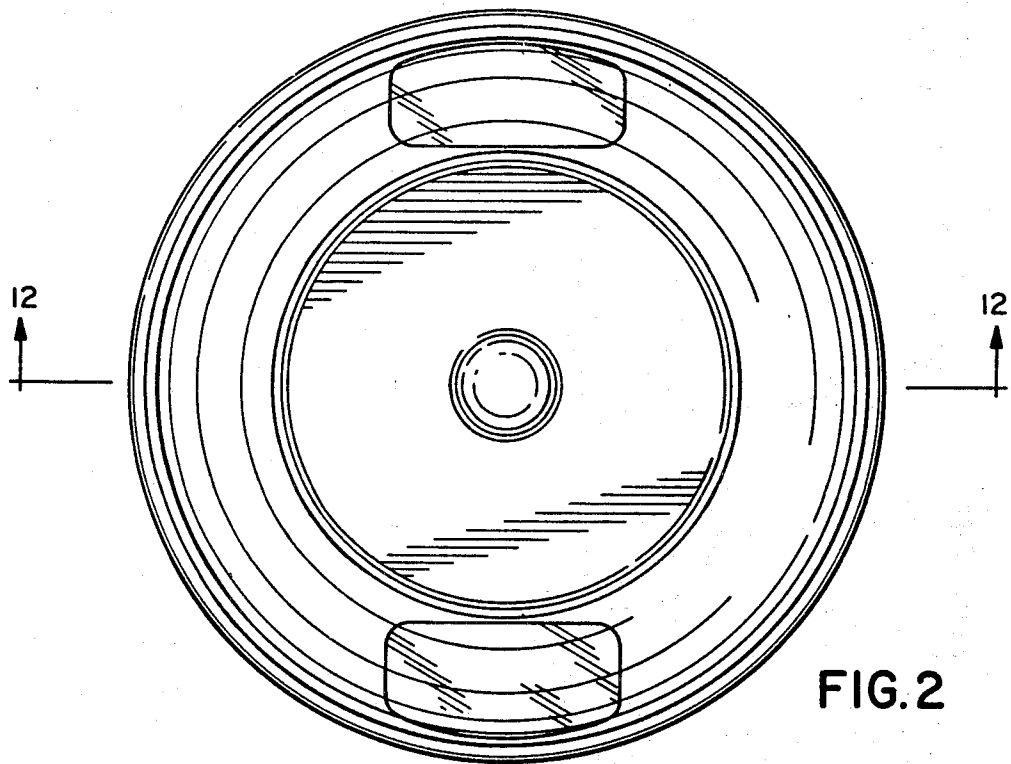

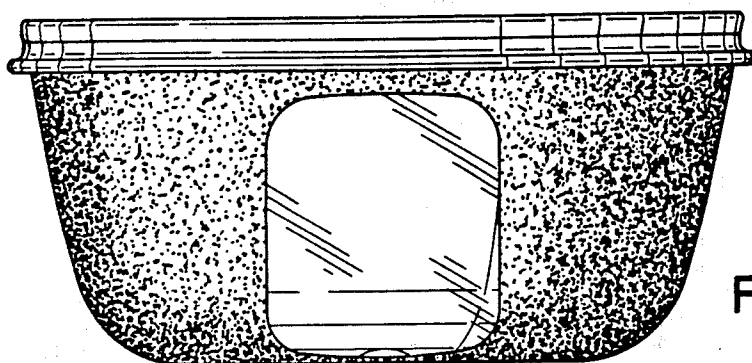

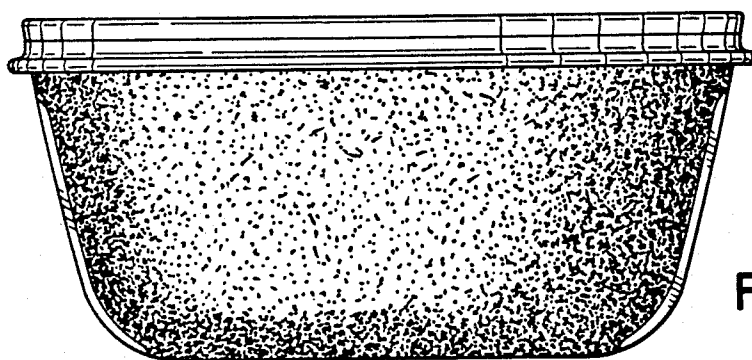

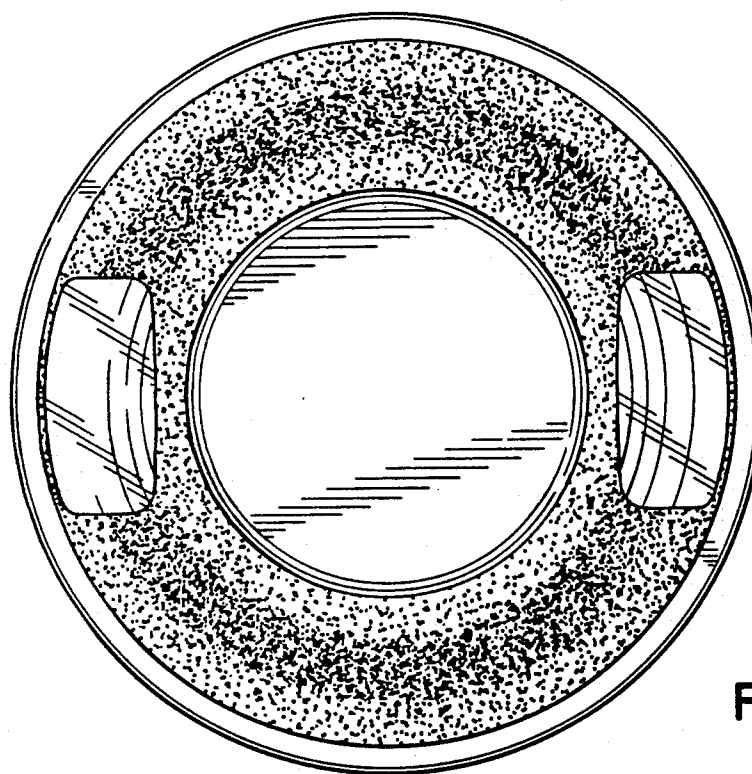

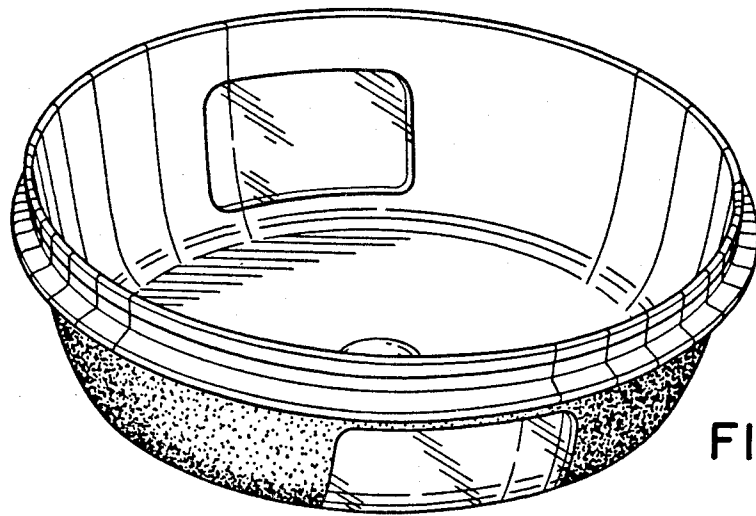

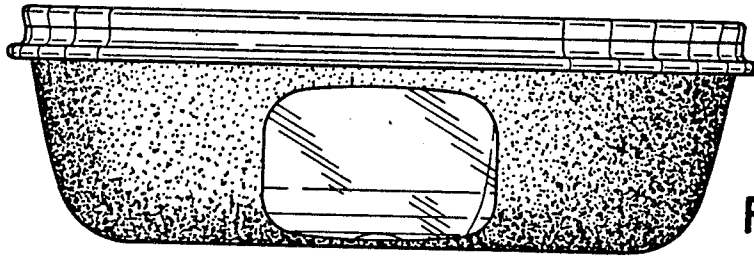

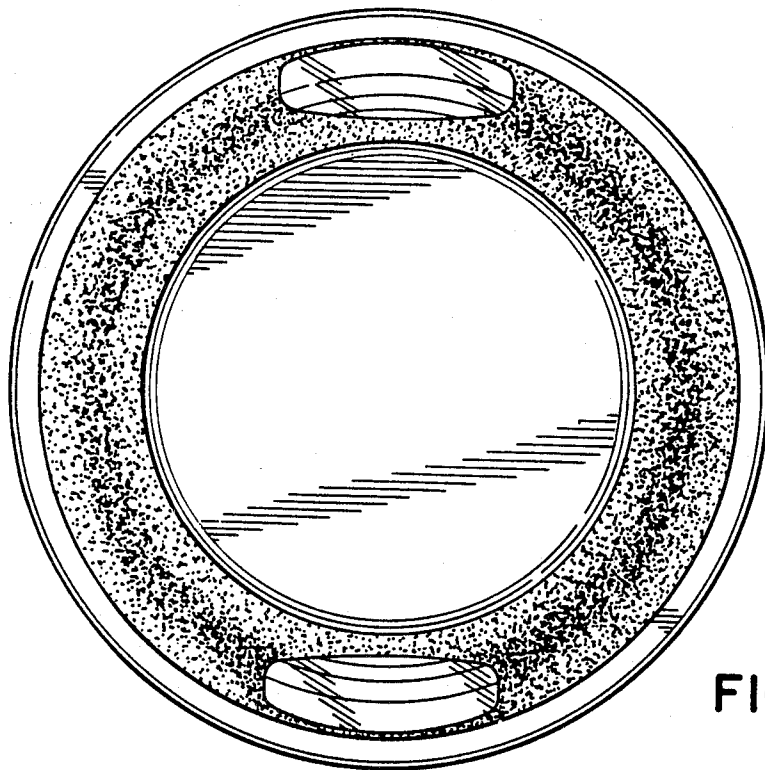

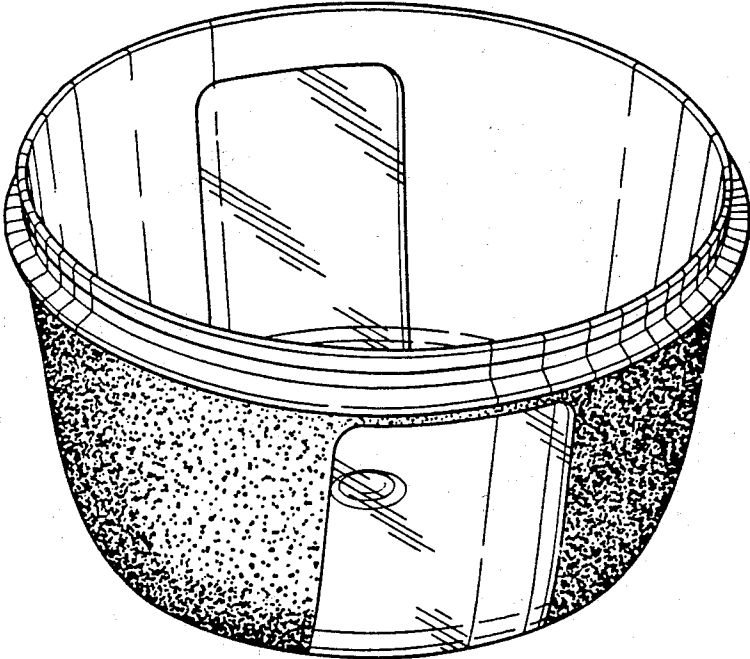

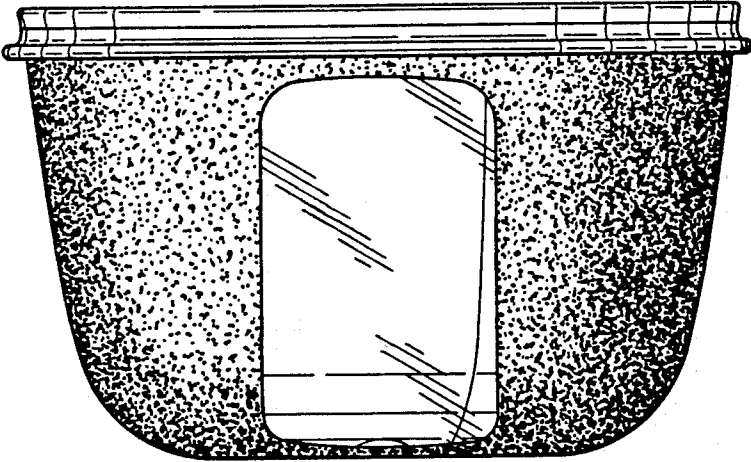

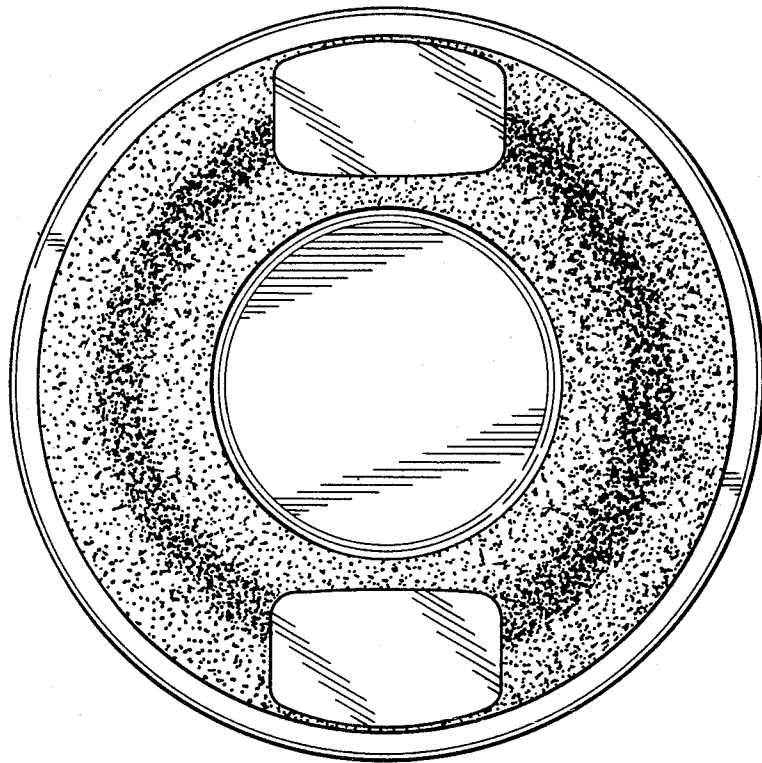

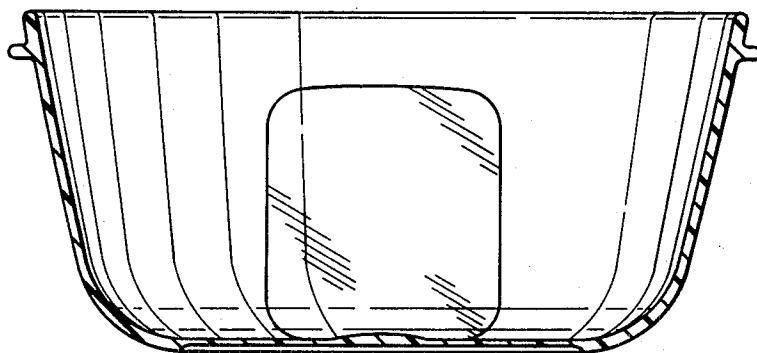
