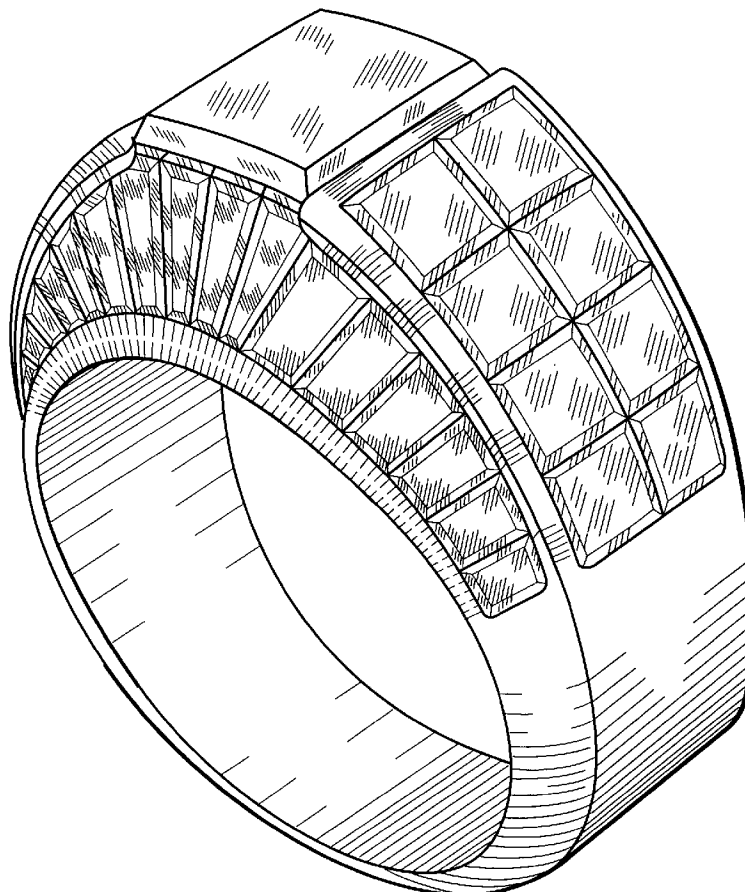
[57] **CLAIM**

The ornamental design for a finger ring, as shown and described.

DESCRIPTION

FIG. 1 is the front, right, side perspective view of a finger ring showing my new design;
FIG. 2 is a front elevational view thereof, the rear view being a mirror image;
FIG. 3 is a right or left side view thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

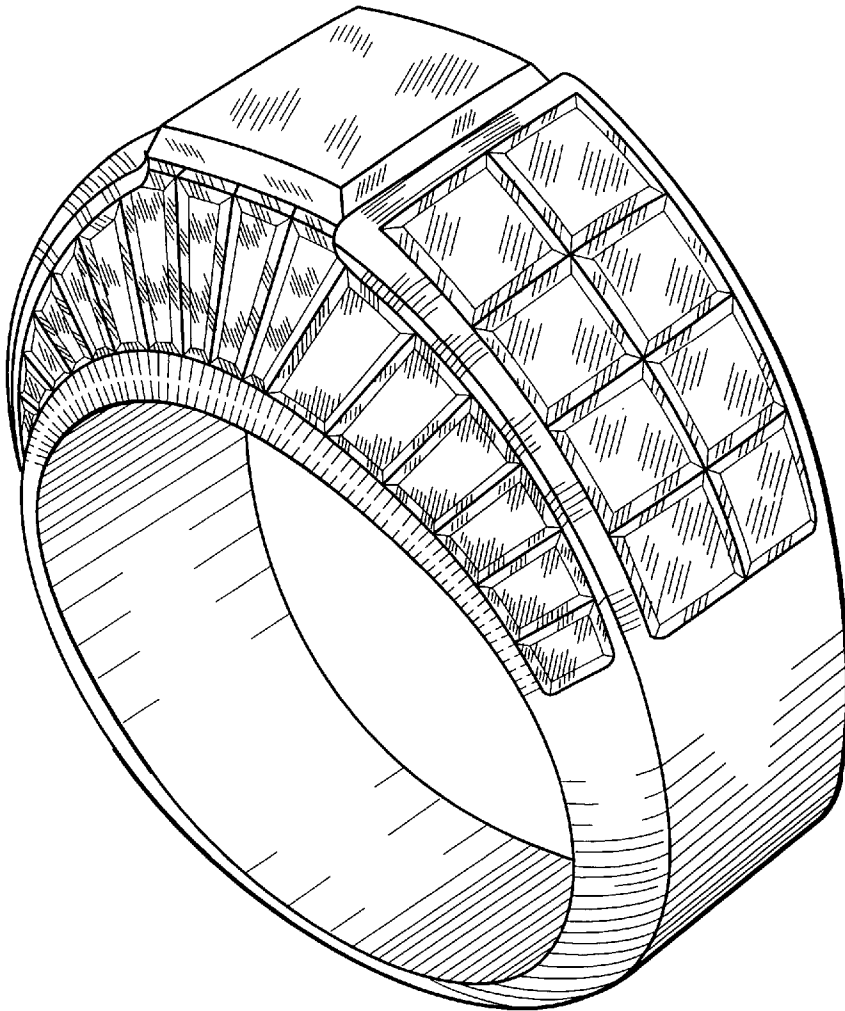

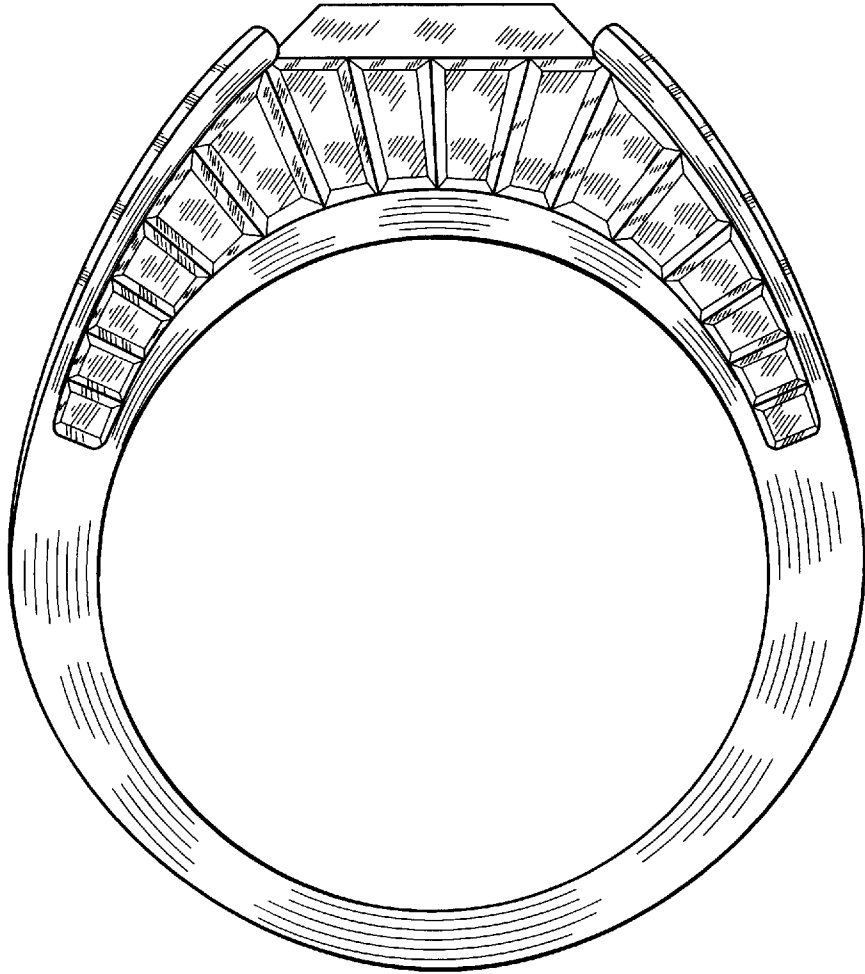

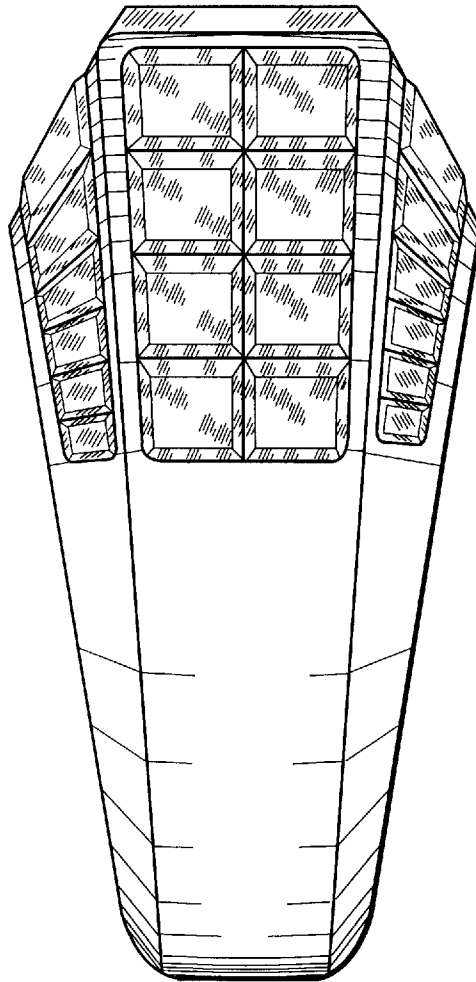

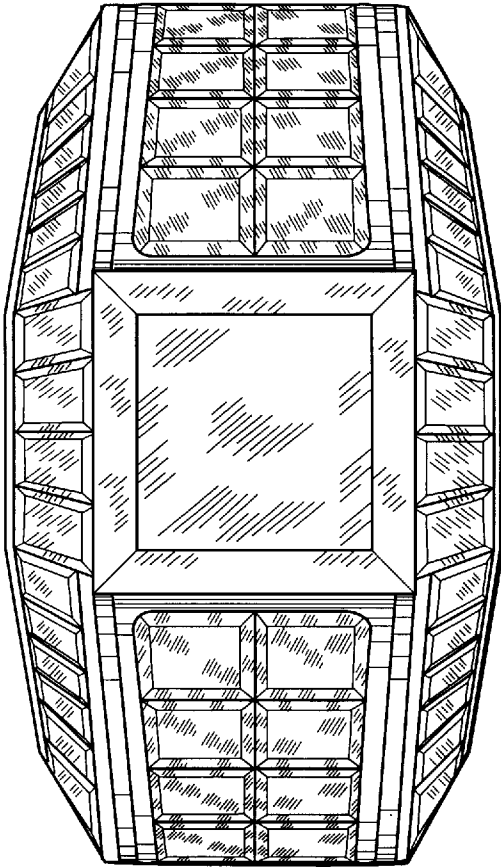

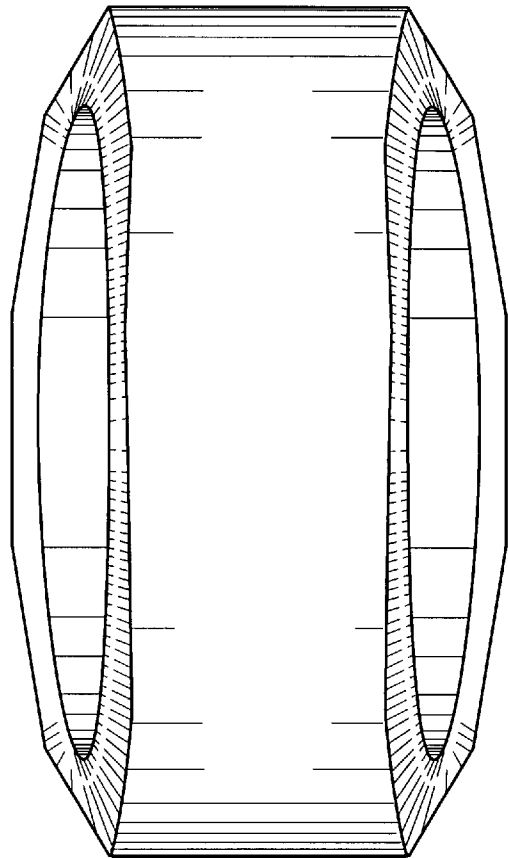
