



## SATCHEL AND MUFF.

SPECIFICATION forming part of Letters Patent No. 273,523, dated March 6, 1883.

Application filed November 25, 1882. (No model.)

*To all whom it may concern:*

Be it known that I, LUCINIUS HAVASY, of the city, county, and State of New York, have invented a new and Improved Combined Satchel and Muff, of which the following is a full, clear, and exact description.

The object of my invention is to provide a new and improved satchel which can also be used as a muff.

10 The invention consists in a satchel containing a longitudinal pocket forming openings in the ends of the satchel, into which pocket a muff can be passed in such a manner that the hands can be passed into the same, which 15 muff can be withdrawn, so that the satchel can be used like an ordinary satchel.

Reference is to be had to the accompanying drawings, forming part of this specification, in which similar letters of reference indicate corresponding parts in both the figures.

20 Figure 1 is a perspective view of my improved satchel and muff, showing the muff partly withdrawn in dotted lines. Fig. 2 is a cross-sectional elevation of the same.

25 A satchel, A, which is made of leather, plush, cloth, fur, or any suitable material, and has the outer appearance of a satchel, is provided with a longitudinal pocket, B, forming openings in the ends of the satchel, into which 30 openings the hands can be passed. The pocket can be made of muslin, leather, or flannel, and can be lined with some soft or hairy material, or with wadding, if desired, but in all cases must be made so that it can be folded together flat

35 to occupy a minimum of space in the satchel. A muff, C, made of wool, fur, plush, or other

suitable material, is adapted to be passed loosely into the openings in the pocket B in such a manner that it can be easily withdrawn when desired. The hairy surface should be 40 to the inside, and the outer surface should be smooth, so that the muff can easily be passed into or withdrawn from the pocket. The satchel is provided with a handle, E, and with a suitable lock. In summer the muff C is 45 withdrawn from the satchel, which can be used as an ordinary satchel, as the pocket for receiving the muff is folded together and occupies very little space. In winter the muff is placed into the satchel, or some suitable lining in place of the muff is secured to the inner 50 surface of the pocket.

I am aware that combined satchels and muffs have been made heretofore; but in all cases they had the appearance of muffs and not of satchels, and they could be used as combined muffs and satchels only, whereas my improved combined satchel and muff can be used as such or as a satchel only.

Having thus described my invention, what I 60 claim as new, and desire to secure by Letters Patent, is—

The combination, with a satchel, of a pocket forming a longitudinal opening in the satchel, and of a muff adapted to be passed into the 65 said pocket or removed therefrom, substantially as herein shown and described, and for the purpose set forth.
