(54) **Title:** MAGNESIUM-CONTAINING POLYMERS FOR HYPERPHOSPHATEMIA

(57) **Abstract:** A pharmaceutical composition comprising an aliphatic amine polymer or a pharmaceutically acceptable salt thereof, and a pharmaceutically acceptable magnesium compound comprising a magnesium ion is disclosed. A method of treating hyperphosphatemia in a patient is also disclosed. The method comprises the step of administering to the subject an effective amount of the disclosed pharmaceutical composition.
