

(57) Abstract: Systems and methods are described that comprise receiving software files of client devices at a platform. The software files include software update images for use in updating software of the client devices. The software files are replicated at multiple distribution platforms. An electronic message is generated to a client device when a software file corresponds to the client device, and the electronic message includes a link. The client device is redirected to a distribution platform geographically closest to the client device upon selection of the link, and the software file is downloaded from the distribution platform to the client device.
