FIG. 1 is a perspective view of the pitch training apparatus showing our new design;

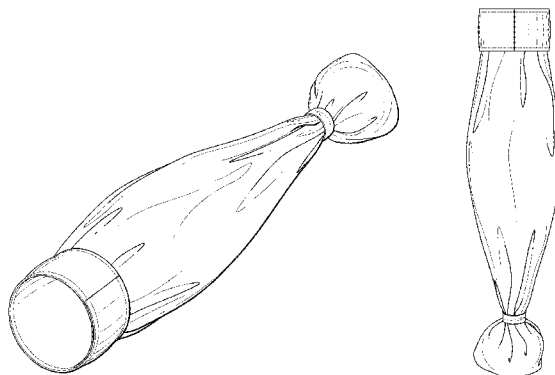


FIG. 2 is an upended left side view thereof;

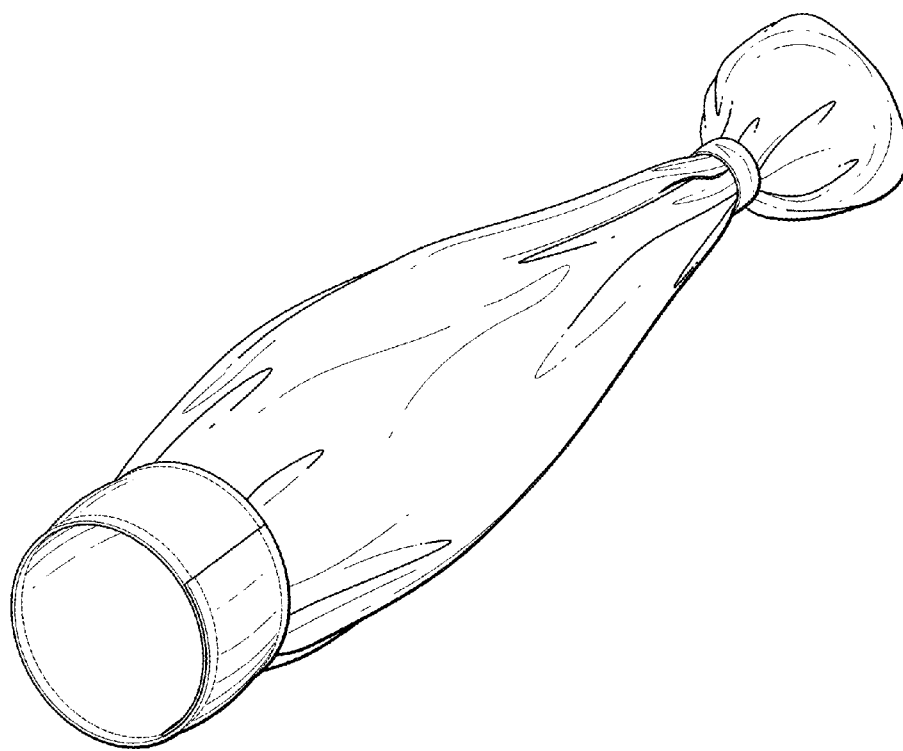

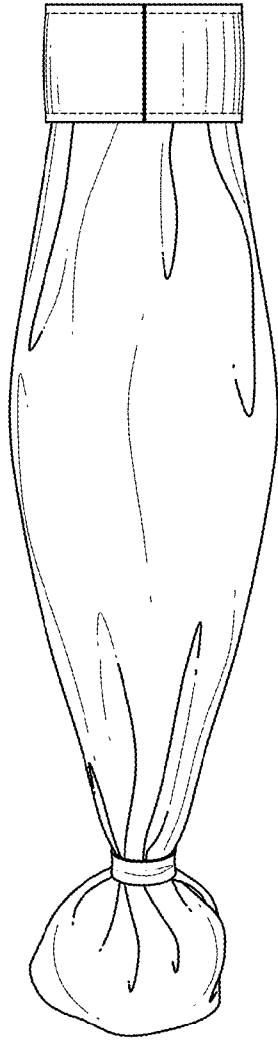

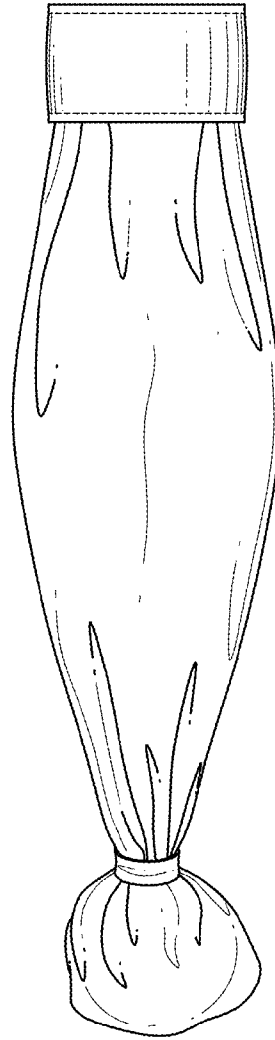

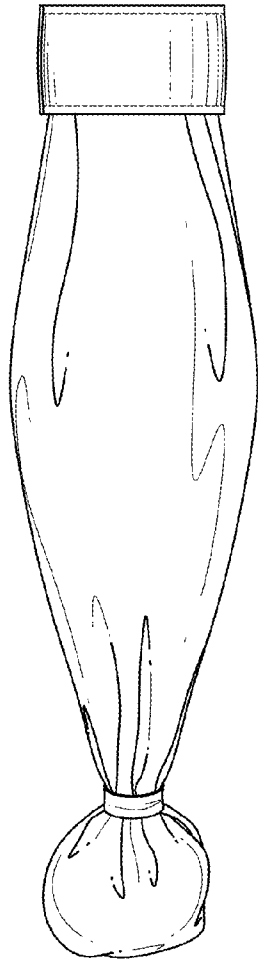

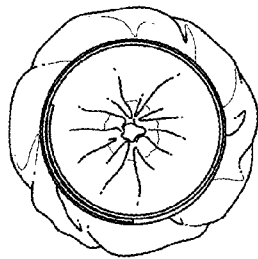

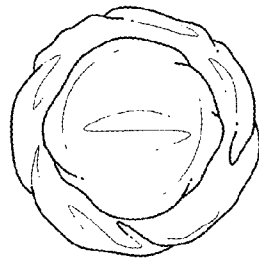
