
(57) **CLAIM**

The ornamental design for a company badge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a company badge showing our new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is another perspective view thereof, wherein the body of the badge and the attachment base is separated.
 The broken lines shown in the drawings are for purpose of illustrating portions of the company badge that form no part of the claimed design.














