The ornamental design for an infant head positioner, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the

inventive design for an infant head positioner;

FIG. 2 is a left side elevational view of the design of FIG. 1;

FIG. 3 is a right side elevational view of the design of FIG. 1;

FIG. 4 is a foot end view of the design of FIG. 1;

FIG. 5 is a head end view of the design of FIG. 1;

FIG. 6 is a top plan view of the design of FIG. 1;

FIG. 7 is a bottom plan view of the design of FIG. 1;

FIG. 8 is a perspective view of a second embodiment of the inventive design for an infant head positioner;

FIG. 9 is a left side elevational view of the design of FIG. 2;

FIG. 10 is a right side elevational view of the design of FIG. 2;

FIG. 11 is a foot end view of the design of FIG. 2;

FIG. 12 is a head end view of the design of FIG. 2;

FIG. 13 is a top plan view of the design of FIG. 2; and,

FIG. 14 is a bottom plan view of the design of FIG. 2.

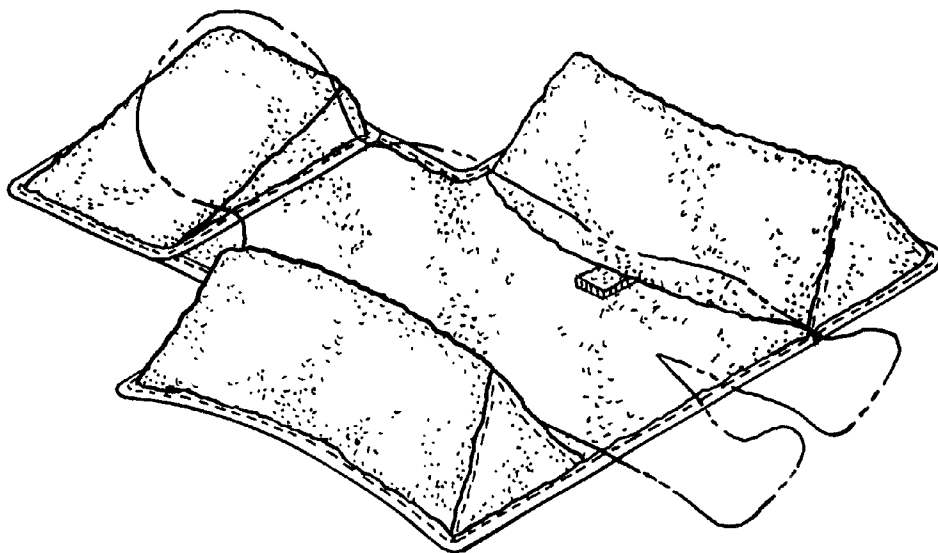

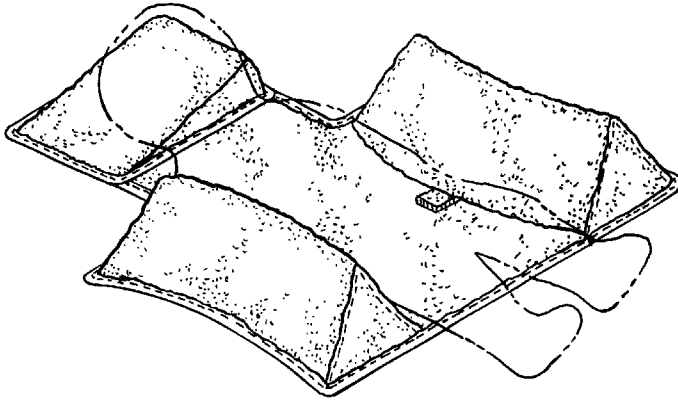

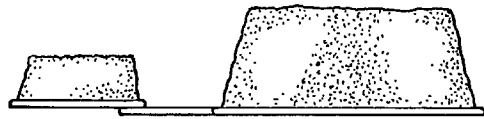

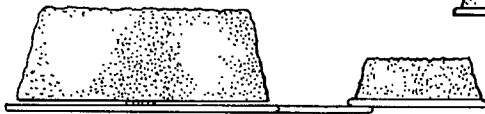

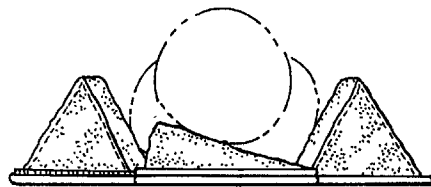

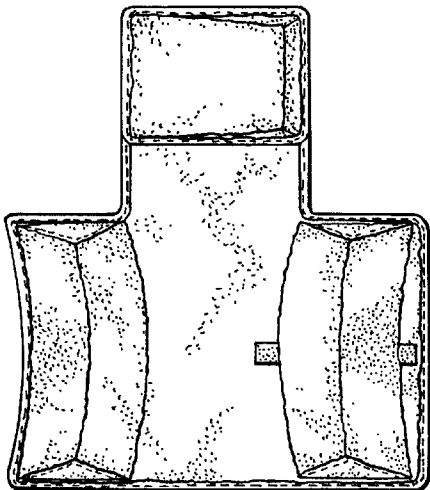

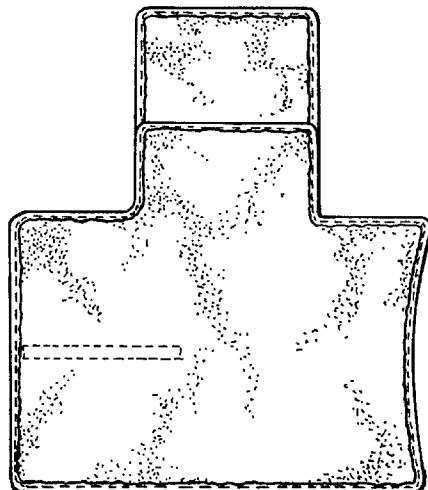

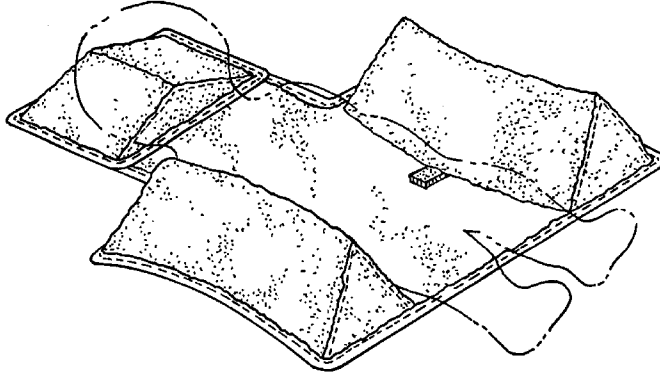

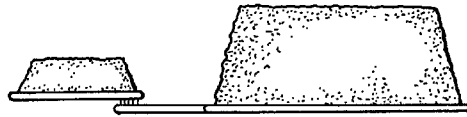

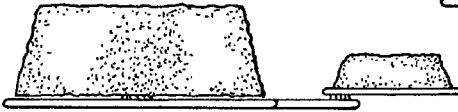

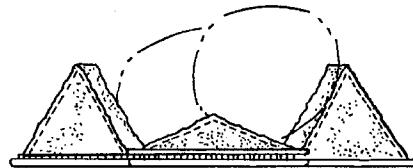

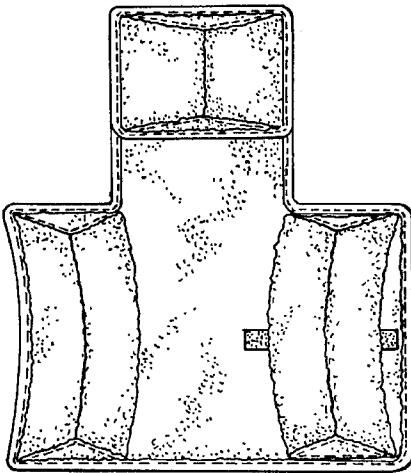
