FIG. 9 is a third view thereof;

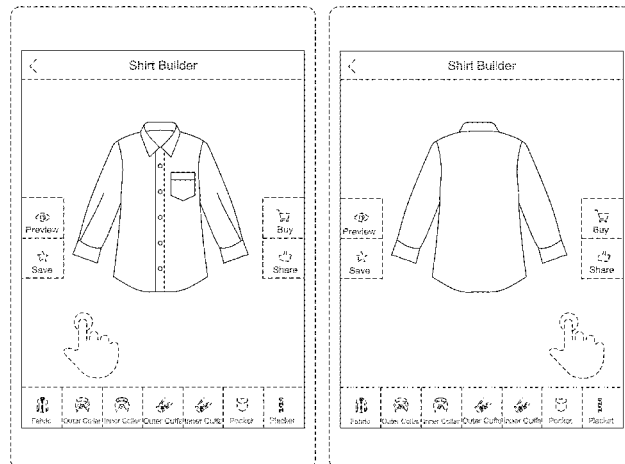
FIG. 10 is a fourth view thereof;

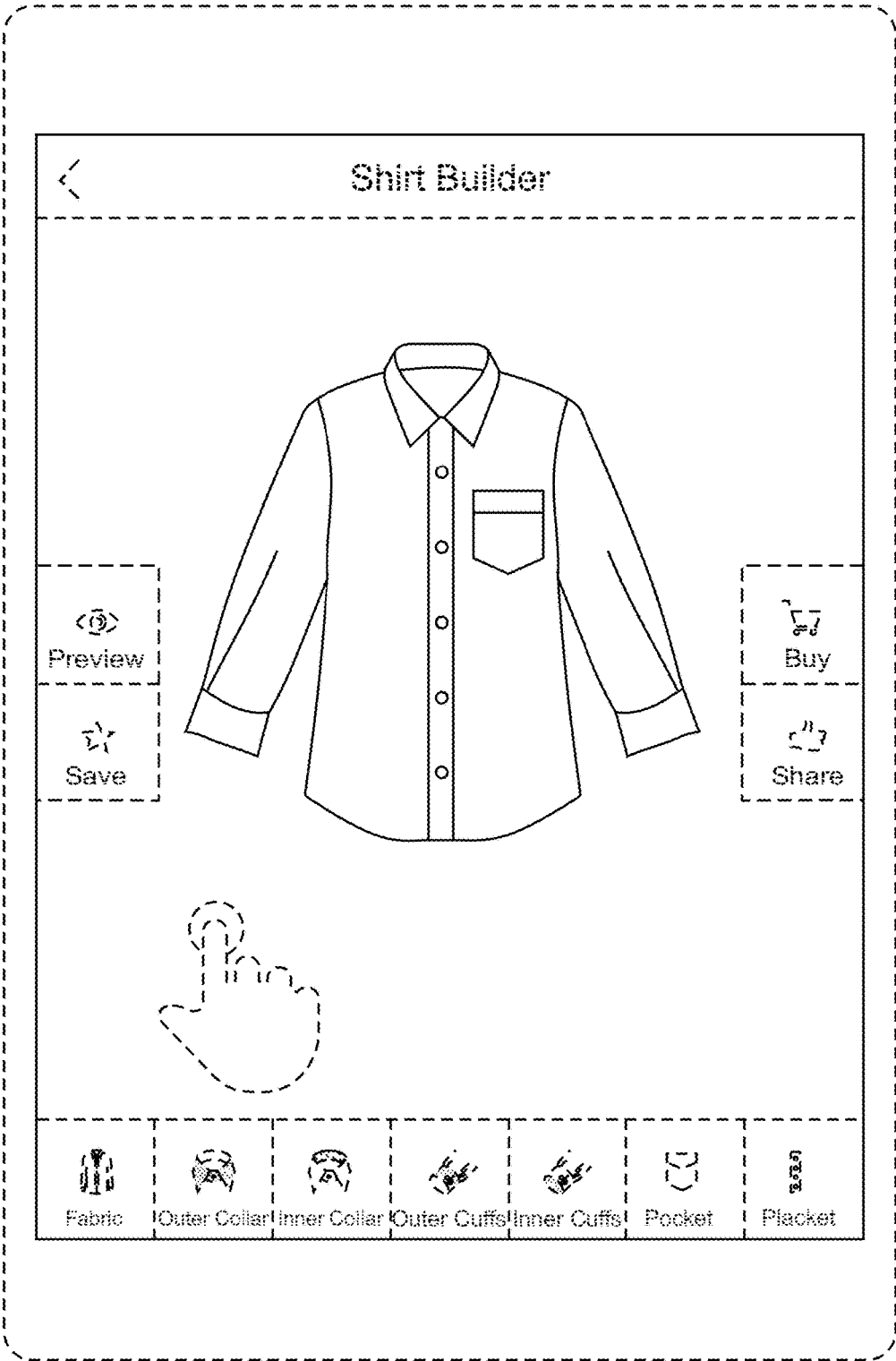

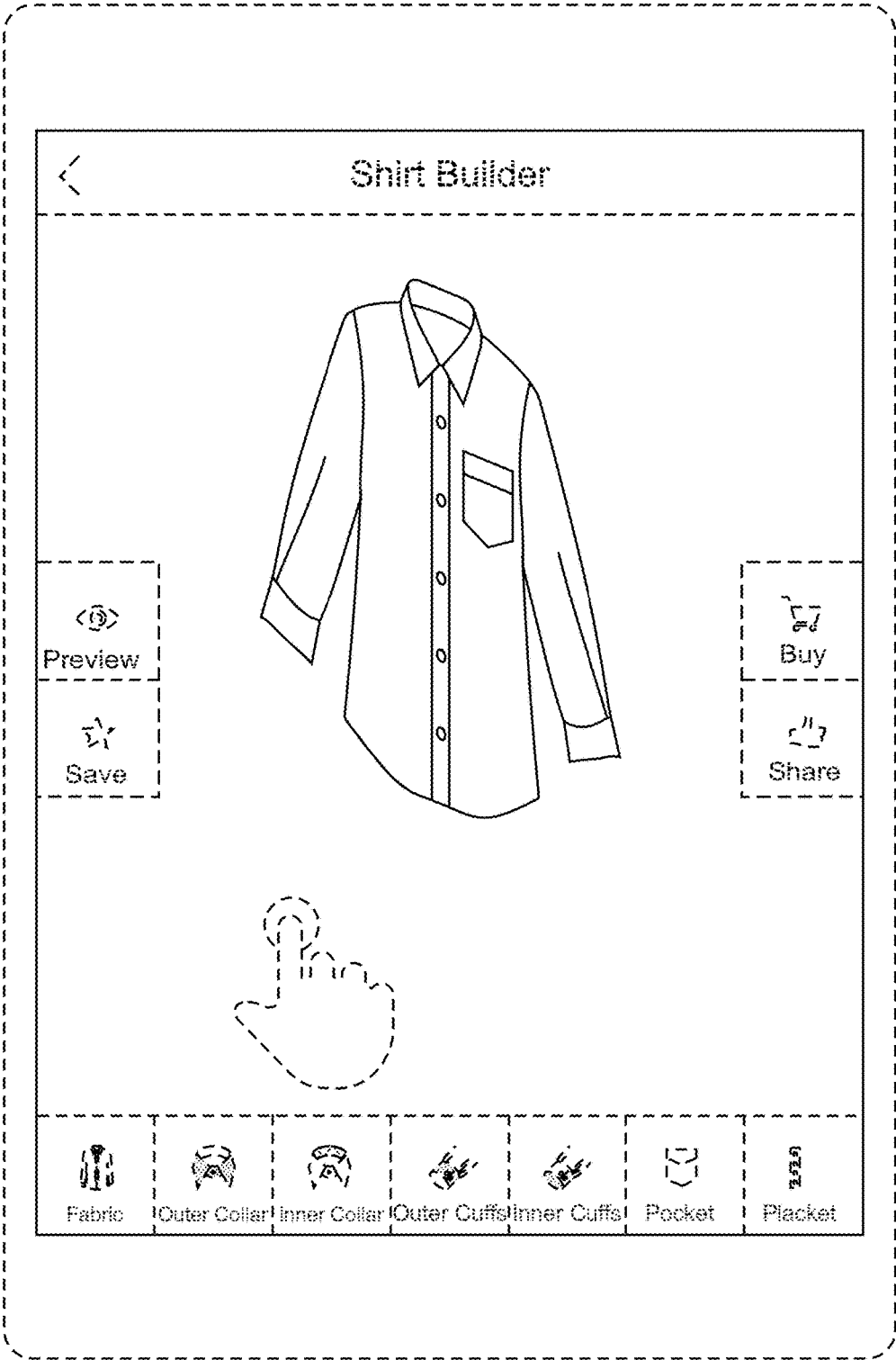

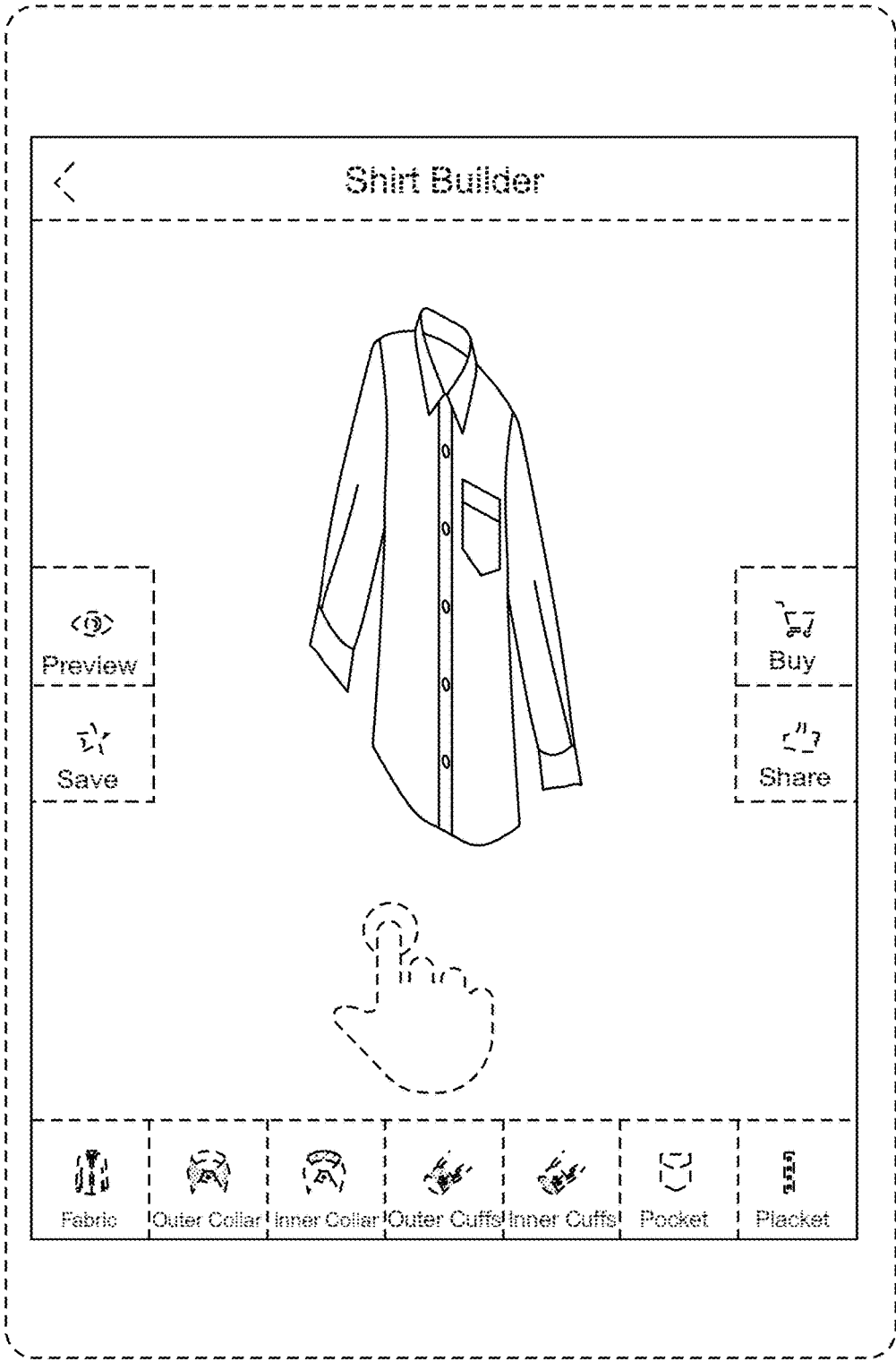

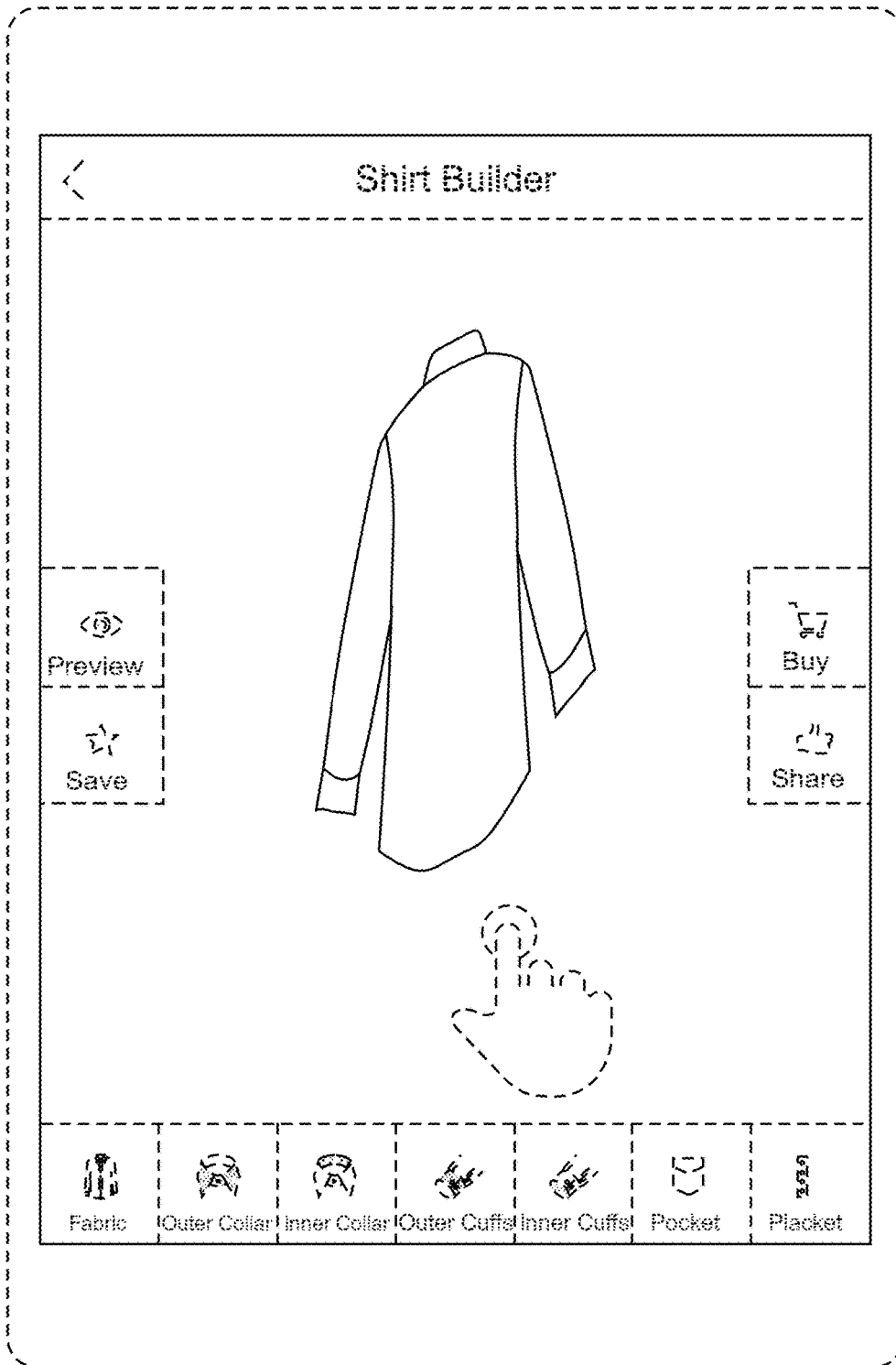

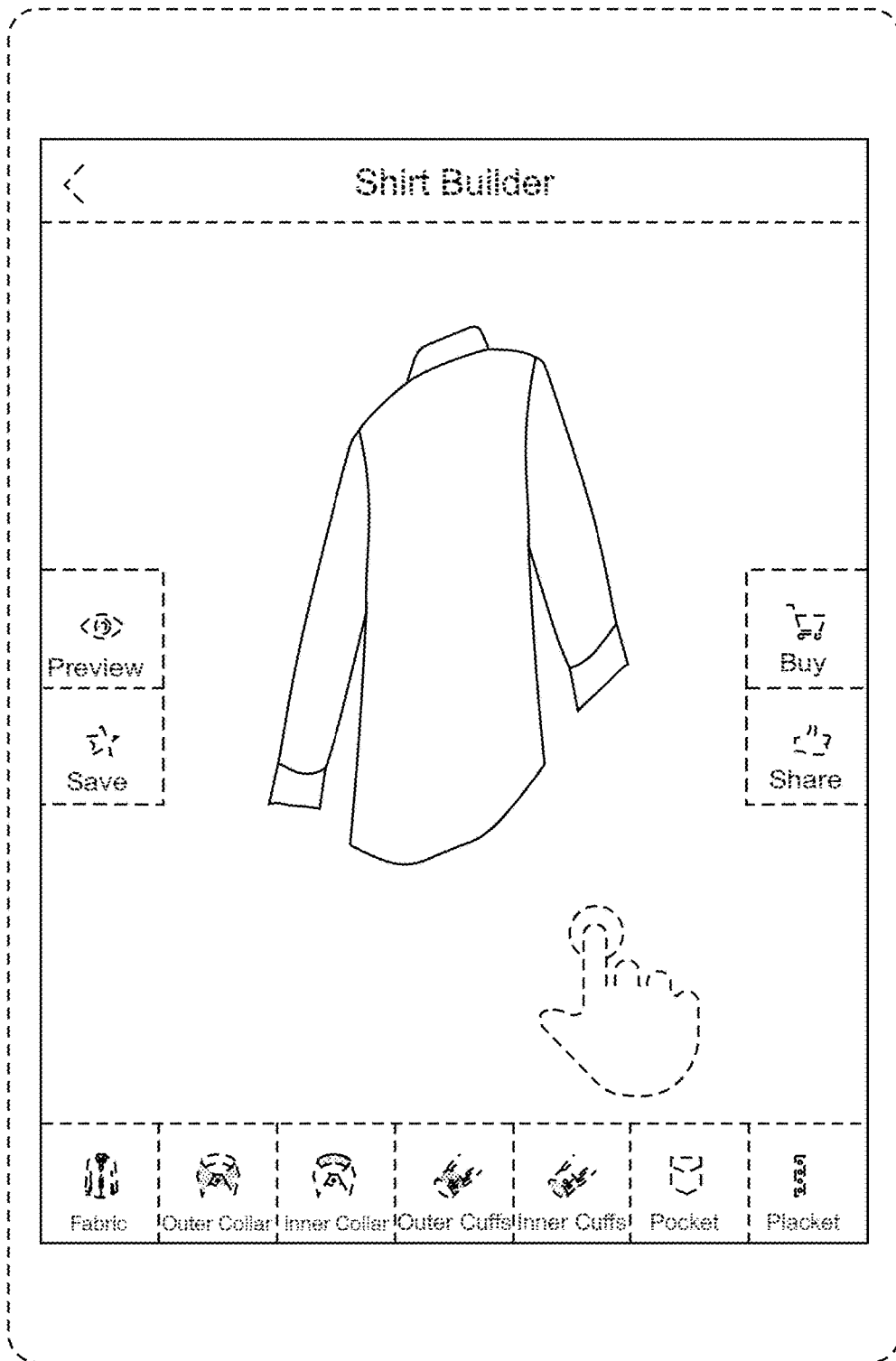

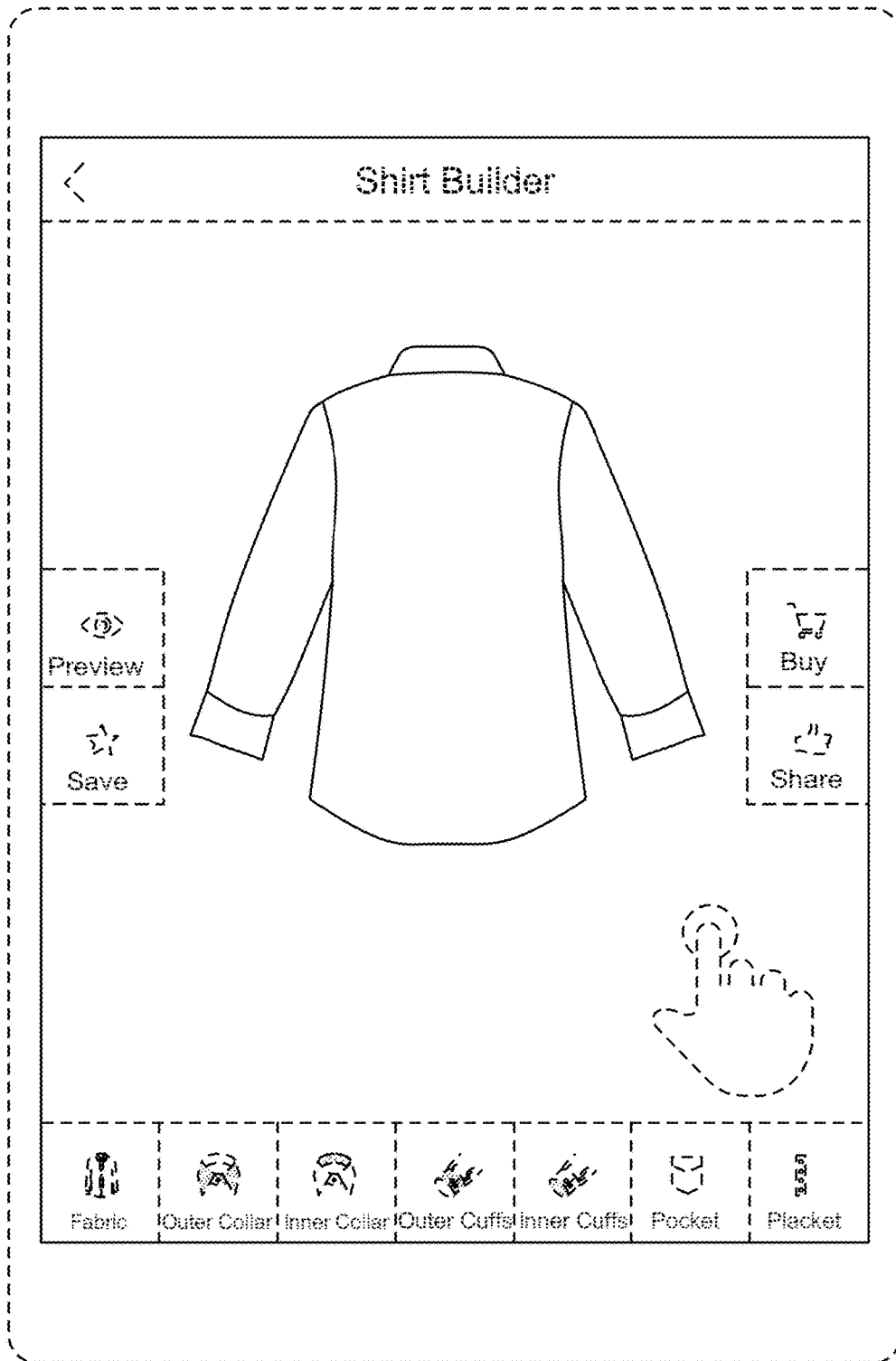

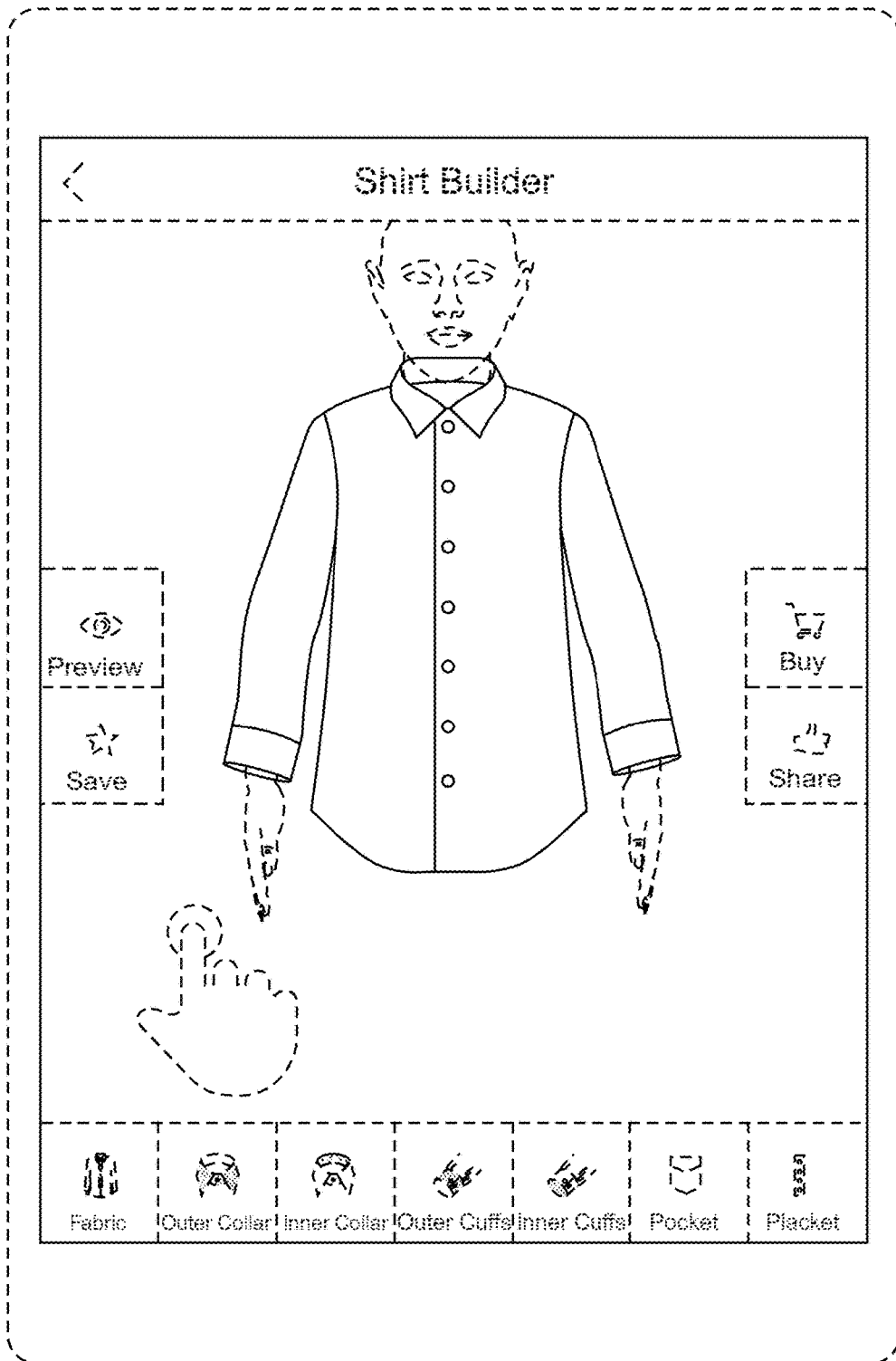

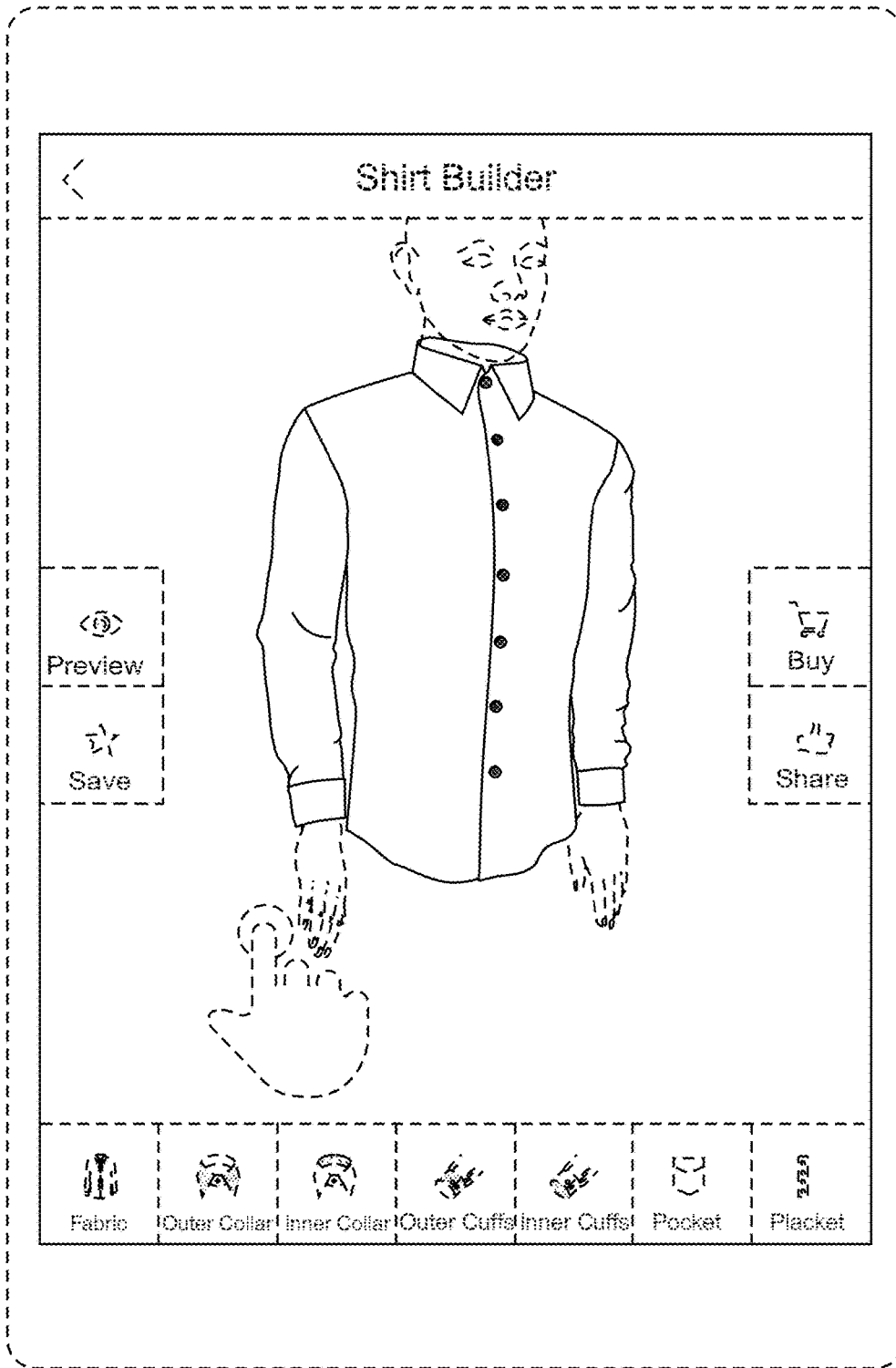

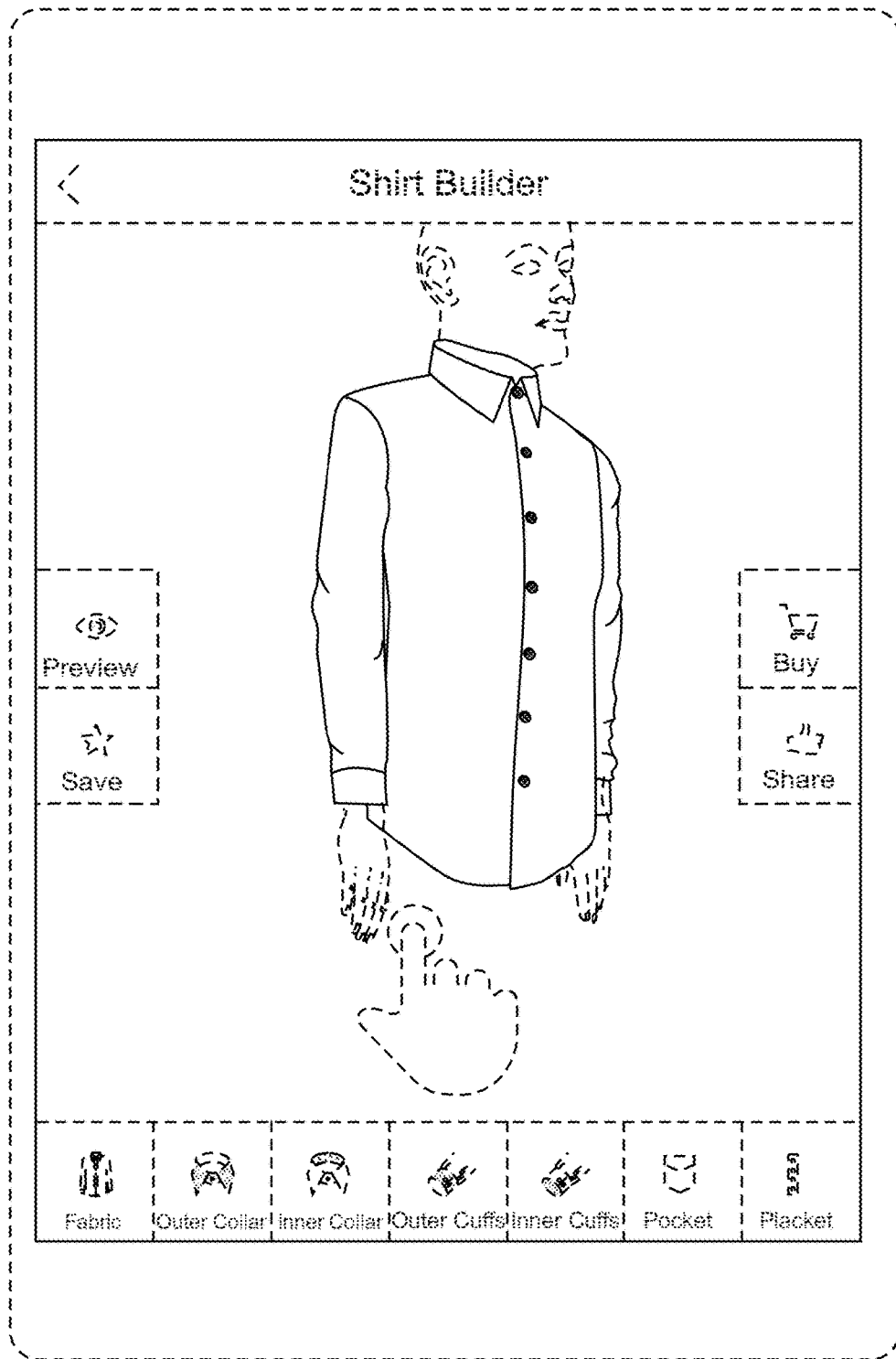

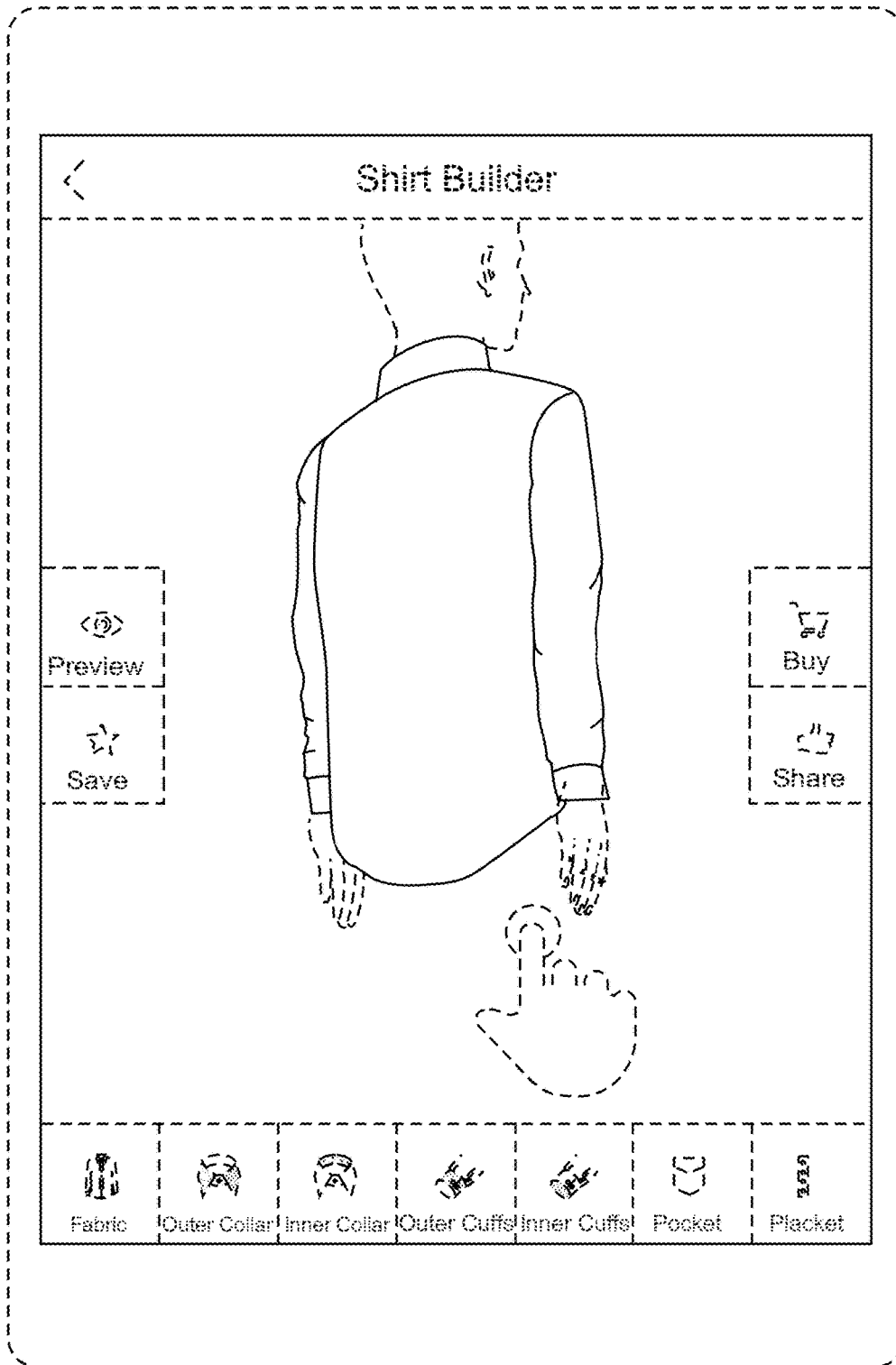

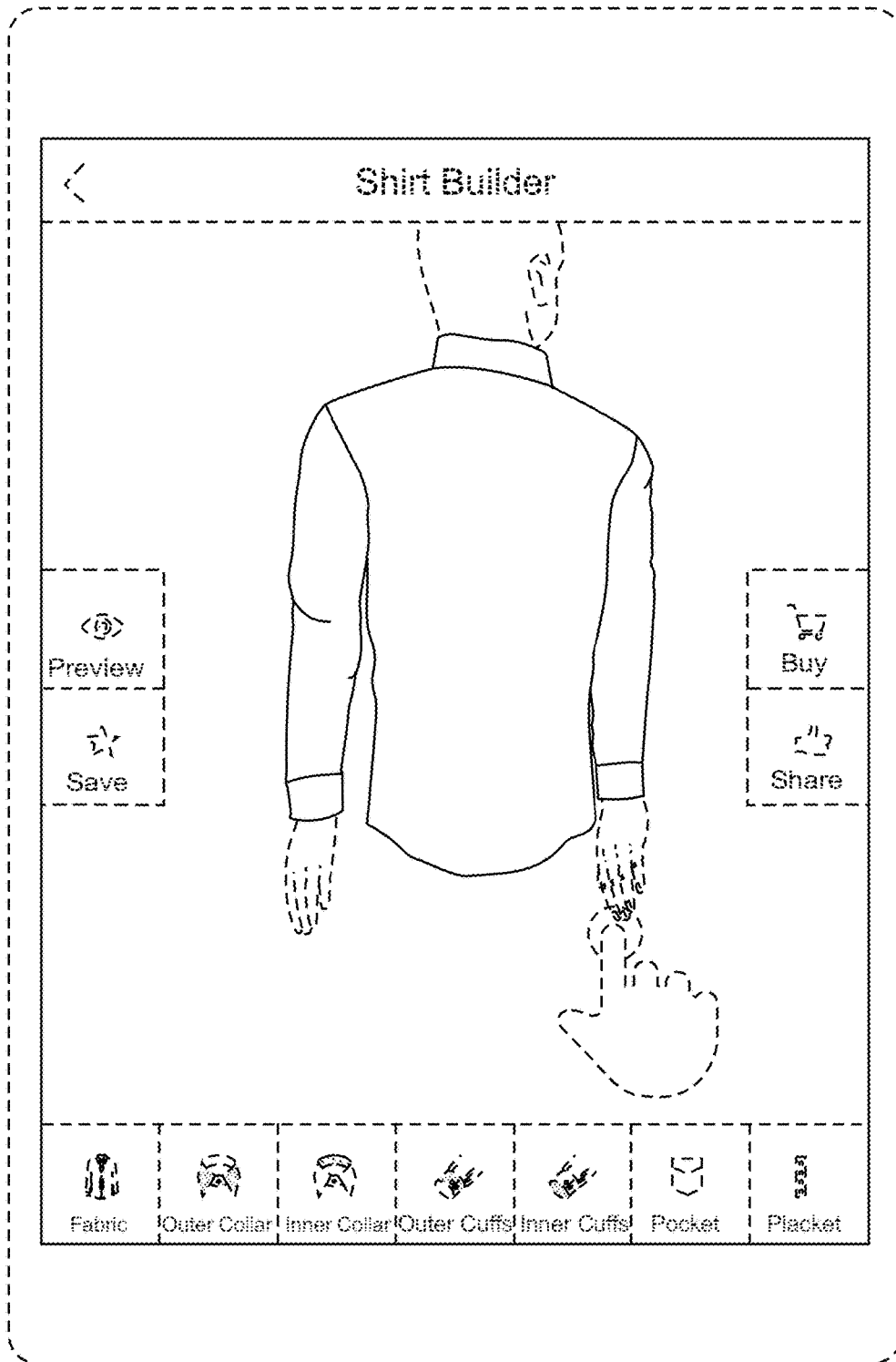

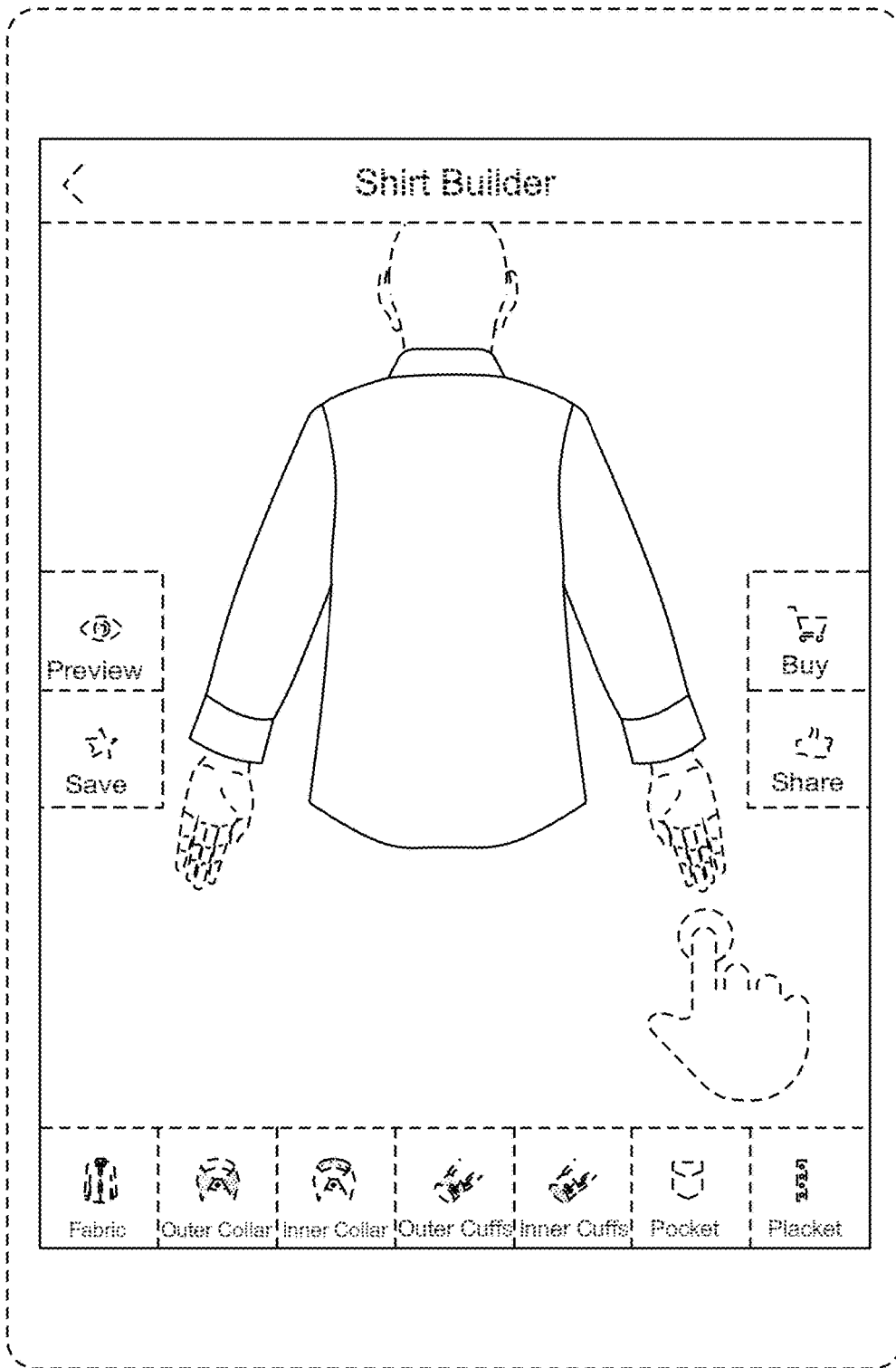
