

(57) **CLAIM**

We claim the ornamental design for a frame for displaying an object, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a frame for displaying an object;
FIG. 2 is a front view of the frame shown in FIG. 1;
FIG. 3 is a rear view of the frame shown in FIG. 1;
FIG. 4 is a right side view of the frame shown in FIG. 1;
FIG. 5 is a left side view of the frame shown in FIG. 1;
FIG. 6 is a top view of the frame shown in FIG. 1; and
FIG. 7 is a bottom view of the frame shown in FIG. 1.
The broken lines shown are included for the purpose of illustrating portions of the frame for displaying an object that form no part of the claimed design.












