The ornamental design for a game piece, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a game piece showing our new design;

FIG. 2 is a front elevational view thereof, the rear elevational view is unclaimed;

FIG. 3 is a right-side elevational view thereof;


FIG. 4 the left-side elevational view thereof;








