CLAIM

The ornamental design for a pet coat with collar and chest pad, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet coat with collar and chest pad, showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a right-side elevation view thereof;

FIG. 5 is a left-side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a top plan view thereof, shown in a flat configuration; and,

FIG. 9 is a bottom plan view thereof.

The drawings are shaded to indicate different materials. The stippling on the collar and the inside surface of the jacket represents a material (e.g., fleece or fur) differing from the outside surface material of the jacket.

The broken lines depict stitching forms no part of the claimed design.




















