(57) **CLAIM**

The ornamental design for a combined nail clipper, removable container for nail clippings, and removable nail file, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combined nail clipper, removable container for nail clippings, and removable nail file of this invention complete with the removable container for nail clippings and the removable nail file.

FIG. 2 is an exploded perspective view of the combined nail clipper, removable container for nail clippings, and removable nail file of FIG. 1 showing the removable container on the left side portion of FIG. 2, the nail cutting portion on the right side portion of FIG. 2 and the removable nail file on the bottom right side portion of FIG. 2.

FIG. 3 is a bottom view of the removable container shown in FIG. 2 with the nail file located in the bottom portion of the removable container.

FIG. 4 is a side view of the removable container portion shown in FIG. 2 with the nail file located in the bottom portion of the removable container.


FIG. 5 is a bottom view of the removable container portion shown in FIG. 2 with the nail file located in the bottom portion of the removable container.

FIG. 6 is a front elevational view of the removable container shown in FIG. 2 taken from the open end thereof and showing the nail file at the bottom thereof; and,

FIG. 7 is a rear view of the removable container shown in FIG. 2 taken from the closed end thereof and showing the nail file at the bottom thereof.

The removable container is disclosed with and without the nail file and nail clipper for convenience of illustration.








