(57) **CLAIM**

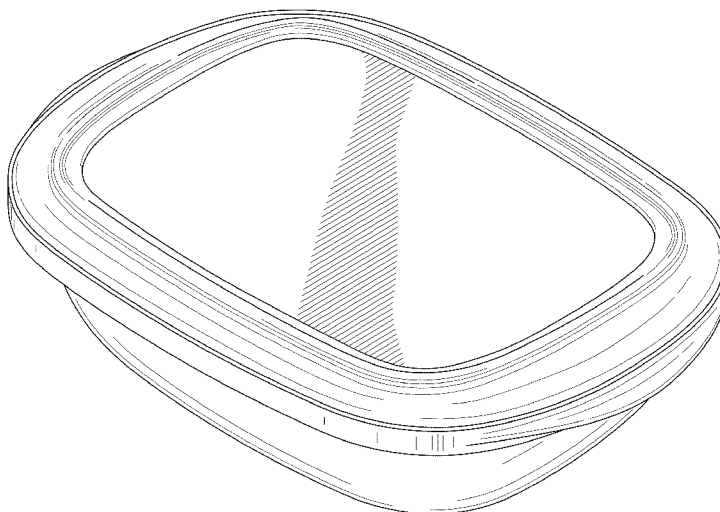
We claim the ornamental design for a container for food product, as shown and described.

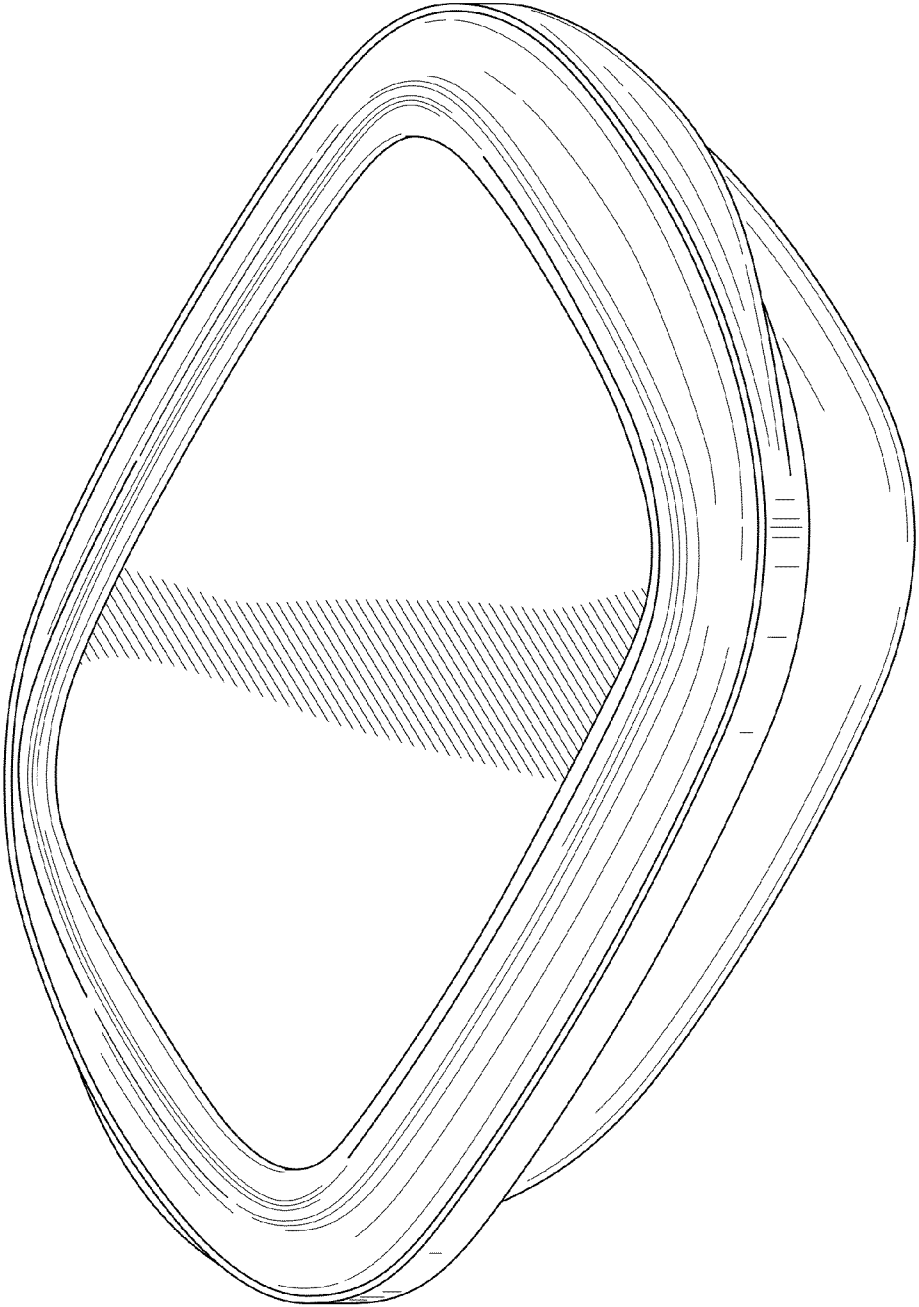

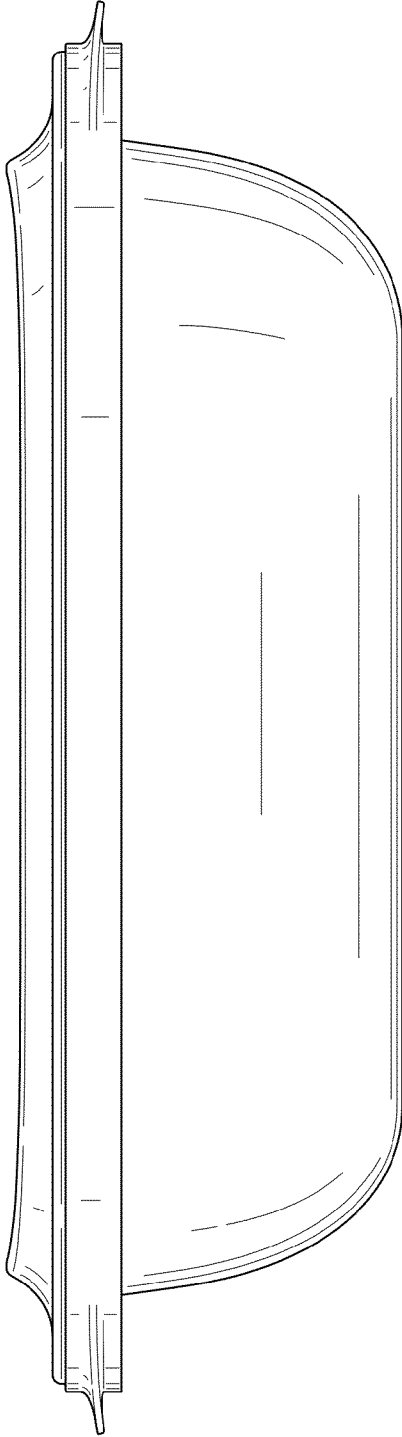

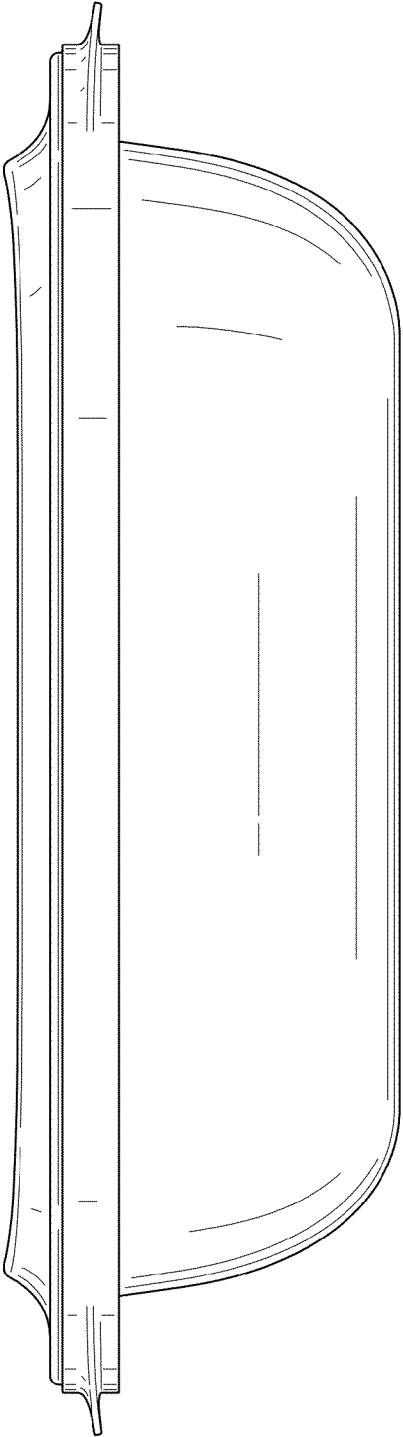

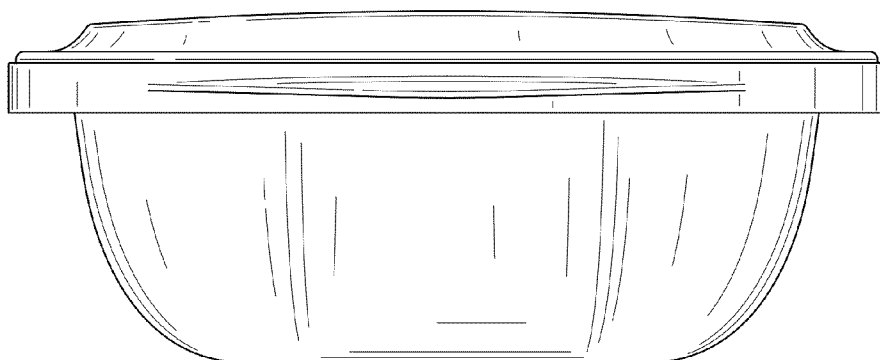

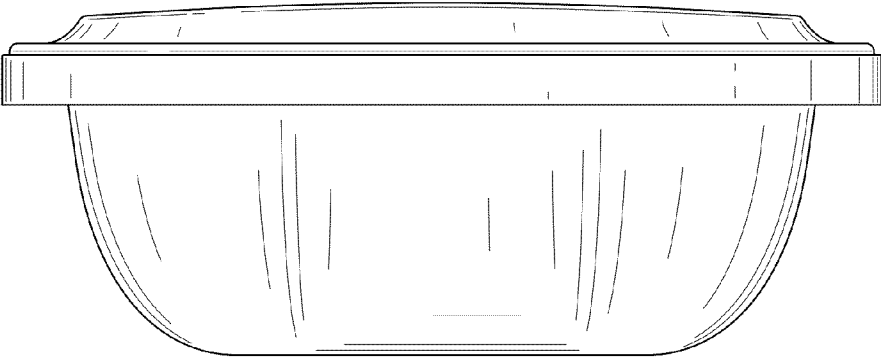

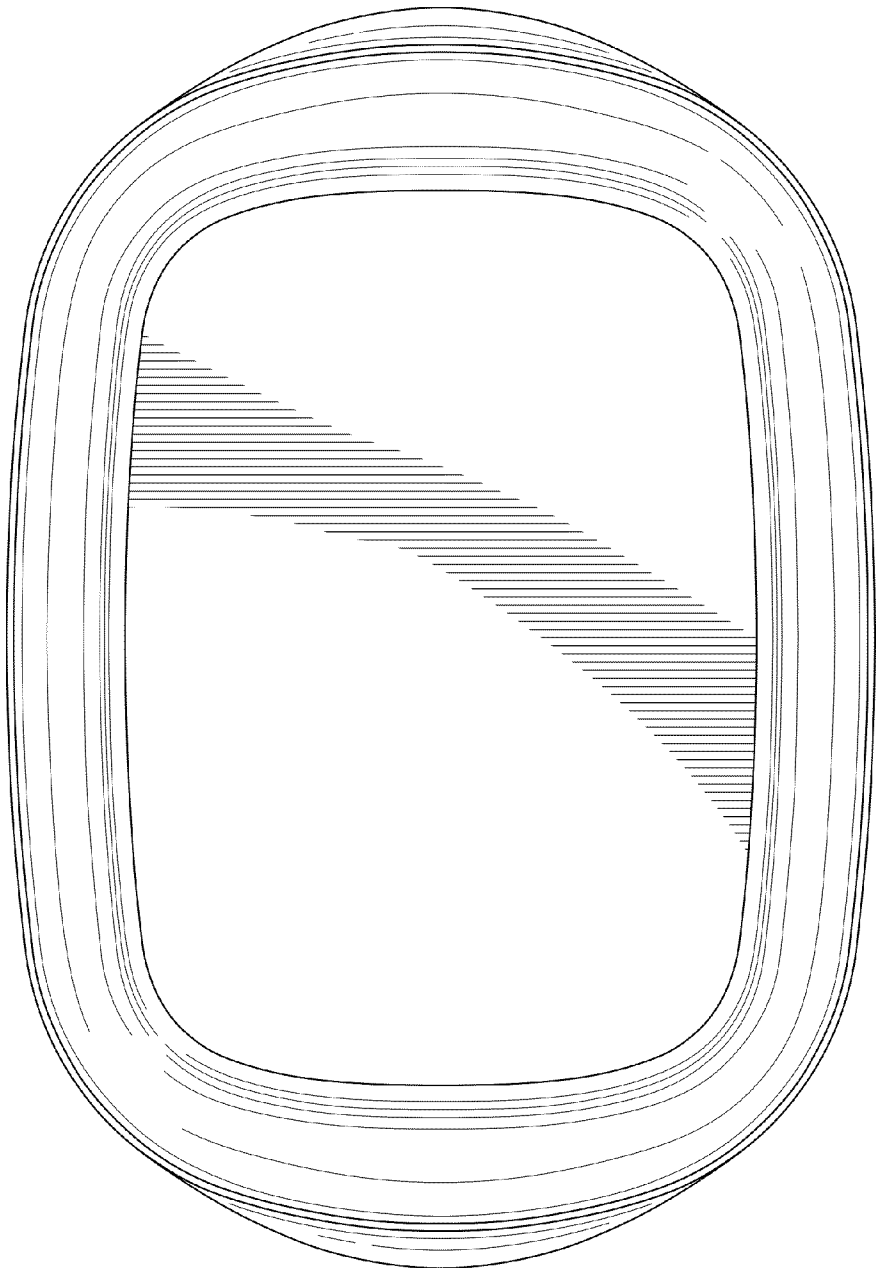

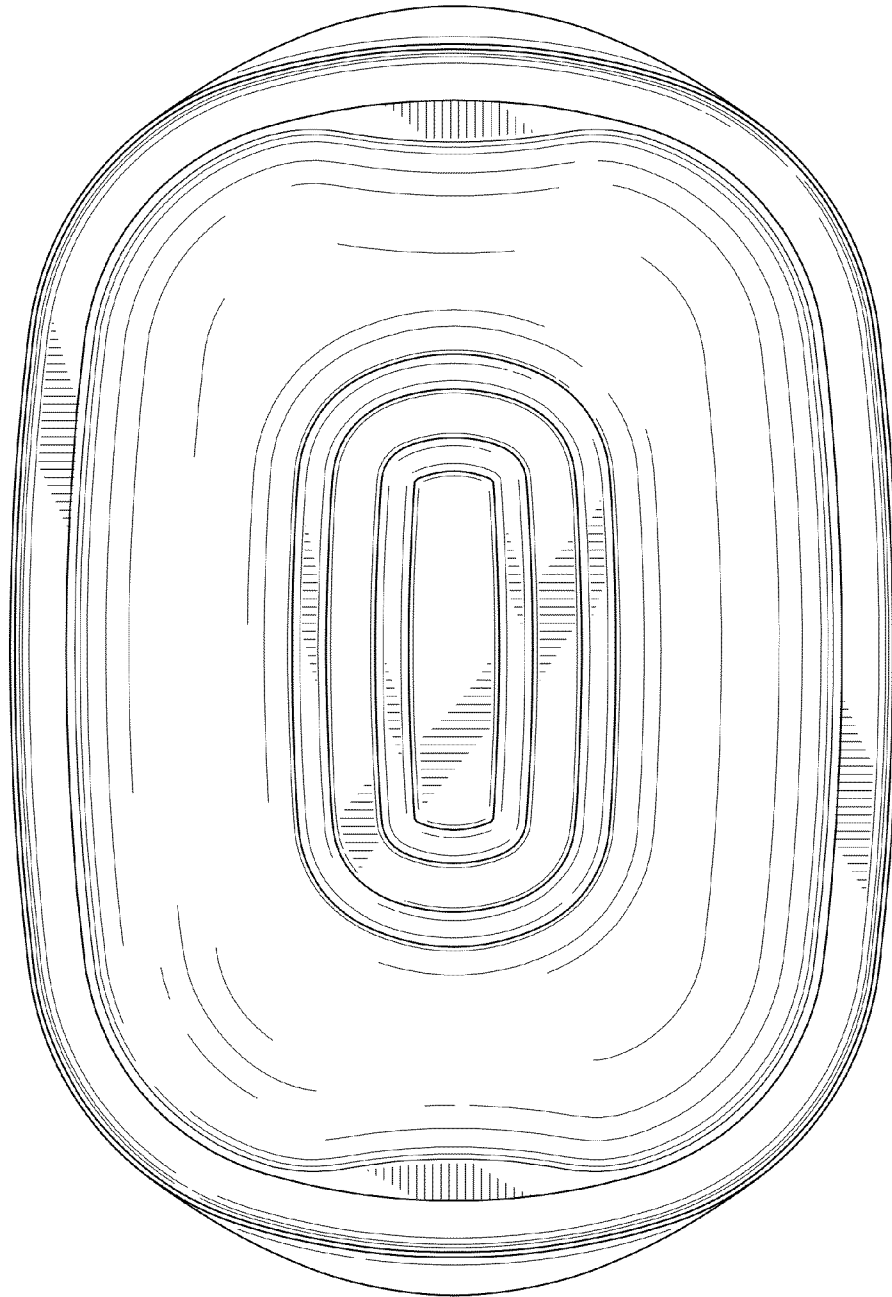
