
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a slide showing my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a left side elevational view thereof;
 FIG. 7 is a top perspective view thereof;
 FIG. 8 is a front elevational view of a second embodiment of the slide of FIG. 1;
 FIG. 9 is a rear elevational view of FIG. 8;
 FIG. 10 is a top plan view of FIG. 8;

 FIG. 12 is a right side elevational view of FIG. 8;


























