[57] CLAIM

The ornamental design for a computer terminal, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a computer terminal showing my new design in the open condition;

FIG. 2 is a reduced top plan view thereof;

FIG. 3 is a reduced front elevational view thereof;

FIG. 4 is a reduced rear elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a right side elevational view thereof in the open condition; and,

FIG. 7 is an enlarged top, right side perspective view thereof.

The undisclosed side has the same appearance as the disclosed side in FIGS. 1 and 5 to 7 except that it lacks the screw head.

The raised keys shown at the front in broken lines are for illustrative purposes only and form no part of the claimed design. The flat keys shown at the rear in solid lines do form part of the claimed invention.













