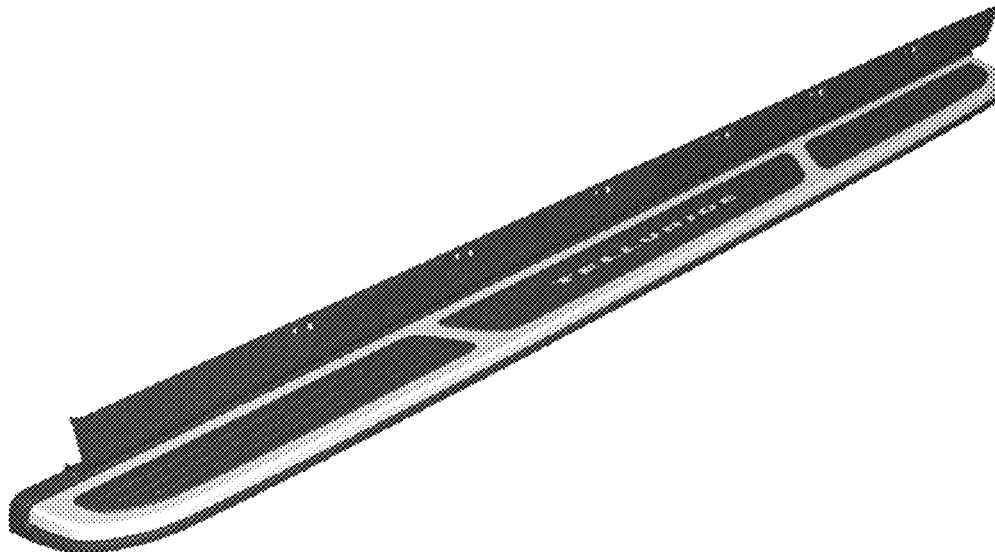
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a door step plate for a vehicle embodying my new design;

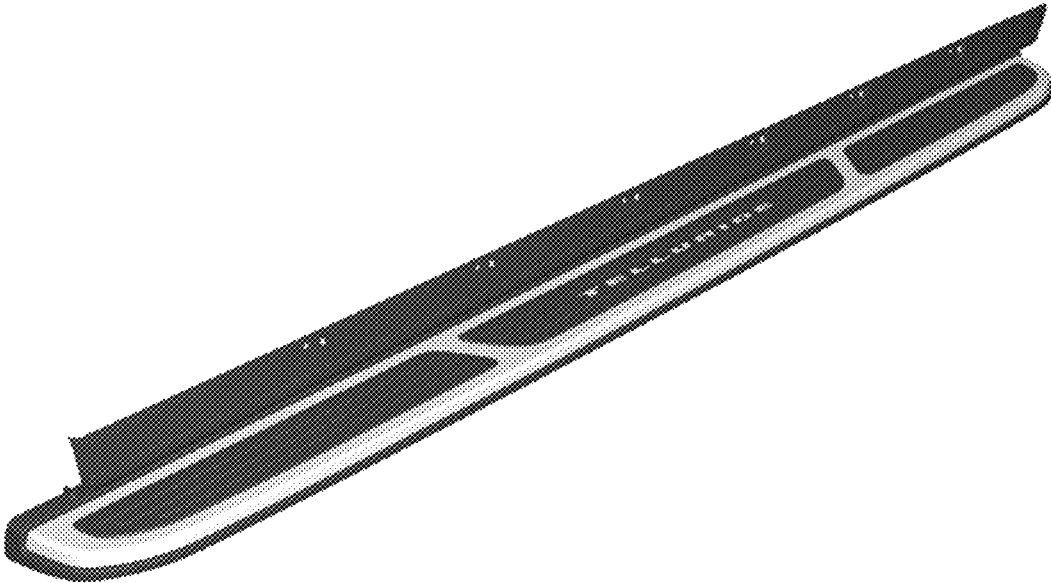
