(57) **CLAIM**

The ornamental design for a multi-tier utility cart, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multi-tier utility cart in accordance with an embodiment of the present invention, FIG. 2 is a rear elevational view of the multi-tier utility cart as shown in FIG. 1.

FIG. 3 is a front side elevational view of the multi-tier utility cart as shown in FIG. 1.

FIG. 4 is a right side elevational view of the multi-tier utility cart as shown in FIG. 1.

FIG. 5 is a left side elevational view of the multi-tier utility cart as shown in FIG. 1.


FIG. 6 is a top plan view of the multi-tier utility cart as shown in FIG. 1.


















