

(54) Paper container

(57) In a paper container (10) having a hexahedral configuration which is formed by shaping paper into a box, the paper container (10) comprises a container main body (12) and a lid member (14) hingedly attached to a back side edge part of an upper end open surface (13) of the container main body (12) and adapted to open/close the upper end open surface (13), a front board (15) of the container main body (12) being formed with a concave cutout part (16) extending from the upper end open surface (13). The lid member (14) comprises an upper surface lid part (17) for covering the upper end open surface (13), a front surface lid part (18) large enough to cover the concave cutout part (16), and a pair of side lid parts (19) interposed between side edge parts of the upper surface lid part (17) and side edge parts of the front surface lid part (18) and adapted to vertically join the front surface lid part (18) with the upper surface lid part (17). A tongue-like lock part (26) is disposed beneath the concave cutout part (16) and adapted to lock a lower end part of the front surface lid part (18) of the lid member (14).
