

(54) Title: COMMUNICATIONS RESTRICTIONS FOR MOBILE COMMUNICATION DEVICES



(57) Abstract: Systems and methods for managing communication groups are provided. In some embodiments, the invention includes systems and methods for managing a mobile communication device group. The system can include a communication device for sending a message from a member of a sender group (301, 304) and network (305) to transmit the message to the recipient group (302, 303) if the identity of the sender group (301, 304) exists in a communication permission parameter associated with the recipient group (302, 303). In other embodiments, the invention includes systems and methods for transmitting a message to a group of communication device users in an identified geographical area and including a graphical display for presenting a geographical representation of an area. The invention can also include a selection tool for identifying one or more communication device users located within a defined area. In such embodiments, a network (305) can be used to transmit a message from a sender (301, 304) to the users located within the defined area.
