(57) **CLAIM**

The ornamental design for an outsole for a golf shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an outsole for a golf shoe showing our new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;



FIG. 5 is a top plan view thereof;














