The ornamental design for a combined disc player, amplifier, tuner and audio player, as shown and described.

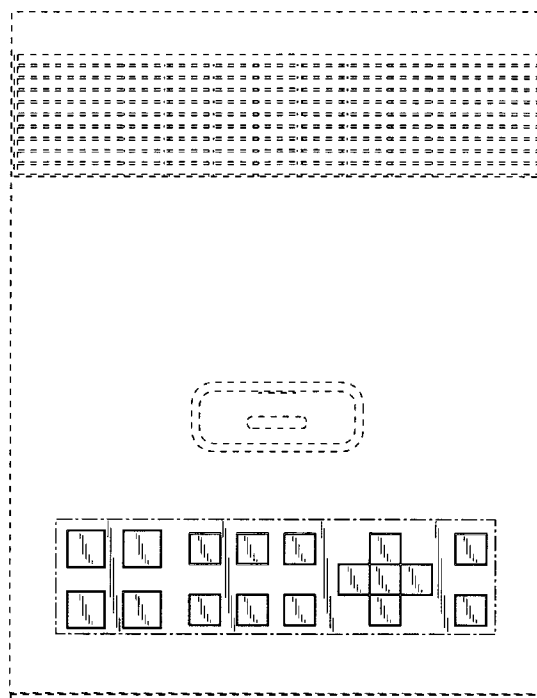
DESCRIPTION

FIG. 1 is a top plan view of a combined disc player, amplifier, tuner and audio player showing our new design; and,

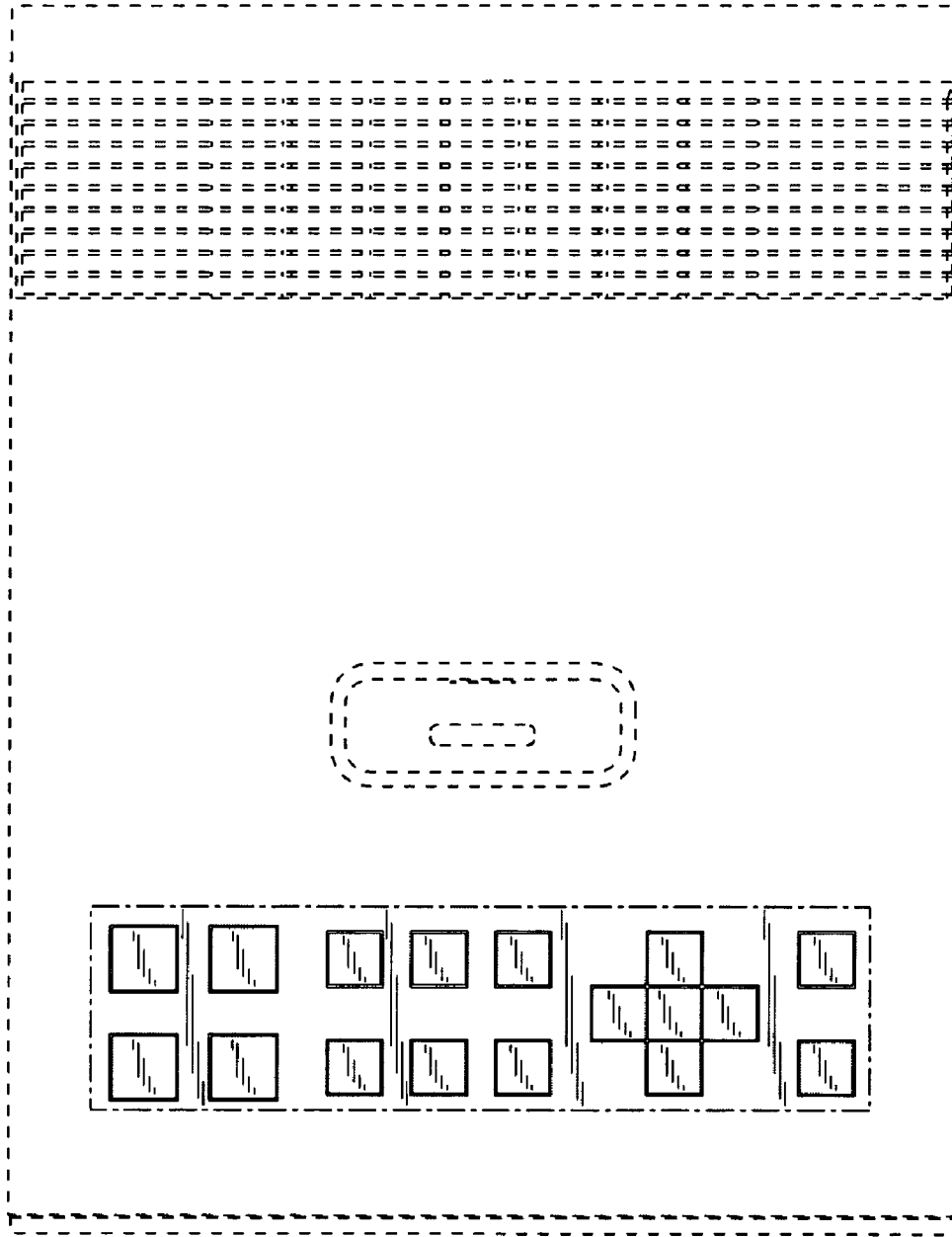

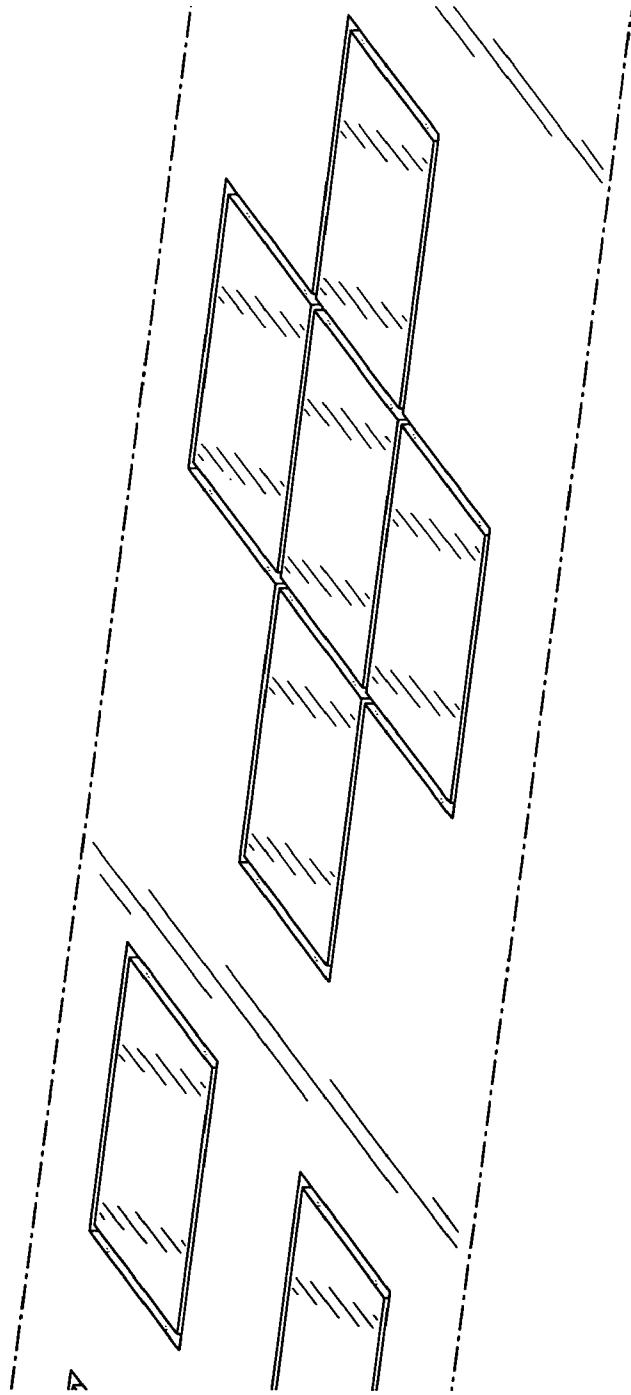
