(57) **CLAIM**

The ornamental design for a camera lens, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a camera lens showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is an enlarged cross-sectional view of a front portion of the article taken along line 7-7 in FIG. 2;

FIG. 8 is a front, top and right side perspective view of FIG. 1, shown without the color designation only for clarity of illustration;

FIG. 9 is a front elevational view of FIG. 2, shown without the color designation only for clarity of illustration;

FIG. 10 is a top plan view of FIG. 3, shown without the color designation only for clarity of illustration; and,

FIG. 11 is enlarged cross sectional view of FIG. 7 taken along line 11 in FIG. 9, shown without the color designation only for clarity of illustration.

The features shown in broken lines in the drawings depict environmental subject matter only and form no part of the claimed design. The dot-dashed lines immediately adjacent to the shaded area define the boundaries of the claimed design and form no part thereof. The portions shown in black in the FIGS. 1 through 7 indicate the color black.

The portions in FIGS. 8-11 corresponding to portions in black (FIGS. 1-7) are shown without the color which are not apparent in FIGS. 1-7.





















