
(57) **CLAIM**

The ornamental design for a pet treat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pet treat showing our new design according to a first embodiment;  
FIG. 2 is a top view of the design shown in FIG. 1;  
FIG. 3 is a bottom view of the design shown in FIG. 1;  
FIG. 4 is a left side view of the design shown in FIG. 1;  
FIG. 5 is a right side view of the design shown in FIG. 1;  
FIG. 6 is a front view of the design shown in FIG. 1;  
FIG. 7 is a rear view of the design shown in FIG. 1; and,  
FIG. 8 is a perspective view of a pet treat showing our new design according to a second embodiment, it being identical to the first embodiment except that it is shown broken apart to indicate that no specific length is claimed.  
The broken lines which define the bounds of the claimed design in FIGS. 1-8 form no part thereof.














