(57) **CLAIM**

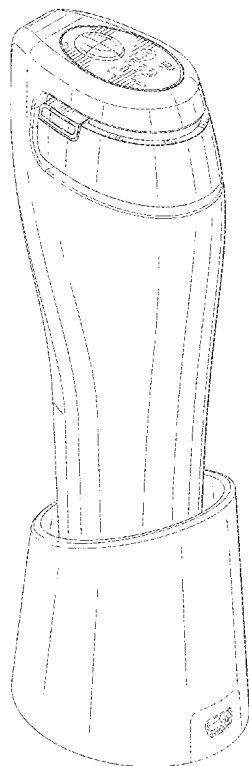
The ornamental design for a dermatological treatment system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dermatological treatment system and base combination showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines in the drawing views are included for the purpose of illustrating portions of the dermatological treatment device and base combination that form no part of the claimed design.

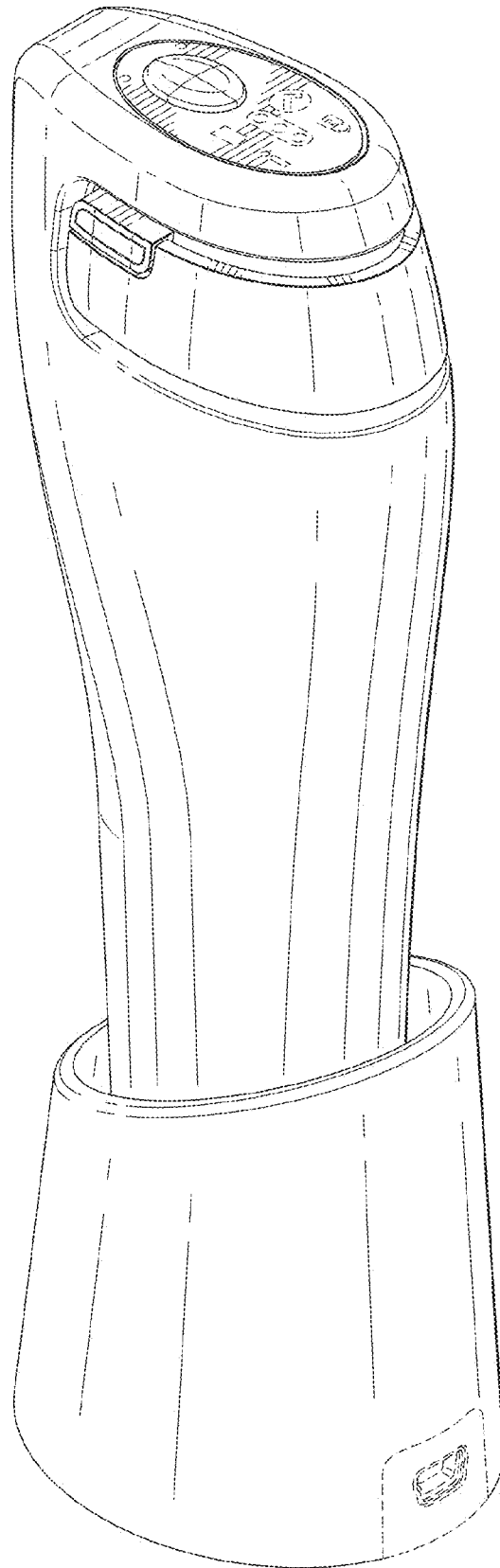

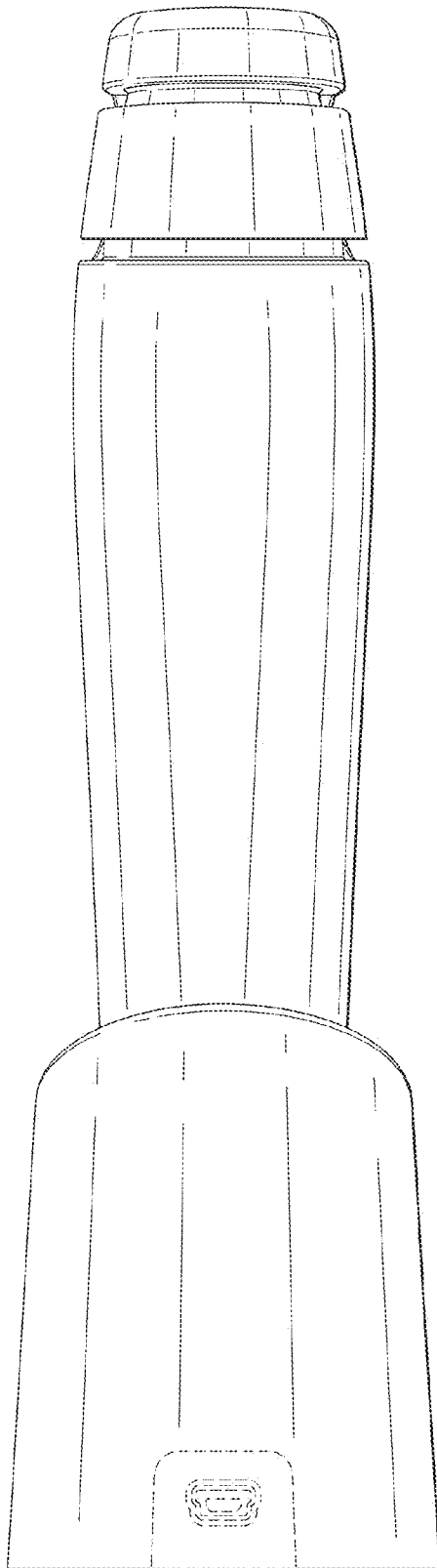

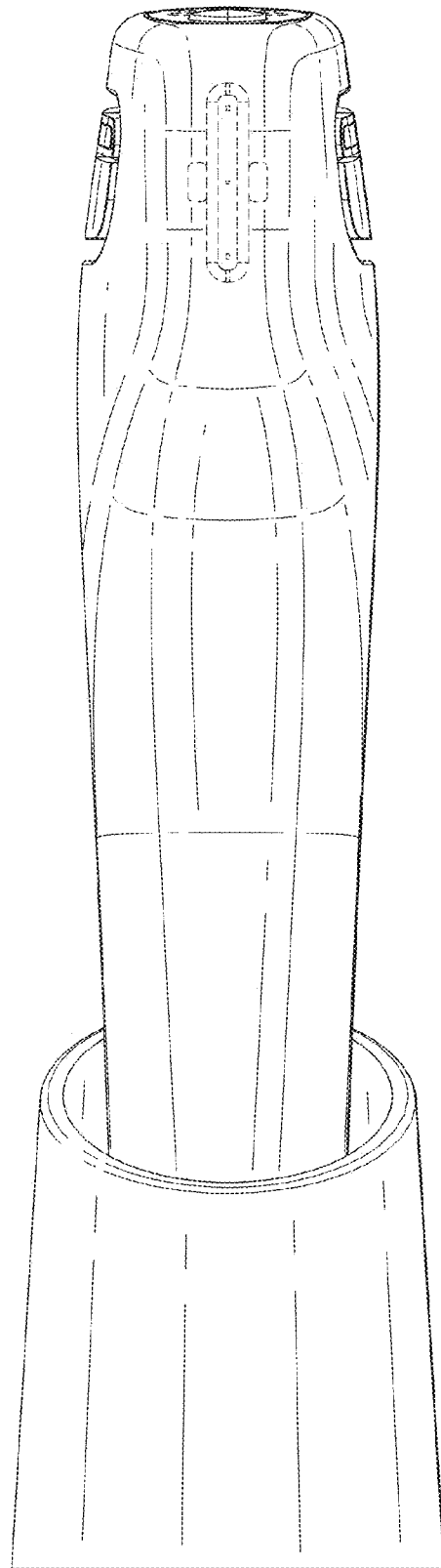
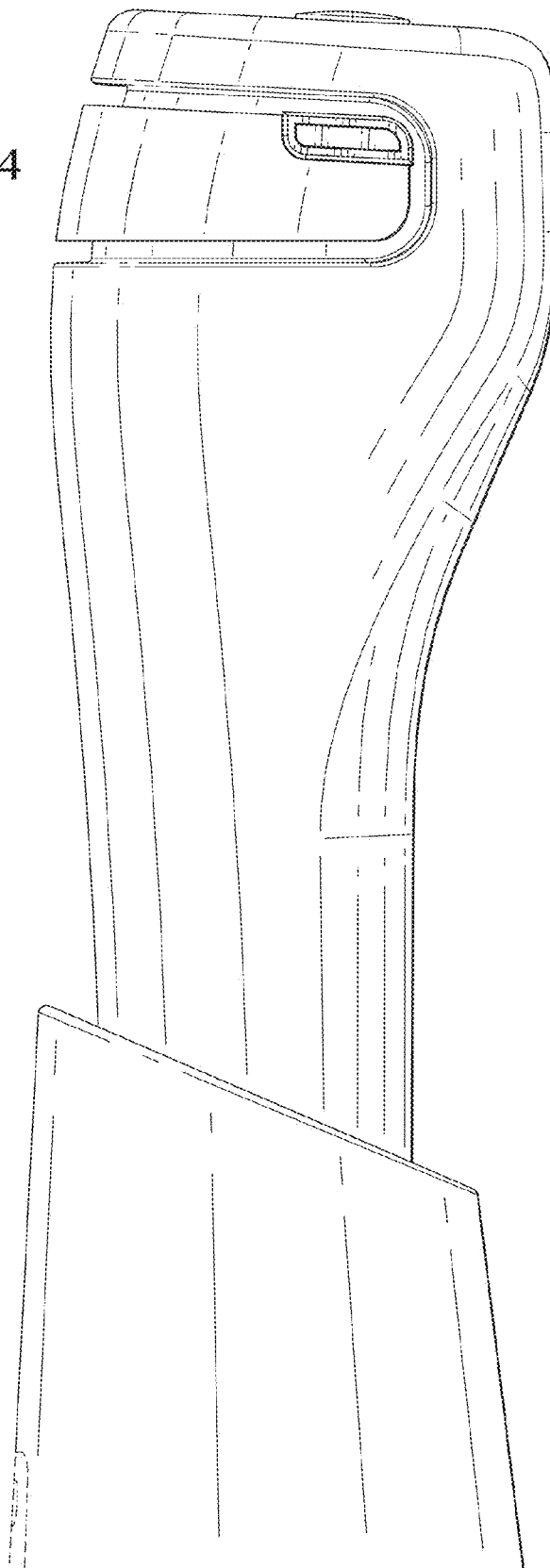

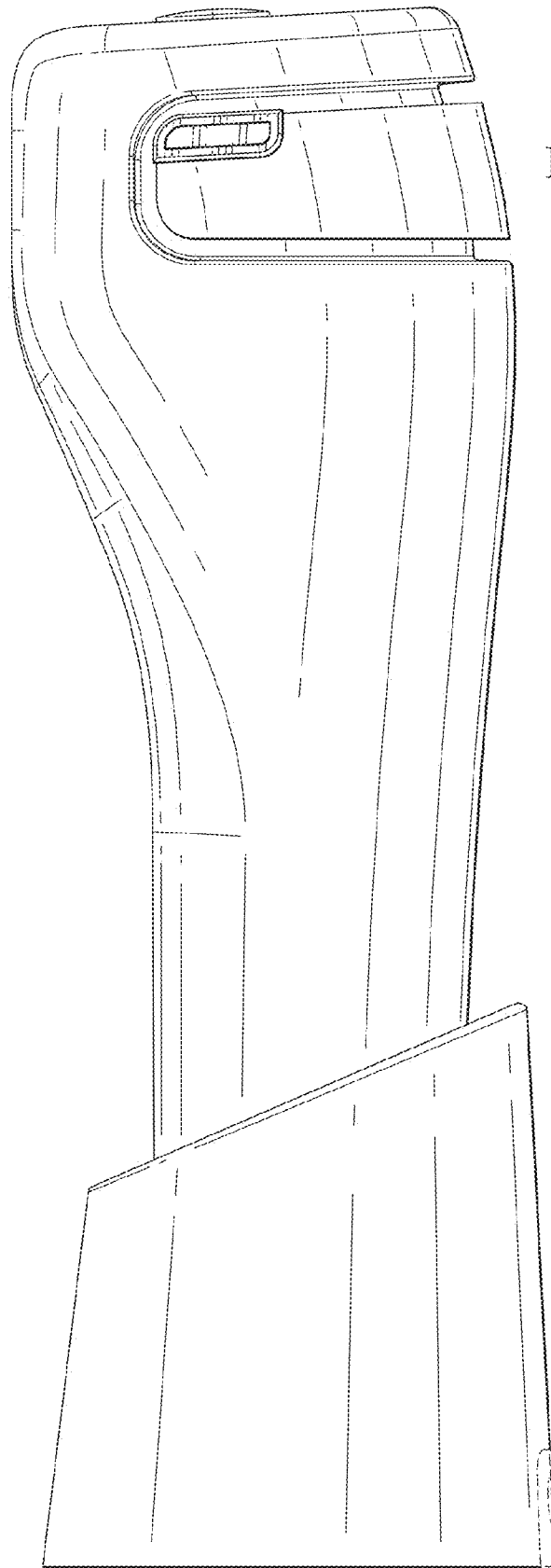

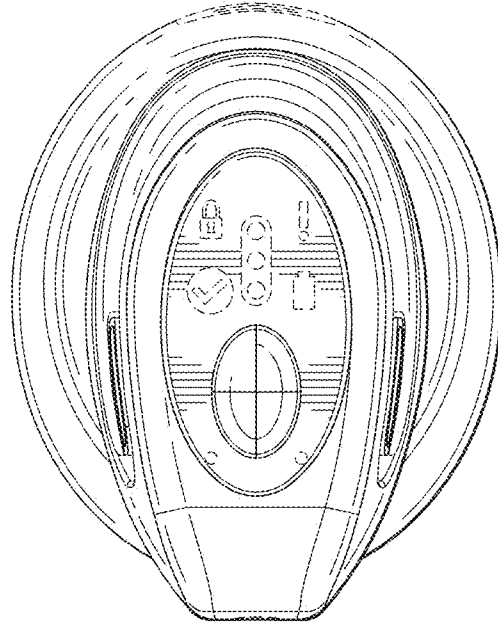
