FIG. 4 is a front view thereof;


FIG. 5 is a back view thereof;


FIG. 6 is a right side view thereof; and,

FIG. 7 is a left side view thereof.


The characteristic features of the design reside in the shape and ornamentation of the entire cabinet as shown in the drawings.













