The ornamental design for a handset, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a handset showing our new design;

FIG. 8 is a perspective rear view thereof;


FIG. 9 is a front view of the handset from FIGS. 1-8 showing our new design in an open position;




















