(57) CLAIM

I claim, the ornamental design for an infrared heating cooker, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of an infrared heating cooker, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an enlarged view of the portion labeled "8" encircled in FIG. 2;

FIG. 9 is an enlarged view of the portion labeled "9" encircled in FIG. 2;

FIG. 10 is an enlarged view of the portion labeled "10" encircled in FIG. 1;

FIG. 11 is an enlarged view of the portion labeled "11" encircled in FIG. 1;

FIG. 12 is an enlarged view of the portion labeled "12" encircled in FIG. 1;

FIG. 13 is an enlarged view of the portion labeled "13" encircled in FIG. 1;


FIG. 14 is an enlarged view of the portion labeled "14" encircled in FIG. 1;



























