(54) **Fast moving part of a plastic working apparatus**

(57) A fast moving part for a plastic working apparatus, such as a press. It is formed from a composite containing, e.g., aluminum as a light metal matrix. The composite contains 10% to 45% by volume of a ceramic material and 0.1% to 1.0% by weight of free-cutting inclusions.
